AUTUMN GOLD	D19-20 - 3 ⁹ / ₁₉ 8 ⁶ Jockey was severely reprimanded for failing to exhibit sufficient vigour on his mount during the race. 19 ¹¹ / ₁₉ 95 ⁰ was found to be lame by its right-fore leg, as such, was withdrawn on veterinary grounds. 24 ¹² / ₁₉ 128 ² Jockey reported that his mount was inclined to lean-in in the early part of the race and then in the straight was inclined to lean out.

MISS BULLET	D19-20 - 26 ¹¹ / ₁₉ 102 ⁷ met interference at the start. and Jockey has been reprimanded for his feeble riding during the race. 7 ¹² / ₂₀ 143 ³ met interference soon after the start and again near 900 metres. and Jockey has been fined for using his whip in excess of the prescribed limit on his mount. 14 ¹² / ₂₀ 150 ¹³ Jockey reported that his mount did not gallop freely from 400 metres onwards. 31 ¹² / ₂₀ 163 ¹² met interference passing 200 meters.	
MISS CINDRELLA	D19-20 - 17 ¹² / ₁₉ 125 ⁷ met interference in the final 200 metres. 7 ¹² / ₂₀ 143 ¹² jumped awkwardly inwards and was steadied off the heels of MISS BULLET at the start. 14 ¹² / ₂₀ 150 ⁷ was found to be lame by her left-fore leg. 31 ¹² / ₂₀ 163 ⁶ was slowly away.	
ASHWA SABIRA	D19-20 - 27 ⁸ / ₁₉ (5) jockey has been cautioned for allowing his mount to shift in under the use of the whip near 200 metres. 14 ¹¹ / ₁₉ (85) jumped out awkwardly and was slow to begin. 26 ¹¹ / ₁₉ 106 ⁷ met interference at the start.

BE CHAMPION	D17-18 - 19 ¹² / ₁₇ 124 ⁰ lame on left fore as such withdrawn on veterinary ground. 15 ¹ / ₁₈ 154 ⁰ shied away from the whip Near 100 metres. revealed a mouth injury on right side.	
GLENEAGLES	D19-20 - 7 ¹¹ / ₁₉ 73 ⁶ Jockey reported that his mount did not gallop fluently during the race. 31 ¹² / ₂₀ 163 ⁵ was slowly away and lost about 2 lengths.	
AMAZING INFERNO	D19-20 - 6 ² / ₂₀ 172 ¹⁴ met interference passing 900 metres.	

OSCAR NOMINATED D19-20 - 24¹²/₁₉130⁰ was examined at the Starting Gate and was found to be lame by the right fore leg and was withdrawn before coming under starters order.

RAXION D19-20 - 14¹/₂₀150¹⁰ met interference at the start and Jockey reported that he did not get a clear run on a couple of occasions in the straight. 6²/₂₀172¹¹ slowly away.

LOVELY GIRL D19-20 - 7¹/₂₀143¹⁰ met interference approaching 900 metres. 24¹/₂₀155¹³ Jockey unnecessarily restrained his mount thereby resulting in it getting its head up and loosing ground shortly after the start. He was fined. 6²/₂₀172⁴ received check passing 900 metres.

PONTY ROSSA D19-20 - 7¹/₁₉77⁸ was slowly away by three length. 14¹/₁₉(88) Jockey suspend for unsatisfactory riding. 17¹²/₁₉125¹¹ was slowly away. 7¹/₂₀140⁹ slowly away and lost a few lengths at the start.

AMAZING JET D19-20 - 10¹²/₁₉115⁵ Jockey reported loss of his whip approaching 300 meters.

MASTER NOVAK D19-20 - 24¹²/₁₉128⁰ was extremely fractious before being loaded and was withdrawn before coming under starters orders. 7¹/₂₀143⁹ met interference soon after the start and again Approaching 900 metres.

BLAVATSKY D19-20 - 31¹/₂₀165⁸ jumped out awkwardly at the start.

GALLOP AWAY D19-20 - 17¹⁰/₁₉44⁶ met interference at the start & the gelding was found to have trailed the field again. 14¹/₂₀147⁹ Jockeys asked to continue riding his mount till past the post.

CONQUERING BID D19-20 - 10¹²/₁₉120³ Jockey reported that his mount lugged-in in the straight. 24¹²/₁₉(132) App reported that his mount was inclined to lean in throughout the race and at the start 31¹/₂₀160⁹ jumped out awkwardly at the start and Jockey reported that his mount jumped out awkwardly due to which he lost his right stirrup, which he regained shortly. and Jockey has been reprimanded for his feeble riding in the straight. He has been informed that a similar riding effort will attract disciplinary action against him. 6²/₂₀172⁷ met interference passing 900 metres.

ALIZAA D19-20 - 3⁹/₁₉10² bumped at the start & met interference passing 1000 metres. 17⁹/₁₉(22) met interference near 1100 metres.

6th Race The Daring Don Plate Div - II

CI-IV, 20-46

1200 Mts.

LIKE MY CHILD D19-20 - 21¹¹/₁₉101⁶ Jockey has been fined and severely reprimanded for failing to sufficiently persevere with his mount in the straight.

MISS DUNCAN D19-20 - 21¹¹/₁₉97⁰ bumped and due to which App lost his stirrups which he could not regain near 400metres. 30¹²/₁₉138¹² met interference approaching 600 metres. 6²/₂₀172⁵ met interference passing 900 metres.

NICHE ORGANIC D19-20 - 17¹²/₁₉(123) met interference at the start.

RANNVIJAY D19-20 - 10¹²/₁₉114⁹ met interference between 900 metres and 800 metres & Trainer has been cautioned for failing to maintain the same running pattern of his charge. 17¹²/₁₉126⁹ met interference passing 900 metres.

MISS GLORIOUS D19-20 - 8¹/₁₉79³ Jockey reported that his mount was inclined to lug-in during the race and he found it difficult to pull his mount out. 6²/₂₀173² lugged out in the straight.

OSCULATE D19-20 - 31¹⁰/₁₉71⁸ drifted outwards at the start. 19¹/₁₉94³ met interference soon after the start and Jockey reported the loss of the whip 100 metres from the winning post. 17¹²/₁₉123² shifted outwards at the start.

PRINCESS ELENA D19-20 - 17¹²/₁₉126⁵ was slowly away and met interference passing 900 metres. 31¹/₂₀161⁶ swerved in and lost ground at the start and met interference passing 1400 metres.

MR SINGH D19-20 - 14¹/₁₉87⁹ Jockey has been cautioned for his feeble riding in the straight. 19¹/₁₉90⁴ Jockey suspend for unsatisfactory riding.

MASTER VANPERISE D19-20 - 30¹²/₁₉139⁸ travelled wide passing 900 metres.

HE IS SEXY D19-20 - 1¹⁰/₁₉32⁹ met interference at the start. 17¹⁰/₁₉43⁵ was checked passing 300 metres. 31¹/₂₀161⁴ met interference soon after the start.

SACHARINES D19-20 - 17¹²/₁₉127⁹ Jockey has been reprimanded for not making an effort after the start to maintain an advantageous position.

ASHWA CHICAGO D19-20 - 10¹²/₁₉119⁶ met interference Near 400 metres. 24¹²/₁₉133⁴ Jockey was observed not to have sufficiently persevered with his mount. 14¹/₂₀152³ was tightened at the start and inclined to lean-in in the final stages of the race. 31¹/₂₀166⁸ slowly away.

BHITSKI D19-20 - 1¹⁰/₁₉33⁴ met interference near 900 metres. 31¹⁰/₁₉(68) lugged out in the straight. 26¹/₁₉107³ met interference passing 1000mts.

CASH IN HAND D18-19 - 18³/₁₉206² have broken a blood vessel. 20⁴/₁₉280¹⁰ observed to have broken a blood vessel. D19-20 - 25⁹/₁₉30⁸ met interference at the start.

SPARKLING THEA	D19-20 - 31¹⁰/₁₉71⁷ met interference approaching 1200mts. 7¹¹/₁₉75¹⁰ met interference approaching 1200 metres.

D19-20 - 14¹/₂₀152⁰ was accepted by Trainer while the gelding was on a Veterinary Ban. In view of this, the gelding was Not Permitted to Race.
DIVINE PRINCE	D18-19 - 18²/₁₉167¹⁰ Jockey reported that between 300 and 200 metres, he felt his left leg slipping out of the stirrup whereby he was unbalanced, however, he managed to get hold of the stirrup.
