1st Race The Seabiscuit Salver	CI-3y, Maiden	1200 Mts.
MORGANITE	Bg19-20 - 6 ³ / ₂₀ 176 ⁰ was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn.	
PRERANA	Bg19-20 - 27 ² / ₂₀ 169 ¹⁰ was slightly slowly away.	
2nd Race The Hassan Plate	CI-V, 00-20, To be ridden by Indian Jockeys claiming allowance.	1100 Mts.
ANNALEASE	Bg19-20 - 14 ² / ₂₀ 146 ² Jockey was fined for not wearing the goggles during the race and also Jockey was severely reprimanded in presence of Master Trainer that he should make every effort to improve his riding in future failing which he would be reported to the Stewards.	
NOSTRADAMUS	Bg19-20 - 20 ¹² / ₁₉ 67 ¹¹ met interference approaching 1000 Metres. 26 ¹ / ₂₀ 121 ⁰ was withdrawn on veterinary grounds as it was found to be suffering from colic. 30 ¹ / ₂₀ 135 ⁷ met interference passing the 200 Metres. 15 ² / ₂₀ 153 ⁰ the trainer was specifically instructed not to accept his charge before getting it passed fit by the Clubs Veterinary Officer, when it was under veterinary ban- withdrawn.	
AEROSPEED	Bg19-20 - 20 ¹² / ₁₉ 67 ⁴ met interference passing the 300 Metres. 4 ¹ / ₂₀ 88 ¹¹ met interference at the start.	
FLICKA	Bg19-20 - 14 ² / ₂₀ 146 ⁵ Jockey reported that his whip got stuck in the reins for a few strides between the 175 Metres till about 150 Metres. 27 ² / ₂₀ 167 ⁰ was extremely fractious, reared up, sat down for a considerable period of time and the nose band snapped. Under the circumstances, it was permitted to be withdrawn.	
AMALFI COAST	BgS19 - 19 ⁵ / ₁₉ 14 ⁶ took a fly jump and met interference soon after the start. 1 ⁹ / ₁₉ 29 ⁸ took a fly jump. Bg19-20 - 13 ¹² / ₁₉ 48 ⁸ jumped awkwardly outwards. 4 ¹ / ₂₀ 89 ³ burst its blood vessels.	
SANTORINI SECRET	Bg19-20 - 14 ² / ₂₀ 146 ⁸ Jockey was fined for dropping hands in the final 100 Metres.	
PRIME STAR	Bg19-20 - 6 ¹² / ₁₉ 39 ⁹ met interference approaching 900 mtrs. 7 ² / ₂₀ 139 ⁷ met interference passing the 200 Metres. and Jockey was reprimanded for dropping hands before passing the winning post. 21 ² / ₂₀ 159 ⁰ was withdrawn on veterinary grounds as it was found to be lame on left hind.	
ASTRON	BgS19 - 28 ⁷ / ₁₉ 151 ⁰ it was found to have burst its blood vessels. Bg19-20 - 30 ¹ / ₂₀ 130 ³ met interference in the final 150 Metres. 7 ² / ₂₀ 139 ¹¹ Jockey reported that due to kick back he was seriously injured on his cheek bone with bleeding resulting in partial vision during the race.

ULTIMATE POWER	My19 - 19 ⁹ / ₁₉ (46) jumped awkwardly 'outwards' at the start. Bg19-20 - 14 ¹² / ₁₉ 57 ⁶ met interference approaching 1300 Metres.. 4 ¹ / ₂₀ 91 ⁸ met interference soon after the start.	
CASEY	Bg19-20 - 4 ¹ / ₂₀ 95 ⁵ met interference passing the 1400 Metres.	
SMILE OF JOY	Bg19-20 - 14 ¹² / ₁₉ 60 ⁹ it was found to have sharp molars on right side & An enquiry is being held into the running and riding.	
INDUSTRIALIST	My19 - 30 ¹⁰ / ₁₉ 127 ³ Jockey was fined for excessive use of whip, on his mount, in the above Race. Bg19-20 - 13 ¹² / ₁₉ 52 ² Jockey was fined for not improving his position from 900 Metres till about 500 Metres for no apparent reason.	
EKALAVYA	Bg19-20 - 4 ¹ / ₂₀ (95) was slowly away and lost few lengths at the start.	
APOLLO BAY	Bg19-20 - 6 ³ / ₂₀ 177 ⁷ Jockey was fined for taking a unduly long lead till about the final bend.	
RANCHO	BgS19 - 9 ⁶ / ₁₉ 49 ¹¹ met interference soon after the start. and pulled up lame on left fore. Bg19-20 - 28 ¹² / ₁₉ 75 ⁷ took a fly jump and met interference passing the 300mts. 26 ¹ / ₂₀ 128 ⁶ was slowly away and lost few lengths at the start. 21 ² / ₂₀ (159) Jockey reported that his mount accidentally stumbled passing the 900 Metres. An enquiry is being held into relatively performance.	
TRACK STRIKER	Bg19-20 - 30 ¹ / ₂₀ 129 ⁸ met interference passing the 900Metres.	
ADMIRAL ONE	BgS19 - 13 ⁷ / ₁₉ 116 ⁵ Jockey had to steady his mount due to crowding of the field passing 1000 Metres. My19 - 4 ¹⁰ / ₁₉ 82 ⁶ met interference within 100 Metres of the start and again passing 350mts and Jockey reported that his mount was not galloping fluently in the straight & sustained bruise on right hock. Bg19-20 - 20 ¹² / ₁₉ 68 ⁷ met interference approaching 900 Metres. 25 ¹ / ₂₀ 119 ⁴ Jockey reported that his mount was hanging in after entering the straight.	
CADILLAC SKY	Bg18-19 - 30 ¹¹ / ₁₈ 39 ⁸ after jumping out, veered out and did not raise a fluent gallop for the first 200 Metres. Bg19-20 - 28 ¹² / ₁₉ 74 ⁶ was slowly away and lost few lengths at the start. 27 ² / ₂₀ 168 ⁵ Jockey was fined for travelling wide from 600 Metres till about 400 Metres for no apparent reason.	
LIMATO	Bg18-19 - 8 ³ / ₁₉ 172 ² met interference approaching 550 metres. Bg19-20 - 20 ¹² / ₁₉ 68 ³ met interference at the start. 27 ² / ₂₀ 168 ⁷ Jockey was fined for shifting in under the use of whip.	
SOUTH BELL	Bg19-20 - 15 ² / ₂₀ 154 ⁹ met interference passing the 200 Metres. 21 ² / ₂₀ 165 ⁷ Jockey had to steady his mount passing the 1000 Metres due to a closely packed field.

QUEEN OF SANDS	Bg19-20 - 30 ¹¹ / ₁₉ 31 ² Jockey reported that his mount was lugging 'in' under pressure in the final 250 Metres. 25 ¹ / ₂₀ 114 ⁰ reared up and fell over in the saddling enclosure and was found to be sore on right fore. Under the circumstances, it was permitted to be withdrawn.	
VENUS BAY	My19 - 30 ⁸ / ₁₉ 11 ⁴ Jockey reported his mount was hanging 'in' after entering the straight. 27 ⁹ / ₁₉ 68 ⁶ Jockey was reprimanded for travelling wide rounding the final bend for no apparent reason. Bg19-20 - 15 ² / ₂₀ 156 ⁰ it was under B.T.F. Ban. Subsequently, permission was granted to him to withdraw.	

SCHAFENBERG	My19 - 29 ⁸ / ₁₉₆ ⁰ withdraw from the above race, as it was observed to have sustained two inch long deep cut above left eye. Bg19-20 - 31 ²⁰ / ₈₇ ⁴ planted and lost many lengths at the start. 26 ¹ / ₂₀ 124 ¹⁰ Jockey reported that he did not have his right leg in the stirrup when the start was given, which he regained passing the 1200 Metres.
STAR AND GARTER	Bg19-20 - 22 ¹¹ / ₁₉₁ ⁷ jumped awkwardly outwards.
SEA OF CORTEZ	BgS19 - 19 ⁵ / ₁₉₈ ⁰ was observed to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn. 1 ⁶ / ₁₉ 31 ⁴ was slowly away and lost few lengths at the start.
STAR CAVALRY	BgS19 - 30 ⁶ / ₁₉₉₆ ⁴ met interference approaching 1000 Metres.
LIGHTNING ATTACK	Bg19-20 - 30 ¹¹ / ₁₉₃₄ ⁰ reared up as the gates opened, dislodging its rider and ran rider less.
GLORIOUS DANCER	My19 - 30 ⁸ / ₁₉₁₂ ⁶ met interference soon after this start. Bg19-20 - 30 ¹¹ / ₁₉₃₆ ⁶ met interference passing the 1500 Metres. 15 ² / ₂₀ 156 ¹¹ met interference passing the 1100 Metres and stumbled unbalancing its rider passing the 1200 Metres.
ZHU ZHU ZEST	My19 - 30 ⁸ / ₁₉₁₀ ⁰ was not co-operative while being loaded into the float for travel to Mysuru. Under the circumstances permission was granted to Trainer Mr. Pradeep Annaiah to withdraw.
5th Race The Hemavati Salver	CI-I, 60 and above 1200 Mts.
SILVER IKON	Bg17-18 - 20 ¹ / ₁₈ (27) Jockey reported that his mount was lugging in under pressure during the final stages of the race.
PSYCHIC WARRIOR	BgS19 - 21 ⁷ / ₁₉₁₃₈ ⁰ it was found to be sore. Under the circumstances, it was permitted to be withdrawn. Bg19-20 - 6 ³ / ₂₀ 181 ⁸ met interference at the start.
KVASIR	Bg19-20 - 25 ¹ / ₂₀₁₁₆ ² Jockey reported that he accidentally lost his whip passing the 100 Metres.
LIFE AWAITS	BgS19 - 29 ⁹ / ₁₉₈₈ ⁶ jumped awkwardly outwards. Bg19-20 - 6 ¹² / ₁₉₄₃ ¹¹ jockey was fined for travelling wide after entering the straight for no apparent reason. 15 ² / ₂₀ 155 ⁸ jumped out awkwardly and it was found to have sharp molars on both sides.
ALBERETTA	Bg19-20 - 30 ¹ / ₂₀₁₃₆ ³ met severe interference passing the 800 Metres.
BIG BOON	Bg19-20 - 13 ¹² / ₁₉₄₉ ⁵ met interference at the start. 17 ¹ / ₂₀ 107 ⁷ Jockey was fined for not making sufficient effort on his mount in the straight. 27 ² / ₂₀ 172 ⁶ met interference approaching 700Metres and again passing the 150 Metres.
6th Race The Lalitha Mahal Plate	CI-IV, 15-35, 5 years old and over 1100 Mts.
CAPSTONE	BgS19 - 9 ⁸ / ₁₉₁₈₈ ⁰ withdraw on veterinary grounds as it was found to be lame on right hind. Bg19-20 - 6 ¹² / ₁₉ (41) severe interference before passing the red marker post. 20 ¹² / ₁₉₆₉ ⁰ met severe interference and Jockey getting totally unbalanced and was dislodged soon after the start. 14 ² / ₂₀ 150 ⁷ met interference before passing the red marker post. and Jockey reported that his mount was hanging out after entering the straight.
GOLD MIST	BgS19 - 13 ⁷ / ₁₉₁₁₆ ⁷ Jockey was reprimanded for travelling wide from 650 Metres till rounding the final bend for no apparent reason and also for dropping hands before passing the winning post. 9 ⁸ / ₁₉₁₈₂ ⁰ withdraw on veterinary grounds as it was found to be lame on right hind due to swelling of tendon on back of cannon.
HUNTERS MOON	BgS19 - 8 ⁸ / ₁₉₁₇₃ ⁷ jumped awkwardly outwards. My19 - 11 ¹⁰ / ₁₉₉₅ ⁷ Jockey was fined for taking an unduly long lead, rounding the bend & Jockey reported that the horse was hanging 'in' at the start. Bg19-20 - 29 ¹ / ₁₉₂₄ ⁴ took a fly jump.
KINGSFIELD	My19 - 19 ⁹ / ₁₉₅₀ ⁰ stopped galloping approaching 700 meters. The horse was impounded for veterinary examination and was reported to have sustained clipped injury over left hind chestnut and cut injury on right hind outer cannon. Bg19-20 - 14 ¹² / ₁₉₆₀ ⁷ met interference approaching 350 Metres.
CHARMAINE	BgS19 - 2 ⁸ / ₁₉₁₆₆ ³ burst its blood vessels.
HONEY TRAP	My19 - 19 ⁹ / ₁₉ (44) was slowly away.
ARROGANCE	My19 - 30 ¹⁰ / ₁₉₁₂₈ ⁶ had apparently lost its left fore shoe, during the race. Bg19-20 - 30 ¹¹ / ₁₉₃₂ ⁸ met interference passing the 300 Metres. 14 ² / ₂₀ 151 ⁹ met interference passing the 1000 Metres and again passing the 800 Metres.
PREMIER PREMISES	My19 - 30 ¹⁰ / ₁₉₁₂₆ ¹⁰ Jockey fine for Injudicious Riding. Bg19-20 - 29 ¹ / ₁₉₂₄ ³ met interference passing the 1000 Metres.
LEGEND IS BACK	Bg17-18 - 10 ³ / ₁₈₁₀₁ ⁸ jumped awkwardly outwards and was inclined to run out from 900 Metres till about 600 Metres, it was running green after entering the straight. BgS18 - 16 ⁶ / ₁₈₆₃ ¹⁰ jumped out awkwardly. Bg18-19 - 26 ¹ / ₁₉₁₂₆ ⁰ was extremely fractious at the start and refused to be stalled. Under the circumstances, it was permitted to be withdrawn. My19 - 19 ⁹ / ₁₉₄₆ ⁰ was not co-operative while being loaded into the float for travel to Mysuru. Under the circumstances permission was granted to Trainer to withdraw.
NERVA	Bg19-20 - 13 ¹² / ₁₉₅₀ ⁸ Jockey was reprimanded for travelling wide rounding the final bend for no apparent reason. 17 ¹ / ₂₀ 105 ⁹ It was observed that Jockey had to steady his mount due to the crowding of the field passing the 900 Metres.
PERFECTGOLDENERA	My19 - 12 ⁹ / ₁₉₃₇ ⁵ Jockey was fined for excessive use of whip on his mount. Bg19-20 - 11 ¹ / ₂₀₉₈ ⁰ it was under B.T.F. BAN. Subsequently, permission was granted to him to withdraw.
7th Race The Brahmaputra Plate	CI-IV, 15-35 1400 Mts.
CHANTELLE	My19 - 3 ¹⁰ / ₁₉₇₉ ³ Jockey reported that he accidentally lost his whip passing 250 Metres. and Jockey reported that, his mount was not galloping fluently in the first 400 Metres of the race.
SUN SPLASH	Bg19-20 - 26 ¹ / ₂₀₁₂₀ ² Jockey had to steady his mount to avoid striking the front runner LE MARC passing the 700 Metres.
AUGUSTINA	Bg19-20 - 13 ¹² / ₁₉₄₈ ⁵ met interference passing the 1000 Metres and jumped inwards at the start.

RED INDIAN My19 - 29⁸/₁₉2⁰ was extremely fractious and got stuck inside the stall for a considerable amount of time. Under the circumstances, it was permitted to be withdrawn. **Bg19-20 - 30¹¹/₁₉38¹¹** Jockey reported that his mount was inclined to run out between the 800 Metres till about 600 Metres. **4¹/₂₀90¹³** Jockey was reprimanded for travelling wide rounding the final bend for no apparent reason. **27²/₂₀168²** It was observed that the left side of the bridle had shifted onto the blinker soon after the start.

CAMELEONS IMAGE Bg19-20 - 11¹/₂₀97² jumped awkwardly outwards at the start. and had a frequent urination, swishing of tail and filly was in visible heat.

POLAR EXPRESS Bg19-20 - 27²/₂₀170⁵ jumped out awkwardly.

GOODWILL WARRIOR My18 - 25¹⁰/₁₈121⁸ met interference passing the 500 Metres. **BgS19 - 6⁷/₁₉101⁰** was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn.

DARING SWEETHEART Bg19-20 - 28¹²/₁₉75⁴ An enquiry is being held into the running and riding. **7²/₂₀137⁶** had to be checked its rider passing the 800 Metres. and Jockey was fined for not making sufficient effort on his mount during the race.

HAPPY DANCING My19 - 20¹⁰/₁₉(113) An enquiry is beng held into the vastly improved performance. **Bg19-20 - 26¹/₂₀123⁰** Trainer was fined for accepting his charge when it was under treatment. Subsequently, permission was granted to him to withdraw.

TAZAMOUR Bg19-20 - 17¹/₂₀106⁶ Jockey was fined for allowing his mount to drift out under the use of whip between the 250 Metres till about the final 50 Metres. **15²/₂₀158⁹** met interference at the start.

LOVELY SIERRA BgS19 - 21⁷/₁₉143⁶ after jumping threw its head up in the air and also Jockey reported that his mount accidentally slipped approaching 900 Metres. **8⁸/₁₉173¹¹** was hanging out throughout the race. **My19 - 30¹⁰/₁₉128⁰** was not co-operative while being loaded onto the float for travel to Mysuru. Under the circumstances permission was granted to withdraw. **Bg19-20 - 6¹²/₁₉39¹²** jumped out awkwardly and met interference approaching 900 mtrs & Jockey reported that his mount was hanging out after entering the straight & burst its blood vessels.
