

RACING INCIDENTS IN BRIEF OF IMMEDIATE PAST 6 RUNS

1 st Race The Sprungli Plate Div - II	CI-IV, 20-46, (0 to 19 eligible).	1200 Mts.
RAMBLER	M19-20 - 13 ² / ₂₀ 141 ⁷ jumped outwards at the start. Pn20-21 - 6 ¹² / ₂₀ 18 ⁰ ducked the front gates and ran breaking the front barrier. In the process, Jockey was hurt and indisposed, as such was withdrawn After being stalled & was observed to have a gum injury.	
RECALL OF YOU	M19-20 - 24 ¹¹ / ₁₉ (14) was observed to have shifted out despite which Jockey persisted with the whip from the right and failed to take corrective measures in final stages of the race. Pn20-21 - 27 ¹¹ / ₂₀ 7 ⁶ met interference soon after the start.	
CELLINI	M18-19 - 6 ⁴ / ₁₉ 223 ⁸ was slow to begin and met interference at the start. Pn19 - 25 ⁸ / ₁₉ 56 ⁵ was marginally slow to begin and met interference at the start & App reported that his mount was inclined outwards throughout the race. 14 ⁹ / ₁₉ 82 ³ was observed to have ducked out and had to be steadied soon after the start. M19-20 - 21 ¹² / ₁₉ 45 ² had to be checked passing the 1200 metres and met interference passing the 1000 metres and bumped passing the 400 metres.	
CIPHER	Pn19 - 21 ⁹ / ₁₉ (96) met interference along the rails approaching the 600 metres. 26 ¹⁰ / ₁₉ 156 ⁴ was observed to have jumped out awkwardly brushing against its stall. M19-20 - 24 ¹ / ₂₀ 110 ⁰ was permitted to be withdrawn on compassionate grounds. Pn20-21 - 6 ¹² / ₂₀ 22 ⁷ was tightened for room and had to be checked approaching 1400 metres & had right eye injury. 27 ¹² / ₂₀ 56 ⁶ met interference at the start.	
BLAZING BAY	M19-20 - 1 ² / ₂₀ 119 ⁸ met interference passing the 1000 metres.	
SALTBAE	M19-20 - 9 ¹ / ₂₀ 81 ⁵ App reported the loss of whip approaching the 200mts. 13 ² / ₂₀ 142 ⁴ jumped inwards at the start.	
2 nd Race The Simply Noble Plate	CI-III, 40-66, (20 to 39 eligible).	1200 Mts.
JOAQUIN	M19-20 - 23 ² / ₂₀ (153) leaned inwards soon after the start and Cross Nose Band used on had broken and was found on the Track soon after the start. 12 ³ / ₂₀ (181) had checked his mount and changed course approaching 1000mts. Jockey reported that his mount hung-out in the straight. Pn20-21 - 20 ¹² / ₂₀ 42 ⁹ was held for room and had to be steadied passing 900 metres.	
EPIPHANY	Pn19 - 22 ⁹ / ₁₉ 104 ⁰ refused to be stalled despite substantial efforts, as such, the mare was withdrawn. M19-20 - 16 ² / ₂₀ 148 ⁴ was bumped and had to be steadied soon after the start. Pn20-21 - 13 ¹² / ₂₀ 32 ³ met interference & bumped and unbalanced passing 800 metres.	
RED CARNATION	M19-20 - 1 ² / ₂₀ 118 ⁴ shifted in soon after the start. 26 ² / ₂₀ 159 ² met interference at the start. Pn20-21 - 27 ¹² / ₂₀ 57 ³ had lost its left hind shoe.	
PRINCESS ANNABEL	Pn19 - 24 ⁸ / ₁₉ 51 ⁶ was found to be sore by the right fore leg. M19-20 - 15 ¹² / ₁₉ 33 ⁵ was scoped at the Clubs Equine Hospital after the races and found to have Guttural Pouch Empyema and URTI (Gr.II) mucopus in the trachea.	
SKY FALL	M19-20 - 22 ¹² / ₁₉ 50 ⁹ was bumped and had to be checked passing the 400 metres. 12 ³ / ₂₀ 181 ⁴ jumped outwards at the start and met interference approaching 1000mts.	
MARKET KING	M19-20 - 1 ² / ₂₀ 116 ² bumped approaching the 600 metres. 23 ² / ₂₀ 153 ² jumped inwards at the start and Jockey reported that his mount maintained an erratic course in the straight. Pn20-21 - 11 ¹² / ₂₀ 28 ² Jockey reported that in the last 150 metres his mount was inclined outwards despite his efforts.	
ARC SHINE	M19-20 - 23 ² / ₂₀ 155 ⁸ bumped at the start.	
RISING BRAVE	M19-20 - 16 ¹ / ₂₀ 93 ⁴ met interference passing the 350 metres. 26 ² / ₂₀ 163 ⁶ met interference approaching 200 metres.	

3rd Race The Maharaja Sir Pratapsingh Gaekwad Trophy**CI-II, 60-86, (40 to 59 eligible).****1400 Mts.****VALEGRO**

Pn19 - 3⁸/₁₉17² was observed to have an abrasion at the left hind pastern. **M19-20** - 1¹²/₁₉20² jumped outwards at the start. 1²/₂₀117³ met interference and was steadied passing the 1000 metres and again passing the 150 metres. Jockey suspend for unsatisfactory riding. **Pn20-21** - 25¹²/₂₀47⁵ was observed to have a gum injury.

REVELATOR

Pn19 - 13¹⁰/₁₉141³ had right eye injury (sore, lacrimation). **M19-20** - 27¹²/₁₉(54) met interference at the start. 12³/₂₀180³ met interference soon after the start and received checked passing 1400mts.

GLORIOSUS

Pn20-21 - 27¹¹/₂₀3⁹ Jockey reported that passing the 800 metres, his mount lost its footing and did not gallop freely post that & was found to be sore by the right fore leg.

MAJESTIC WARRIOR

M19-20 - 18¹/₂₀99³ met interference negotiating the final bend. and Jockey reported that his mount was inclined outwards throughout the race. **Pn20-21** - 27¹¹/₂₀3⁸ was observed to have brushed the rails and was steadied approaching 800 metres & had to be checked passing 300 metres and had injury in both eyes (sore). 11¹²/₂₀23³ jumped outwards at the start.

SULTAN SULEIMAN

M19-20 - 22¹²/₁₉51⁹ had to be steadied, approaching the 600 metres, due to a tightly packed field and met interference passing the 500 metres. 23²/₂₀155⁵ jumped outwards at the start.

ENID BLYTON

M18-19 - 24²/₁₉167⁶ was tightened for room and had to be checked soon after the start. **Pn19** - 11⁸/₁₉(29) met interference approaching 1000 Metres. 15⁹/₁₉88³ Jockey reported that passing the 400 metres he was blocked of a clear run. **M19-20** - 24¹¹/₁₉13³ Jockey reported that passing the 400 metres he was held up for room and had to change course. **Pn20-21** - 6¹²/₂₀(19) met interference soon after the start.

ODESSA

Pn19 - 25¹⁰/₁₉144¹⁰ met interference soon after the start. **M19-20** - 17¹¹/₁₉7³ App reported the loss of whip at about 150 metres.

4th Race The Jayant M Shah Plate Div - II**CI-V', 4-30, 5 years old and over****1400 Mts.****WORLD IS ONE**

M19-20 - 17¹¹/₁₉6⁹ was observed to have stumbled and showed signs of distress after returning from the race.

TAKE IT EASY

Pn19 - 25¹⁰/₁₉147⁶ had to be checked approaching the 1000 metres. **Pn20-21** - 27¹¹/₂₀2⁹ jumped inwards at the start. 27¹²/₂₀58² Jockey has been fined for having used the whip in excess of the prescribed limit on his mount.

SO SPLENDID

M19-20 - 5¹/₂₀73³ jumped inwards at the start.

SADDLE THE WIND

M19-20 - 1²/₂₀113¹⁰ App. was observed to have lost his whip. On being questioned, he stated that in his effort to change his whip hand the same had slipped passing the 300 metres.

SHAPATH

M19-20 - 21²/₂₀68² met interference passing the 150 metres. 1²/₂₀119⁷ met interference passing the 1000 metres. 5³/₂₀172⁸ jumped inwards at the start. **Pn20-21** - 31²/₂₁62⁴ jumped inwards at the start & had to be checked and dropped back approaching 1000 metres, due to a tightly packed field.

HONOURABLE EYES

M19-20 - 23²/₂₀158² App was observed to have used the whip in excess of the prescribed limit on his mount. 5³/₂₀172⁰ found to be sore by the left hind leg, as such the gelding was certified unfit to race and was withdrawn.

KANADARIO

M19-20 - 9¹/₂₀81¹² jumped out slow losing about 2 lengths at the start. 16¹/₂₀91⁹ jumped out slow losing about a length at the start. 13²/₂₀136¹¹ marginally slow to begin and met interference at the start. 23²/₂₀157⁰ stopped galloping at the 200 metres marker. On examination, swelling on the left point of hip was noticed. **Pn20-21** - 13¹²/₂₀37¹³ lost about 3 lengths at the start.

NUSRAT M19-20 - 17¹¹/₁₉9² jumped inwards at the start and NUSRAT had right eye injury (sore corneal opacity and ulcer). 16¹/₂₀89² Jockey had used the whip in excess of the prescribed limit on his mount. 5³/₂₀166³ jumped inwards at the start and met interference in the final stages of the race.

WHISPERING QUEEN M19-20 - 17¹¹/₁₉9³ met interference passing the 300 metres. Pn20-21 - 20¹²/₂₀38⁸ met interference & had to be steadied approaching 800 metres.

GANDALF Pn20-21 - 27¹¹/₂₀4⁷ had right eye injury (sore). 6¹²/₂₀16⁹ had right eye injury (sore eye & lacrimation). 20¹²/₂₀38⁵ shifted out approaching 800 metres. 3¹/₂₁68³ met interference and stumble and drop back passing the red marker and again met interference along the rails passing 900 metres.

SAFFRON FLOWER M19-20 - 29¹²/₁₉65⁰ jumped out awkwardly throwing her head at the start and Jockey (Placed 5th by the Judge) failing to weigh in after the race and was disqualified. Jockey suspended for failing to weigh-in. Pn20-21 - 20¹²/₂₀38¹⁰ received checked at the start.

I AM THE WAY Pn19 - 26¹⁰/₁₉157¹⁰ jumped out slow losing about a length at the start & who was racing on the haunches of OUTSTASNDING and GLORIANA was denied a clear passage and had to be held in the final stages of the race. Pn20-21 - 27¹¹/₂₀1¹⁰ reared up as the start was given thus losing considerable ground at the start.

RED FIRE Pn19 - 14⁹/₁₉85⁵ had a cut injury at the left fore knee. M19-20 - 9¹/₂₀87⁹ was bumped and tightened at the start. Pn20-21 - 27¹¹/₂₀1³ had left eye injury (sore).

5th Race The V R Menon Plate

CI-IV', 20-46, (0 to 19 eligible).

1400 Mts.

BEEJAY Pn20-21 - 3¹/₂₁62² met interference at the start.

RAYS OF SUN Pn20-21 - 27¹¹/₂₀6⁵ met interference passing 200 metres.

SPANISH CITY Pn20-21 - 27¹²/₂₀55³ met interference soon after the start & had injuries to both eyes.

MARLBORO MAN M19-20 - 5³/₂₀171⁸ met interference at the start. Pn20-21 - 6¹²/₂₀20¹³ leaned inwards soon after the start & had left eye injury.

MARVIN M19-20 - 2¹/₂₀71⁶ had injury to both eyes (sore). Pn20-21 - 13¹²/₂₀31⁵ leaned inwards passing 400 metres.

FALAKNUMA Pn20-21 - 27¹²/₂₀55¹² jumped outwards at the start.

SMOKIN' HOT M19-20 - 13²/₂₀141⁵ received checked passing the 450 metres.

FARAHNAAZ M19-20 - 29¹²/₁₉61⁰ found to have cut injury on right shoulder; as such the filly was certified unfit to race. 12³/₂₀181⁵ was inclined outwards despite which App. used the whip from the right thereby causing the filly to further shift out and in an attempt to correct the outward shift of his mount, App was observed to have lost his whip. Pn20-21 - 29¹¹/₂₀11⁵ met interference at the start & had right eye injury (mild ulcer). 27¹²/₂₀55⁶ jumped out slow losing about 3 lengths at the start.

7th Race The Sprungli Plate Div - I

CI-IV, 20-46, (0 to 19 eligible).

1200 Mts.

SPEED AIR M18-19 - 12¹/₁₉98⁴ was lethargic in the early part of the race and also ran green. 3²/₁₉131⁸ met interference soon after the start and was held up for room along the rails and had to be steadied Passing 900 metres, came back in distress. M19-20 - 13²/₂₀140² met interference soon after the start. Pn20-21 - 6¹²/₂₀(18) met interference soon after the start.

BELENUS Pn19 - 21⁹/₁₉98² met interference soon after the start. 13¹⁰/₁₉137⁶ met interference at the start. M19-20 - 27¹²/₁₉58⁶ jumped inwards at the start and had to be checked soon after the start. Pn20-21 - 27¹²/₂₀56⁹ leaned outwards at the start.

RUN FORREST RUN Pn19 - 25⁸/₁₉57⁵ jockey reported that his mount hung-in in the straight & had left eye injury (sore). 26¹⁰/₁₉156³ jumped inwards at the start & had to be steadied and met interference passing the 250 mtrs. M19-20 - 8¹²/₁₉27³ shifted out passing the 250 metres and Jockey stated that his mount was inclined outwards despite his efforts. 21¹²/₁₉40³ jumped inwards at the start. 1²/₂₀118⁷ lost its footings and stumbled the start.

AGRAMI M19-20 - 2¹/₂₀70⁷ met interference at the start. 9²/₂₀133³ jumped inwards at the start. Pn20-21 - 13¹²/₂₀32² bumped and passing 800 metres. 27¹²/₂₀57⁴ hung-in passing 200 metres.

RON Pn19 - 26¹⁰/₁₉150⁷ jumped out slow losing about 2 lengths at the start. M19-20 - 29¹²/₁₉(60) jumped outwards at the start.

PLEIADES Pn19 - 24⁸/₁₉48⁵ met interference passing the 100 metres & had left eye injury (sore). M19-20 - 13²/₂₀137⁹ met interference from the 250 Metres.

PULVERIZE Pn19 - 15⁹/₁₉88⁵ met interference soon after the start & had right eye injury (sore eye). M19-20 - 8¹²/₁₉27⁸ was observed to have stumbled and had to be steadied at the start. 24¹/₂₀110⁰ Jockey reported that his mount jumped out brushing against its stall due to which his right stirrup broke and thus he could not ride out his mount to complete advantage. 23²/₂₀156⁶ met interference passing the 200 metres. and was found to be sore by the left fore leg. Pn20-21 - 27¹/₂₀8¹³ was found to be sore by the right fore leg. Also, the gelding had lost its right fore shoe.

POWERFUL LADY M19-20 - 5³/₂₀171² met interference at the start and Jockey reported that his mount ran green. Pn20-21 - 25¹²/₂₀(46) leaned inwards approaching 50 metres.

ROYALTY M19-20 - 24¹¹/₁₉14⁴ met interference at the start and had right eye injury (sore, lacrimation). 8¹²/₁₉(29) met interference approaching the 500 metres. Pn20-21 - 29¹/₂₀10³ had left eye injury (sore, lacrimation).

MOUNT OLYMPUS Pn19 - 26¹⁰/₁₉151⁴ jumped outwards at the start & was found to be sore by the left fore leg. M19-20 - 9¹/₂₀84³ met interference approaching the 1100mts. and was found to be sore by the left fore leg. 1²/₂₀118¹⁰ was found to be sore by the left fore leg.

8th Race The Jayant M Shah Plate Div - I

Cl-V', 4-30, 5 years old and over

1400 Mts.

CROSSWINDS Pn20-21 - 25¹²/₂₀52¹¹ met interference soon after the start.

SACHERTORTE Pn19 - 13¹⁰/₁₉137¹⁰ met interference at the start. M19-20 - 11²/₁₉18⁴ showed signs of distress after returning from the race. 5¹/₂₀77⁵ bumped approaching 300mts and showed signs of distress. After cold water hosing and First Aid treatment the gelding recovered and was sent to the stables. 13²/₂₀140⁷ had to be checked soon after the start and again passing the 1100 Metres. Pn20-21 - 27¹²/₂₀58³ was found to be in distress after the finish of the race.

MIKAYLA'S PRIDE M19-20 - 1²/₂₀119² bumped at the start. 12³/₂₀184³ was observed to have stumbled and was steadied at the start. and met interference negotiating the final bend. Pn20-21 - 27¹/₂₀2⁵ met interference at the start & had right eye injury (sore, lacrimation).

CAESAR Pn19 - 25⁸/₁₉59⁷ met interference at the start. M19-20 - 5¹/₂₀80³ jumped out and tried to whip around. and Jockey reported that his mount jumped outwards and had to be steadied. Pn20-21 - 27¹/₂₀4⁴ leaned inwards approaching 1000 metres. 3¹/₂₁68⁰ jumped inwards at the start & received checked passing the red marker, saddle was observed to have slipped forward due to which the rider had to dismount passing 300 metres.

PERIWINKLE Pn19 - 5¹⁰/₁₉117⁹ jumped outwards at the start. 26¹⁰/₁₉151³ jumped outwards at the start and received checked at 800 mtrs. M19-20 - 18¹/₂₀98⁶ jumped out slowly losing about 2 lengths at the start. and App reported that his mount hung out in the straight. 23²/₂₀157⁰ the bit used on broke which led to the rider getting dislodged on the way to the start and being unable to ride, as such, the filly was withdrawn before coming under the Starters order. Pn20-21 - 29¹/₂₀9³ met interference at the start & was observed to shift out in the final stages of the race, Jockey reported that his mount tried to run out in the straight.

ARABIAN STORM	M19-20 - 13 ² / ₂₀ 137 ⁷ met interference from the 250 Metres.
ELLYSIA	M19-20 - 9 ¹ / ₂₀ 84 ⁶ met interference passing the 300mts. 23 ² / ₂₀ 156 ⁷ shifted out and had to be steadied passing the 550 metres. Pn20-21 - 29 ¹¹ / ₂₀ 9 ⁵ had right eye injury (sore). 27 ¹² / ₂₀ 56 ³ jumped outwards at the start.
ETERNAL DANCER	M19-20 - 21 ¹² / ₁₉ 42 ⁸ met interference approaching the 600 metres. 5 ¹ / ₂₀ 77 ⁴ Jockey reported that his mount hung-in in the straight despite his efforts. 18 ¹ / ₂₀ 97 ⁸ met interference at the start. 23 ² / ₂₀ 156 ⁹ met interference at the start.
VA BENE	Pn19 - 26 ¹⁰ / ₁₉ 152 ⁵ had to be steadied and met interference soon after the start & had an abrasion at both hind fetlock. M19-20 - 22 ¹² / ₁₉ 46 ⁰ found to be tied up, as such the filly was certified unfit to race and was withdrawn. 13 ² / ₂₀ 142 ⁷ met interference and was steadied turning for home. 5 ³ / ₂₀ 169 ² met interference at the start. Pn20-21 - 25 ¹² / ₂₀ 45 ⁴ leaned inwards passing 200 mtrs.
HOLLYWOOD PARK	M19-20 - 18 ¹ / ₂₀ 98 ⁹ App reported that his mount hung-in in the straight. 13 ² / ₂₀ 142 ⁹ jumped out slow, losing about 5 lengths at the start.
DOWSABEL	M19-20 - 16 ¹ / ₂₀ 91 ⁸ Jockey reported that his mount was hesitant to raise a fluent gallop throughout the race despite his efforts. Pn20-21 - 27 ¹² / ₂₀ 58 ⁷ Jockey right rein was observed to have slipped momentarily soon after the start.
POLARIS	Pn19 - 10 ⁸ / ₁₉ 23 ² had an abrasion at the left hind pastern. 24 ⁸ / ₁₉ 49 ⁶ had left eye injury (sore). M19-20 - 5 ¹ / ₂₀ 73 ⁵ had to be checked and dropped back approaching the 1400mts.
CUPIDO	M19-20 - 5 ¹ / ₂₀ 77 ⁷ met interference approaching 300mts. 1 ² / ₂₀ 113 ¹¹ was observed to have broken a blood vessel.
ROMANESQUE	M19-20 - 27 ¹² / ₁₉ 53 ⁷ was observed to have a cut injury at the left hind hoof. 9 ¹ / ₂₀ 84 ⁷ met interference at the start.
