As such, the mare was certified unfit to race and was withdrawn on veterinary grounds. LOVELY BOY	D19-20 - 11 ² / ₂₀ 178 ⁰ was found to be lame by its right fore as such was withdrawn before coming under Starters order.
BELLA MIA	D18-19 - 23 ¹⁰ / ₁₈ 40 ² leaned in passing 400 metres.
MISS DUNCAN	D19-20 - 21 ¹ / ₁₉ 97 ⁰ bumped and due to which App lost his stirrups which he could not regain near 400metres. 30 ¹² / ₁₉ 138 ¹² met interference approaching 600 metres. 6 ² / ₂₀ 172 ⁸ met interference passing 900 metres.

On examination, the horse was found to be lame by its right-fore leg. D19-20 - 21 ¹ / ₁₉ (96) jumped awkwardly inwards at the start.
MASTER NOVAK	D19-20 - 24 ¹² / ₁₉ 128 ⁰ was extremely fractious before being loaded and was withdrawn before coming under starters orders. 7 ¹ / ₂₀ 143 ⁹ met interference soon after the start and again Approaching 900 metres. 11 ² / ₂₀ 178 ⁵ met interference and was steadied near 300 metres

TALENTED	D19-20 - 29 ¹⁰ / ₁₉ 61 ⁴ jumped awkwardly outwards at the start & Jockey were reprimanded for not sufficiently persevering with his mount during the race. 21 ¹ / ₁₉ 96 ⁵ Jockey reported that since he was not ready for the start, his left leg was not in the stirrup at the time the start was affected due to which his mount travelled wide and he was able to regain his stirrup soon thereafter. 31 ¹ / ₂₀ (165) Jockey has been cautioned for keeping an erratic course under the use of the whip in the final 300 metres.
CONQUERING BID	D19-20 - 10 ¹² / ₁₉ 120 ³ Jockey reported that his mount lugged-in in the straight. 24 ¹² / ₁₉ (132) App reported that his mount was inclined to lean in throughout the race and at the start 31 ¹ / ₂₀ 160 ⁹ jumped out awkwardly at the start and Jockey reported that his mount jumped out awkwardly due to which he lost his right stirrup, which he regained shortly. and Jockey has been reprimanded for his feeble riding in the straight. He has been informed that a similar riding effort will attract disciplinary action against him. 6 ² / ₂₀ 172 ⁷ met interference passing 900 metres. 11 ² / ₂₀ 178 ⁶ reared up as the start was affected and was slowly away.
VICTORIOUS KING	D19-20 - 26 ¹ / ₁₉ 105 ³ Jockey reported that he lost his left stirrup at the start, which he regained shortly.

NICHE CURRENCY D19-20 - 3⁹/₁₉9² met interference before the red marker. 31¹/₂₀161¹⁰ jumped awkwardly inwards and met interference at the start.

6th Race The Blazing Ace North India Derby (grade Iii) CI-Dr, Terms 1600 Mts.

ASHWA YASHOBALI D18-19 - 15⁴/₁₉(269) lugged out in the straight. HyM19 - 9⁹/₁₉111² Jockey was cautioned for failing to maintain a straight course in the final stages of the race. 16¹⁰/₁₉184⁸ bumped at about the 400 mtrs & met interference at about 700 mtrs.

HANCOCK D18-19 - 27⁴/₁₉291⁴ Jockey has been cautioned for failing to persevere with his mount in the straight. D19-20 - 31¹/₂₀(160) met interference near 1000 metres and Jockey has been cautioned for improper use of the whip, wherein he allowed his mount to shift-in under the use of the whip in the straight and sustained a cut injury on its left hind leg.

MISTER STUNNER D19-20 - 7¹¹/₁₉74⁶ saddle slipped forward during the race.

PLAYER D19-20 - 18¹⁰/₁₉54³ was inclined to lug-in in the straight.

PREMIER ACTION HyM19 - 1⁹/₁₉85² Jockey was severely reprimanded for failing to maintain a straight course at about the 400 mtrs. 13⁹/₁₉(116) jumped out slowly losing about 1 or 2 lengths.

PRINCE VALIANT Hy19-20 - 17¹¹/₁₉(25) met interference in 100 mtrs after the start. 22¹²/₁₉87² An enquiry has been opened into the running and riding. 19¹/₂₀(138) met interference at about the 800 mtrs. and sustained clipped injury on right hind.

THE CHEETAH M18-19 - 13⁴/₁₉236² met interference in the final stages. D19-20 - 14¹¹/₁₉84² Jockey reported that his mount was inclined to lug-out in the straight.

TOP SECRET D19-20 - 17¹⁰/₁₉(44) met interference at the start.

ADORABLE D18-19 - 15⁴/₁₉269³ Jockey reported that his mount was inclined to lug-in in the straight. D19-20 - 17¹⁰/₁₉46⁰ were withdrawn before coming under Starters orders as both the horses were extremely fractious before being loaded. 26¹¹/₁₉106⁴ was observed to have sustained a cut injury on her right-fore leg.

ELECTRA BgS19 - 27⁷/₁₉(146) Jockey was fined for the excessive use of whip on his mount during the race. Bg19-20 - 22¹¹/₁₉21² Jockey reported that his mount was running green throughout the race.

JUNGLE WAVE D19-20 - 30¹²/₁₉137¹² Jockey had to check his mount near 300 meters.

RESPONSIBLEFORLOVE D18-19 - 26²/₁₉168² met interference at the start. D19-20 - 26¹¹/₁₉106⁸ jumped awkwardly outwards and Jockey explained that this mount jumped outwards despite his efforts and he tried to pull his mount inwards at the start. and travelling some distance from the start and Jockey has been fined for using his whip in excess of the prescribed limit on his mount.

TUDOR HALL Pn19 - 16⁸/₁₉45³ had right eye injury (corneal ulcer). 26¹⁰/₁₉153³ had to be steadied and met interference at the start and again approaching the 600 metres. M19-20 - 22¹²/₁₉48² had to be checked and change course approaching the 200 metres. 18¹/₂₀96⁴ received check passing the 350 metres and met interference passing the 150 metres.

VEERABHADRA D18-19 - 18³/₁₉(208) had splayed one of its hind plates while being saddled and it would be time consuming to re-plate the filly and requested that he be permitted to remove the plate from the other hind leg. D19-20 - 7¹¹/₁₉(72) Jockey reported the loss of whip in the final 50 metres.

7th Race The Chairman Emeritus Cup CI-T, Terms 1200 Mts.

ASHWA JAGIRA D18-19 - 5⁴/₁₉249⁵ hesitated and then fly jumped, losing about 3 lengths. 21⁴/₁₉287⁰ was very fractious due to which the bridle, along with the equipment, came off. After reaching the Starting Gates, the gelding was fractious and did not allow all the declared equipments to be re-applied, as such, the gelding was withdrawn. 30⁴/₁₉306⁰ was extremely fractious inside the stalls and hurt himself and was in shock and was wobbling, as such, was withdrawn before coming under starters order. D19-20 - 31¹/₂₀(162) jumped out awkwardly at the start and Jockey was questioned with regard to his riding in the final stages of the race wherein he was observed to have eased up his mount before passing the post.

ASHWA JOSHILA D19-20 - 13⁹/₁₉15⁵ jumped out awkwardly at the start. 11²/₂₀175⁴ was restless in its Stall and had prematurely charged at the Gates once and when the Gates opened was slowly away.

BESHIKTASH Pn19 - 26⁷/₁₉10² leaned inwards in the final stages of the race. 15⁹/₁₉89⁷ jumped inwards at the start & met interference approaching the 600 metres, had right eye injury (sore eye, lacrimation). 5¹⁰/₁₉115³ had right eye injury (sore eye, lacrimation). D19-20 - 7¹/₂₀142⁴ Jockey has been cautioned for his feeble handling of his mount in the straight and was inclined to lug-in in the straight.

HOPE AND GLORY D18-19 - 20⁴/₁₉(281) reared up as the start was affected, as such, lost about 2 lengths at the start. D19-20 - 24¹⁰/₁₉(58) raced keen and shifted out to avoid clipping the front runner passing 900 metres.

UNDISPUTED D19-20 - 13⁹/₁₉14⁴ met interference near 1100 metres. 11⁰/₁₉34⁴ met interference at the start & again near 700 metres. 19¹¹/₁₉92⁶ was tightened soon after the start and Jockey has been cautioned for travelling wide at the bend for no apparent reason.

VAZRA D19-20 - 14¹/₂₀(149) shifted out under the use of the whip in the straight.

8th Race The Ace Parkway Plate CI-II, 60-86, (Lower Class Eligible.) 1600 Mts.

BLUE TIGER D18-19 - 18³/₁₉(209) met interference soon after the start. D19-20 - 17¹⁰/₁₉46⁴ Jockey has been cautioned for his feeble riding in the straight. 31¹⁰/₁₉70⁵ lugged-out in the straight.

BIG APPLE D19-20 - 11⁰/₁₉32⁴ jumped awkwardly outwards at the start & Jockey reported that his mount grabbed the bit and was inclined to drift reported that his mount grabbed the bit and was inclined to drift outwards. had sharp molars and had sustained a cut injury on its right hind leg. 7¹/₂₀142⁵ App reported loss of his whip near 300 metres and was found to be lame by its right hind leg. 24¹/₂₀154³ Jockey was cautioned for allowing his mount to drift out without taking corrective action.

TOP KING D19-20 - 13⁹/₁₉14⁵ met interference near 1100 metres.

GO MY GIRL	D19-20 - 24 ¹² / ₁₉ 131 ⁵ Jockey reported that his mount was restless in the gates, as such, the mare was slowly away.
ZELBET	D19-20 - 1 ¹⁰ / ₁₉ (31) was found to have sustained a cut injury on its right hind tendon.
HELLO HELLO	D19-20 - 14 ¹¹ / ₁₉ 86 ³ was slowly away. 17 ¹² / ₁₉ 124 ³ slow to start.
IMBALI	D19-20 - 24 ¹⁰ / ₁₉ 60 ³ was running green thorough out the race and soon after the start. 21 ¹¹ / ₁₉ (97) met interference soon after the start.
AUTUMN GOLD	D19-20 - 3 ⁹ / ₁₉ 8 ⁶ Jockey was severely reprimanded for failing to exhibit sufficient vigour on his mount during the race. 19 ¹¹ / ₁₉ 95 ⁰ was found to be lame by its right-fore leg, as such, was withdrawn on veterinary grounds. 24 ¹² / ₁₉ 128 ² Jockey reported that his mount was inclined to lean-in in the early part of the race and then in the straight was inclined to lean out. 11 ² / ₂₀ 176 ² was tightened while racing on the inside of RIOS PRINCESS passing 1000 metres.
TREASURE	D19-20 - 14 ¹¹ / ₁₉ 84 ³ Jockey reported that his mount lugged-out during the race. 26 ¹¹ / ₁₉ 106 ¹⁰ suddenly ducked inwards due to which the Jockey lost his balance which resulted in him losing his right stirrup in the final 100 metres. 7 ¹ / ₂₀ (140) was inclined to lug-in in the straight. 24 ¹ / ₂₀ (157) took a fly jump at the start.
