

RACING INCIDENTS IN BRIEF OF IMMEDIATE PAST 6 RUNS

1 st Race The Nora Plate Div - II	CI-V, 0-25	1400 Mts.
SUPREME COMMANDER	Md19-20 - 8 ² / ₂₀ 174 ⁵ met interference negotiating the bend.	
GLORIOUS WIND	Md20-21 - 28 ¹ / ₂ 199 ⁵ was observed to be hanging in in the final stages of the race.	
CHANAKYA	Oty19 - 6 ⁶ / ₁₉ 108 ⁰ was permitted to be withdrawn on veterinary grounds before coming under the Starters orders, trotting lame on right hind. Md19-20 - 1 ¹ / ₂₀ 115 ² Trainer was fined for not using Ear Plugs on his charge for which permission was not obtained. 29 ¹ / ₂₀ 164 ² jumped awkwardly inwards at the start. Md20-21 - 10 ² / ₂₁ 115 ² Jockey was cautioned for shifting in under use of the whip in the final stages of the race.	
AL HILALEE	Md19-20 - 8 ¹ / ₂₀ 125 ⁹ jumped awkwardly inwards at the start was affected. and Jockey was fined for not improving position in the early stages of the race.	
FAMOUS QUEEN	Md19-20 - 15 ¹ / ₂₀ 138 ⁹ drifted out passing the 300 metres. Md20-21 - 13 ¹ / ₂₁ 77 ⁰ withdraw Veterinary grounds as the mare was found to be lame on left hind.	
ORANGE PEKOE	Md19-20 - 13 ² / ₂₀ 186 ⁷ Jockey was fined for not persevering with his mount from the 300 metres till 50 metres before the post. Md20-21 - 10 ² / ₂₁ 115 ³ sustained superficial injury to the gum after the race.	
VELOCITY	Md19-20 - 26 ¹⁰ / ₁₉ 18 ¹⁰ was slow to start losing about a length. 29 ¹¹ / ₁₉ 66 ³ sustained superficial injury on right hind pastern. 29 ¹ / ₂₀ 158 ⁵ Jockey was fined for shifting out under use of the whip entering the straight. Md20-21 - 13 ¹ / ₂₁ 76 ⁵ fly jumped as the start was affected losing about 2 lengths.	
PRICE STRIKER	Oty19 - 6 ⁶ / ₁₉ 111 ⁰ was permitted to be withdrawn due to non availability of a replacement jockey. Md19-20 - 18 ¹⁰ / ₁₉ 76 ⁶ met interference lost 2 lengths. 31 ¹ / ₁₉ 22 ⁷ Jockey was fined for shifting out and travelling wide out from the 300 metres till the winning post. 9 ¹¹ / ₁₉ 33 ⁹ jumped awkwardly inwards losing about a length.	
ARAZINGER	Md19-20 - 7 ² / ₂₀ 167 ¹⁰ sustained puncture wound on left shoulder. 23 ² / ₂₀ 202 ⁰ was permitted to be withdrawn, trotting lame due to myopathy. Md20-21 - 6 ¹¹ / ₂₀ 1 ¹¹ Jockey was cautioned for negotiating the final bend wide for no apparent reason. 15 ¹² / ₂₀ 41 ⁰ sustained contusion and therefore was permitted to be withdrawn on Veterinary grounds before coming under the Starters orders.	
THOUSAND FENCE	Oty19 - 12 ⁵ / ₁₉ 60 ⁰ planted, thereafter ducked and got loose rider less. 30 ⁵ / ₁₉ 91 ⁷ jumped awkwardly inwards. 7 ⁶ / ₁₉ 114 ⁰ met interference passing the 800 metres. Md19-20 - 14 ² / ₂₀ 194 ³ received check negotiating the final bend and lost its right hind shoe during the above race.	
CLEONA	Md19-20 - 7 ² / ₂₀ 165 ⁰ was permitted to be withdrawn on veterinary grounds (lame on right fore) before coming under Starters orders.	
BE MY STAR	Md19-20 - 8 ³ / ₂₀ 216 ⁴ was slow to start losing about 2 lengths. Md20-21 - 15 ¹² / ₂₀ 40 ⁰ withdraw on veterinary grounds as it was found to have EIPH(Gr 3). 11 ² / ₂₁ 130 ¹² was slow to start losing about 3 lengths and thereafter ran detached.	
2 nd Race The El Tropic Plate	CI-IV, 20-45, 5 years old only	1200 Mts.
RHIANNON	Md19-20 - 14 ² / ₂₀ 193 ³ jumped awkwardly inwards.	
FIAT JUSTITIA	Md19-20 - 14 ² / ₂₀ 190 ⁷ jumped awkwardly outwards and met interference bumped the inner railings and dropped back passing the 800 metres. returned lame on left fore after the race. Md20-21 - 15 ¹² / ₂₀ 43 ⁰ withdraw on veterinary grounds as it was found to have an abscess on right fore hoof.	

STAR FLING Md19-20 - 8²/₂₀175⁷ sustained superficial injury on left hind cannon. Md20-21 - 24¹/₂₀59⁶ Jockey was reprimanded for dropping his hands before passing the winning post, though on a beaten horse, further Jockey reported the loss of whip at about the 350 metres. 10²/₂₁119⁶ was observed to drop back passing the 250 metres.

STRIKING DISTANCE Md19-20 - 14²/₂₀189⁸ met interference and stumbled and dropped back soon after the start Md20-21 - 14¹/₂₁85⁴ met interference in the final stages of the race and received check as the start was affected.

TRENDING PRINCESS Md19-20 - 23²/₂₀198² met interference at the start. Md20-21 - 24¹/₂₀59⁰ reared up inside the stall, suffered from Epistaxis and therefore was permitted to be withdrawn on veterinary ground.

FUN LOVER Md20-21 - 24¹/₂₀(54) met interference soon after the start and forcing out forcing out 250 metres till the winning post.

GLORIOUS FLAME Md19-20 - 14¹/₁₉36⁴ was observed to be hanging in for major part of the race. 25¹/₁₉(96) was observed to be hanging out under pressure in the straight. 8¹/₂₀125² was inclined to hang in in the final stages of the race. and sustained bruises on left hind fetlock.

BIG TREASURE Md19-20 - 6¹/₁₉68³ jumped awkwardly outwards as the start. 8¹/₂₀127² turned her head towards the left as the start was affected and hence was slow to start losing about a length or two.

DAIYAMONDO Md19-20 - 25¹/₁₉96⁷ met interference at the start and again passing the 1100 metres. 7²/₂₀167⁸ was found to be trotting lame on right fore during Veterinary examination after the last race, further endoscopic examination revealed EIPH (Grade 3).

3rd Race The Icebreaker Plate

CI-IV, 20-45

1600 Mts.

DIVINA Md19-20 - 19¹/₁₉87² got keen 50 metres after the start and to avoid clipping the heels of the front runner Jockey checked his mount and shifted out. 15¹/₂₀136² fly jumped as the start was affected losing about 2 to 3 lengths. Md20-21 - 6¹/₂₀4⁵ burst its blood vessels.

SALVO M19-20 - 8¹/₁₉29⁹ jumped outwards at the start. 26²/₂₀162⁶ met interference passing 150 metres.

MAJESTIC WIND Md19-20 - 13²/₂₀180⁶ was observed to run green and bumped the inner rails at about the 300 metres. Md20-21 - 17¹/₂₀(48) was hanging in the straight despite jockey's efforts. 1¹/₂₁67⁵ received check at the start & Jockey was fined for stopping riding out his mount before passing the post.

OTUS Md19-20 - 29¹/₂₀161⁴ slow to start losing about 2 lengths and met interference at 800 meters and dropped back about 2 to 3 lengths. Md20-21 - 13¹/₂₁79³ was observed to bump the inner railings passing the 1300 metres.

CITY OF SAILS Md20-21 - 4²/₂₁113⁰ was reluctant to be stalled despite all efforts and therefore was permitted to be withdrawn before coming under the Starters orders.

WELCOME WINNER Md19-20 - 23²/₂₀196² Jockey reported that his mount was hanging in under pressure.

KING HOROF Md19-20 - 7²/₂₀166⁴ veered out sharply soon after the start. 8³/₂₀211⁵ jumped awkwardly outward. Md20-21 - 14¹/₂₀31⁵ jumped awkwardly outwards at the start.

KASI MASI Md19-20 - 22¹/₂₀151⁸ fly jumped as the start was affected losing about 2 lengths. Md20-21 - 14¹/₂₀37⁴ flyjumped as the start was affected.

SIFAN Md20-21 - 4²/₂₁113⁹ bumped the inner rails passing the 1300 metres.

4th Race The Madras Race Club Cup

CI-3y, Maiden

1200 Mts.

CLOUD JUMPER Md20-21 - 4²/₂₁110¹⁰ met interference immediately after the start.

STRIDE FOREVER Md20-21 - 24¹²/₂₀56⁶ Jockey was cautioned for shifting out under use of the whip passing the 300 metres despite being clear of the field.

ABILITARE Md20-21 - 4²/₂₁110⁷ Jockey reported that he accidentally lost his whip passing 200 metres.

GEISHA GIRL Md20-21 - 21¹/₂₁92⁷ was slow to start and jumped out awkwardly, losing about 6 lengths as the start was affected.

HALLUCINATE Md20-21 - 4²/₂₁110⁶ jumped awkwardly inwards.

PINK PEARL Md20-21 - 11¹/₂₁61⁷ Jockey was severely cautioned for dropping his hands before passing the post though on a beaten horse.

5th Race The M.Ct.M.Chidambaram Chettiar Memorial Cup CI-ii, 60-85 1200 Mts.

VERSALLIES Md20-21 - 24¹²/₂₀58⁰ withdraw on veterinary grounds as it was found to have a right capped elbow.

GOOD FORTUNE Md19-20 - 28¹¹/₁₉58⁷ jumped awkwardly and bumped at the start. 8³/₂₀215⁷ met interference passing the 1000 metres till the 800 metres.

EMISSARY Md19-20 - 13²/₂₀184⁰ stopped galloping passing the 800 metres, drifted wide out and did not finish the race.

OSCAR THUNDER Md20-21 - 6¹¹/₂₀6⁶ lost right fore shoe.

SOARING HIGH M19-20 - 16¹/₂₀(92) had an abrasion at the left hind pastern. 12³/₂₀181³ met interference at the start and had checked his mount and changed course approaching 1000mts.

MZILIKAZI M19-20 - 24¹/₂₀111⁸ shifted out and brushed the haunches and was steadied in the final stages of the race.

NIGHT HUNT Pn19 - 31⁸/₁₉64⁴ jumped outwards at the start and met interference approaching the 1000 metres. 26¹⁰/₁₉156² met interference in the final stages of the race. M19-20 - 16¹/₂₀93⁵ met interference at the start and Jockey reported that his mount hung-in throughout the race and maintained an erratic course in the final stages. and was found to be sore by the right fore leg.

BREAKING BOUNDS Md19-20 - 19¹²/₁₉91⁴ got keen approaching the 1200 metres and had to be checked and in trying to control his mount. Md20-21 - 14¹/₂₁91⁵ Jockey was fined for excessive use of the whip.

OPTIMUS COMMANDER Md19-20 - 23¹/₂₀156⁸ met interference and dropped back by 2 to 3 lengths. 7²/₂₀170⁷ Jockey reported that his mount was inclined to hang out and drifted out entering the straight despite his efforts.

RUTBEDAAR Md20-21 - 14¹/₂₁90¹¹ met interference entering the straight.

SENTOSA Md19-20 - 22¹/₂₀149² met interference 50metres after the start. Md20-21 - 6¹/₂₀6³ Jockey was cautioned for unsettling himself and his mount in the initial stages of the race for no apparent reason. 1¹/₂₁64³ Jockey was fined for excessive use of the whip.

PRICELESS RULER Md19-20 - 15¹/₂₀140⁴ received a check passing the 450 metres. Md20-21 - 20¹/₂₀20⁹ Jockey was severely cautioned for taking a long lead whereby his mount tired and dropped back passing the 250 metres.

6th Race The Nora Plate Div - I CI-V, 0-25 1400 Mts.

LADY BLAZER Md19-20 - 7³/₂₀204⁴ stumbled soon after the start and met interference passing the 800 metres.

MAJESTIC CHARMER Md20-21 - 14¹²/₂₀31⁴ slowly off losing about a length at the start.

WELCOME CHAKKARAM Md19-20 - 26¹²/₁₉108⁸ slow to start losing about 3 lengths. 8¹/₂₀125¹⁰ jumped awkwardly inwards at the start was affected.

HEART OF GOLD Md19-20 - 13¹²/₁₉81⁴ met interference negotiating the final bend & returned bleeding (EIPH) after the race. 14¹/₂₀(129) Jockey was fined for excessive use of the whip. 23¹/₂₀157⁸ was found to have EIPH (Gr-4).

PERFECT SUPPORT Md19-20 - 15¹/₂₀144⁵ met interference passing the 1350 metres. 29¹/₂₀160⁰ was permitted to be withdrawn on Veterinary grounds (lame on left hind) before coming under the Starter's orders. Md20-21 - 28¹/₂₁(99) Jockey was fined for exalting victory sign before passing the post.

QUEEN JUSTITIA Md20-21 - 6¹¹/₂₀5¹¹ Jockey reported that his mount did not feel right and stopped galloping entering the straight despite efforts and had lost her Left fore shoe during the race. 17¹²/₂₀48¹¹ was observed to drop back passing the 200 metres.

BEAUTIFUL PRINCESS Md19-20 - 25¹²/₁₉96⁴ received a check and lost about 2 to 3 lengths. Md20-21 - 1¹/₂₁63⁴ met interference entering the straight. 21¹/₂₁98³ Jockey reported that the saddle shifted back soon after the start whereby he could not do justice to his mount.

DREAM RUN Md19-20 - 1¹/₂₀109⁶ was slow to start losing about 3 lengths and dropped back passing the 600 mts.

SHELOMI Md20-21 - 13¹/₂₁(76) Trainer was fined for the inconsistent manner of running of his charge.

SABIHAA Oty19 - 27⁴/₁₉22⁵ met interference at the start. 17⁵/₁₉76⁴ sustained an overreach cut injury on the inside left hock. Md19-20 - 22¹/₂₀147⁹ met interference at the start. 8³/₂₀216⁰ ducked under the stalls and the saddle came undone, therefore he was permitted to be withdrawn.

GARDINER Md20-21 - 1¹/₂₁63⁶ was observed to drop back approaching 1600 metres and caught up with the field passing the 1300 metres. 10²/₂₁115⁷ met interference as the start was affected.

TENCENDUR Md19-20 - 15¹/₂₀144⁴ Apprentice Jockey was fined for maintaining a wide course for major part of the race for no apparent reason. 14²/₂₀194⁵ Apprentice Jockey was fined for excessive use of the whip and further severely cautioned for losing his reigns passing 300 metres which he regained after travelling a few strides.
