

RACING INCIDENTS IN BRIEF OF IMMEDIATE PAST 6 RUNS

1st Race The Beginners Plate

CI-IV, 20-45

1100 Mts.

MEHRZAD HyM19 - 21¹⁰/₁₉191³ App reported that his mount was trying to run out soon after the start. Hy19-20 - 17²/₂₀183¹² returned lame on right fore due to shoulder sprain.

WAITOMA Hy19-20 - 24¹¹/₁₉(28) met interference at about the 300 mtrs.

STEPPER Hy19-20 - 8¹²/₁₉62⁴ Jockey reported that his mount was hanging in in the straight

MERRY DANE HyM19 - 26⁸/₁₉82³ met interference soon after the start and again at about the 850 mtrs & sustained cut injury over left hind. 30⁹/₁₉142⁸ App reported that his mount was running green throughout the race was trotting lame on right fore due to shoulder sprain.

ELEGANT STROKE Hy19-20 - 11¹¹/₁₉14⁵ ran green throughout the race. 24¹¹/₁₉28³ Jockey reported that his mount ran green in the straight in the process veered out in spite of his best efforts.

FOUR ONE FOUR HyM19 - 21¹⁰/₁₉191⁴ Jockey was severely reprimanded for not being more vigorous in his efforts soon after entering the straight. Hy19-20 - 10¹¹/₁₉12⁵ Jockey was cautioned for changing course on more than one occasion in the straight for no apparent reason.

LET IT BE ME Hy19-20 - 9¹²/₁₉66² App reported that his mount was tending to run out in the final stages of the race more so under pressure. 30¹²/₁₉104⁷ met interference 50 metres after the start. 13¹/₂₀123⁴ has bled.

THAT'S MY SPEED Hy19-20 - 24²/₂₀193¹² stumbled at about the 600 mtrs for no apparent reason.

MAGIC STREET HyM19 - 19⁸/₁₉76⁵ met interference soon after the start. 22⁹/₁₉133² met interference at about the 900 mtrs. Hy19-20 - 10¹¹/₁₉13⁹ App reported that his mount stumbled soon after the start for no apparent reason. 9¹²/₁₉68⁰ was examined at the Starting gates and as the gelding was showing the signs of discomfort, was permitted to be withdrawn. 10²/₂₀164¹¹ met interference at about the 300 mtrs.

SUN DANCER Hy19-20 - 25¹¹/₁₉41⁶ met interference in immediately after the start and App reported loss of whip at about the 350 mtrs. 22¹²/₁₉88⁴ took fly jump and lost about a length.

2nd Race The Deccan Star Plate Div - I

CI-III, 20-45

1200 Mts.

ASHWA YASHOBALI HyM19 - 9⁹/₁₉111² Jockey was cautioned for failing to maintain a straight course in the final stages of the race. 16¹⁰/₁₉184⁸ bumped at about the 400 mtrs & met interference at about 700 mtrs. D19-20 - 18²/₂₀186⁰ was found to be lame by its left-fore leg, as such, was withdrawn before coming under Starters order on veterinary grounds.

RAPID FIRE Hy19-20 - 17²/₂₀181² met interference soon after the start. 22²/₂₀189⁹ met interference at about the 800 mtrs and received interference at about the 800 mtrs, was trotting lame on right fore due to fetlock joint sprain.

SITARA BgS19 - 6⁷/₁₉105² met interference passing the 150 Metres. Hy19-20 - 3¹¹/₁₉3³ Jockey reported that his mount was lugging in, in the final stages of the race. 25¹¹/₁₉38⁸ met interference at the start & An enquiry has been opened into the running and riding. 17²/₂₀181³ returned bleeding.

LA MER HyM19 - 7¹⁰/₁₉162⁵ met interference at about the 1000 mtrs & revealed sharp molars on both sides. Hy19-20 - 1¹²/₁₉49² met interference negotiating the final bend. 10²/₂₀159⁴ met interference in the final stages of the race and lost its right fore shoe during the running of the race. 17²/₂₀178⁹ bumped at about the 900 mtrs.

MERITOCRACY HyM19 - 28¹⁰/₁₉203⁰ was observed to be trotting lame on right fore due to shoulder sprain, as such the mare has been permitted to be withdrawn on Veterinary grounds. Hy19-20 - 22²/₂₀185⁷ sustained cut injury over left hind.

BLAZER HyM19 - 8¹⁰/₁₉171⁴ App was fined for riding contrary to the given instructions in that he shifted out from about 800 mtrs instead of positioning his mount on the rails as instructed and veered out further in the straight for no apparent reason. Hy19-20 - 22²/₂₀185⁸ On endoscopic examination, revealed as bleeder.

SOUL EMPRESS HyM19 - 4⁸/₁₉35³ App. was cautioned for traveling wide while negotiating the final bend and in the straight and for failing to maintain straight course soon after the start. Hy19-20 - 6¹/₂₀(118) Jockey reported that his mount was hanging in, in the final stages of the race more so under pressure. 9²/₂₀150⁵ Jockey reported that his mount was hanging in for great part of the race.

STAR GAZER HyM19 - 28¹⁰/₁₉203⁸ the gelding was trotting lame on left fore due to shoulder sprain. Hy19-20 - 25¹¹/₁₉38⁵ returned lame on left fore due to shoulder sprain.

DANCING DOLL HyM19 - 21¹⁰/₁₉190⁶ jumped inside awkwardly & the filly sustained bleeding cut injury over left fore. Hy19-20 - 25¹¹/₁₉42⁴ jumped out awkwardly in the process losing about 1 or 2 lengths. 27¹/₂₀147⁹ lost his hind action as the start was effected in the process lost about a length. 10²/₂₀159³ the mare sustained cut injury over right hind.

3rd Race The Grand Entry Plate Div - II

CI-III, 40-65

1400 Mts.

GALLOPING GANGSTER Hy19-20 - 17¹¹/₁₉25² met interference in 100 mtrs after the start and bumped at about the 200 mtrs. 22¹²/₁₉(84) Jockey was cautioned for shifting in 50 mtrs after the start in the process crowding the runners drawn on his inside. 19¹/₂₀131² Jockey reported that his mount was hanging in for greater part of the the race.

DANDY MAN Hy19-20 - 30¹²/₁₉107⁵ severe interference approaching 200 metres. 5¹/₂₀111² jumped out slowly losing about 1 or 2 lengths. 16²/₂₀169² jumped out slowly losing about 2 or 3 lengths.

THAT'S MY MAGIC Hy19-20 - 10²/₂₀163¹¹ slow out.

PREMIER ACTION HyM19 - 19⁹/₁₉85² Jockey was severely reprimanded for failing to maintain a straight course at about the 400 mtrs. 13⁹/₁₉(116) jumped out slowly losing about 1 or 2 lengths. D19-20 - 18²/₂₀186⁸ was inclined to lug out while negotiating the bend and also briefly in the straight.

AYUR SHAKTI HyM19 - 27¹⁰/₁₉197⁰ met interference soon after the start. Hy19-20 - 10²/₂₀160⁷ was observed to have developed swelling over right hind. 24²/₂₀196⁰ Jockey was cautioned for failing to maintain a straight course in the final stages of the race.

N R I VISION Hy19-20 - 9²/₂₀150² Jockey reported that his mount has soft mouth and was also throwing her head up in the initial stages of the race as such he could not position his mount. 17²/₂₀178⁵ met interference at about the 900 mtrs.

ICE WARRIOR Hy19-20 - 11¹¹/₁₉16⁰ was observed to be trotting lame on left hind, as such the colt has been permitted to be withdrawn. 9²/₂₀151³ Jockey reported that his mount was slow into stride in the initial stages of the race because of which he was forced to race at the rear end.

MARK MY DAY Hy19-20 - 16¹²/₁₉73³ met interference at the start. 22²/₂₀(186) took a fly jump as the start was effected in the process lost about a length.

4th Race The Deccan Star Plate Div - II

CI-III, 40-65

1200 Mts.

CITY OF BLOSSOM Hy19-20 - 24²/₂₀196⁵ bumped at about the 200 mtrs.

MAKRAM Hy19-20 - 9²/₂₀150¹⁴ was slow into stride losing about 1 or 2 lengths. 17²/₂₀(178) Trainer was cautioned for inconsistent running of his charge.

MARINA DEL REY HyM19 - 9⁹/₁₉113⁵ returned bleeding from both the nostrils. Hy19-20 - 23¹²/₁₉95² was denied a clear un in the final 400 mtrs due to wall of horses racing in front & reported loss of the whip at about the 100 mtrs.

MAX Hy19-20 - 1¹²/₁₉45² jumped out slowly losing about 3 to 4 lengths. 10²/₂₀159⁸ met interference about 800 mtrs to 700 mtrs.

FLAMINGO FAME HyM19 - 16¹⁰/₁₉180⁴ sustained superficial injuries over right hind.

CLASSY GUY HyM19 - 21¹⁰/₁₉(194) App was cautioned for failing to maintain a straight course in the final stages of the race. Hy19-20 - 5¹/₂₀113¹¹ clipped the heel of front horse DUNKIRK and stumbled at about the 800 mtrs. 10²/₂₀162¹¹ met interference before the red marker, and App was fined for travelling wide in the straight for no apparent reason.

BEST IN SHOW HyM19 - 23⁹/₁₉(134) Jockey was cautioned for failing to maintain a straight course in the final stages of the race.

5th Race The Srisailam Plate

CI-IV, 20-45

1200 Mts.

LINEWILER Hy19-20 - 19¹/₂₀136⁹ met interference at about 100mts.

AINTREE Hy19-20 - 3¹¹/₁₉92² Jockey was severely reprimanded for failing to maintain a straight course in the final stages of the race and lost its right hind shoe during the running of the race.

RED SNAPER Hy19-20 - 5¹/₂₀110³ stumbled soon after the start for no apparent reason. 10²/₂₀158⁶ Jockey reported that his mount was hanging in, in the straight.

BUTTONWOOD HyM19 - 8⁹/₁₉101³ was observed to be trotting short on both fores.

ANGEL TESORO Hy19-20 - 24¹¹/₁₉(29) sustained lacerated injuries over right fore.

GOOD CONNECTION Hy19-20 - 24²/₂₀201² was hanging in from about the 400 mtrs more so under pressure, as such Jockey could not able to ride out his mount to complete advantage in the final stages of the race.

HIDDEN HOPE Hy19-20 - 30¹²/₁₉(105) Jockey was cautioned for drifting out in the final stages of the race for no apparent reason.

PRIME GARDENIA Hy19-20 - 9²/₂₀149⁹ Jockey reported that his mount was trying to run out throughout the race.

SURSEINE HyM19 - 7¹⁰/₁₉165⁴ saddle slipped during the running of the race. 16¹⁰/₁₉188¹⁰ planted and lost about distance
Hy19-20 - 3¹¹/₁₉7⁶ jumped out slowly losing about 3 or 4 lengths. 10²/₂₀(164) met interference at about the 1000 mtrs. and returned lame on left fore.

FLEUR Hy19-20 - 23¹²/₁₉89⁵ Jockey reported that his mount ran green throughout the race inspite of their best efforts.

BREAK THE ICE Hy18-19 - 10²/₁₉179⁰ was reluctant to be stalled inspite of several attempts, as such the filly has been permitted to be withdrawn. Hy19-20 - 9¹²/₁₉66⁸ met interference soon after the start.

ROYAL VALENTINE Hy19-20 - 17¹¹/₁₉21⁷ Jockey reported that his mount was trying to run out in the process veered out in the straight inspite of his best efforts.

7th Race The Grand Entry Plate Div - I

CI-III, 40-65

1400 Mts.

ARTISTRY Hy19-20 - 23¹²/₁₉94² Jockey reported that his mount was hanging out throughout the race. 10²/₂₀160⁴ met interference at about the 1000 mtrs.

EGYPTIAN PRINCE HyM19 - 2⁹/₁₉96² Jockey reported loss of whip at about the 300 mtrs.

GUIDING FORCE Hy19-20 - 16¹²/₁₉77² Jockey was cautioned for travelling wide in the straight for no apparent reason.

BRITISH EMPRESS BgS19 - 29⁸/₁₉87³ burst its blood vessels. HyM19 - 5⁸/₁₉(43) veered out soon after the start & returned bleeding from right nostril. Md19-20 - 1¹/₂₀113⁷ broke a blood vessel during the race.

RHYTHM SELECTION HyM19 - 19¹/₁₉88³ met interference in the final stages of the race and was denied a clear run in the straight due to wall of horses racing in front. Hy19-20 - 10¹/₁₉10⁵ denied a clear run due to wall of horses racing in front and in the final 200 mtrs.

STAR OF TIARA HyM19 - 16¹⁰/₁₉184⁵ Jockey was severely reprimanded for forcing a passage at about the about 700 mtrs. Hy19-20 - 22²/₂₀185⁴ Jockey was fined for losing his position in the initial stages of the race whilst travelling with front runners and thereafter veering out while negotiating the final bend for no apparent reason.

MR.SHANGHAI HyM19 - 48¹/₁₉40⁰ was observed to have developed swelling over left hind fetlock joint. As such the gelding has been permitted to be withdrawn on Veterinary grounds. Hy19-20 - 9²/₂₀155⁷ met interference soon after the start.

ASHWA BRAVO Hy19-20 - 24²/₂₀(201) met interference at about the 700 mtrs.

MIND READER Hy19-20 - 17¹¹/₁₉27⁵ App reported that his mount held the bit and ran out from about the 800 and also in the straight inspite of his best efforts. 30¹²/₁₉104⁵ Jockey was fined for taking a long lead in the initial stages of race resulting in the gelding tired and dropped back in the final 150 metres. 17²/₂₀175⁸ met interference in soon after the start. and App was cautioned for taking long lead in the initial stages of the race resulting in his mount tiring in the final stages of the race and dropping back. 22²/₂₀(191) Trainer was fined for inconsistent running of his charge.

8th Race The Own Opinion Plate

CI-IV., 20-45

1200 Mts.

UNSTOPPABLE HyM19 - 30⁹/₁₉140⁵ jumped out slowly losing about 1 or 2 lengths & revealed sharp molars on both sides. 27¹⁰/₁₉199² severe interference approaching the final 300 mtrs.

AMYRA Hy19-20 - 17²/₂₀179³ met interference soon after the start.

BELLE SPRINGS Hy19-20 - 9¹²/₁₉65³ ran green throughout the race inspite of Jockeys' efforts. 5¹/₂₀109² Jockey reported that his mount was trying to run out in the straight more so under pressure. 27¹/₂₀144² Jockey reported that his mount was hesitant to take the gap on the rails in the final 200 mtrs as such he was forced to shift out and make his move was noted.

JUST INCREDIBLE Hy19-20 - 16¹²/₁₉73⁴ Jockey reported that his mount was tending to run out throughout the race.

MACHISMO HyM19 - 24⁷/₁₉19⁸ Jockey was cautioned to be more vigorous in his efforts in the straight. 26⁸/₁₉79⁰ was observed to be trotting short on both fore, as such the horse has been permitted to be withdrawn on Veterinary grounds. 9⁹/₁₉108⁴ was observed to travel wide in the straight inspite of Jockeys efforts, the rig revealed lame on right hind due to back sprain.

BEAUTIFUL LUV Hy19-20 - 16²/₂₀165⁸ met interference at about the 600 mtrs.

AFRICANUS Hy19-20 - 5¹/₂₀112⁸ sustained bleeding cut injury over left fore.

DUE DILIGENCE Hy19-20 - 30¹²/₁₉103⁴ Jockey reported that his mount ran green for greater part of the race. 16²/₂₀165⁴ met interference soon after the start.

MELTING ICE Hy19-20 - 11¹¹/₁₉14⁴ met interference at about the 200 mtrs.

MISTY RIVER Hy19-20 - 16²/₂₀165⁷ met interference at about the 150 mtrs.

MORINGA Hy19-20 - 17²/₂₀174⁴ Jockey reported that his mount reared up inside the stalls as the start was effected resulting in him hitting his head to the bar of the starting gates in the process lost couple of lengths.
