1 st Race The Peter & Hyacinth Gibson Memorial Cup Div - III	CI-IV, 20-45	1200 Mts.
VICTORY WALK	Md19-20 - 15 ¹ / ₂₀ 136 ³ met interference at the start. 13 ² / ₂₀ (180) Jockey was fined for using his hands on the neck of the horse in the final stages of the race.	
PACIFIC	Md19-20 - 6 ¹² / ₁₉ 70 ⁴ took a fly jump as the start was affected.	
PARRYS GLORY	Md20-21 - 20 ¹¹ / ₂₀ 19 ³ met interference passing the 300 meters and sustained a superficial injury of left hind inner bulb.	
NYMERIA	Md19-20 - 25 ¹² / ₁₉ 101 ² met interference at the start.	
CHOIR	Md18-19 - 15 ² / ₁₉ 157 ⁷ was hanging out in the straight from the 300 metres to the winning post. 16 ³ / ₁₉ 202 ⁰ was permitted to be withdrawn on veterinary grounds (suffering from diarrhoea). Oty19 - 30 ⁵ / ₁₉ 97 ⁰ was permitted to be withdrawn on veterinary grounds, lame on right fore due to sore shin. Md19-20 - 15 ¹ / ₂₀ 137 ⁴ The Sheep Skin Nose band used on came loose in the race.	
BREAK THE SILENCE	Md19-20 - 22 ¹ / ₂₀ 147 ⁶ received a check soon after the start.	
CHALOUCI GIRL	Md19-20 - 13 ² / ₂₀ 182 ⁰ was reluctant to be stalled and was permitted to be withdrawn. Md20-21 - 20 ¹¹ / ₂₀ 19 ¹⁰ was slowly away and lost about 5 to 6 lengths at the start.	
QUEEN SUPREME	Md19-20 - 8 ¹ / ₂₀ 127 ⁹ mt interference and rider lost balance and lost right iron stirrup which he regained after travelling a few strides. 23 ¹ / ₂₀ 153 ⁷ was slow to start losing about 2 lengths. Md20-21 - 6 ¹ / ₂₀ 5 ⁸ met interference at the start.	
SONGBIRD	Md20-21 - 6 ¹¹ / ₂₀ 4 ¹² met interference passing the 800 metres.	
WILD PASSION	Oty19 - 12 ⁵ / ₁₉ 63 ³ met interference at about the 500 metres. 30 ⁵ / ₁₉ 92 ⁶ slipped from fore momentarily at the 800 metres passage. 7 ⁶ / ₁₉ 120 ² stumbled at about the 800 metres.	
KINGS PRIDE	Oty19 - 6 ⁶ / ₁₉ 105 ² sustained superficial injury on right hind cannon. Md19-20 - 28 ¹¹ / ₁₉ 59 ⁶ met interference at about the 100 metres and suffered from EIPH during the race. 14 ² / ₂₀ 193 ⁹ returned bleeding after the race.

BLUE PATENT	Md20-21 - 20 ¹¹ / ₂₀ 18 ⁹ sustained a superficial injury on left hind cannon.	
FUN LOVER	Md19-20 - 7 ¹² / ₁₉ 80 ⁹ took a fly jump as the start was affected. 25 ¹² / ₁₉ 101 ⁵ met interference negotiating the bend.	
MEDOVIK	Md19-20 - 18 ¹⁰ / ₁₉ 4 ⁰ was permitted to be withdrawn on veterinary grounds, lame on right hind due to sore right hock. 8 ¹ / ₂₀ 125 ³ jumped awkwardly inwards at the start was affected. 22 ¹ / ₂₀ 147 ⁵ jumped awkwardly and stumbled at the stat. 29 ¹ / ₂₀ 159 ³ Jockey reported that his mount was running green for major part of the race. 14 ² / ₂₀ 193 ⁴ jumped awkwardly outwards as the start was affected.	
PRAGMATIC	Md19-20 - 9 ¹¹ / ₁₉ 29 ² jumped awkwardly inwards and broke a blood vessel during the race.	
DYNAMITE GIRL	Md19-20 - 13 ¹² / ₁₉ 86 ¹⁰ was slow to start losing about 3 lengths.	
JERICHO	Md19-20 - 28 ¹¹ / ₁₉ 59 ⁸ jumped awkwardly inwards.	
SYMPHONY IN STYLE	Oty19 - 6 ⁶ / ₁₉ 105 ⁴ was slow to start losing about 2 to 3 lengths.	
VULTURE	Md19-20 - 14 ¹ / ₂₀ 131 ⁷ Jockey reported that his mount was inclined to hang in in the straight.	

BE MY LIGHT Md19-20 - 23¹/₂₀152⁷ was slow to start losing about 2 to 3 lengths. 7³/₂₀209⁷ Apprentice Jockey reported that he felt something wrong with his mount. the mare pulled up lame on left hind due to sore back. Md20-21 - 15¹/₂₀40⁰ withdraw on veterinary grounds as it was suffering from Pyrexia.

PERFECT SUPPORT Md19-20 - 14¹¹/₁₉35⁵ sustained a superficial injury on right fore coronet during the race. 15¹/₂₀144⁵ met interference passing the 1350 metres. 29¹/₂₀160⁰ was permitted to be withdrawn on Veterinary grounds (lame on left hind) before coming under the Starter's orders.

TENCENDUR Md19-20 - 7¹²/₁₉76⁴ was observed to drop back passing the 100 metres. 15¹/₂₀144⁴ Apprentice Jockey was fined for maintaining a wide course for major part of the race for no apparent reason. 14²/₂₀194⁵ Apprentice Jockey was fined for excessive use of the whip and further severely cautioned for losing his reigns passing 300 metres which he regained after travelling a few strides.

3rd Race The Tokyo Drift Plate

Cl-IV, 20-45

2000 Mts.

ROYAL COMMANDER Md19-20 - 14²/₂₀188² met interference and lost about 2 lengths at the start and again passing the 1350 metres. Md20-21 - 15¹/₂₀(45) Jockey was fined for excessive use of the whip.

CHAITANYA Md19-20 - 23¹/₂₀154⁶ was observed to be lugging in while negotiating the bend and entering the straight. Md20-21 - 20¹¹/₂₀22⁴ met interference soon after the start.

OTUS Md19-20 - 2¹/₂₀118² was inclined to hang-in in the straight, the filly had a chronic wound on left oral commissure. 29¹/₂₀161⁴ slow to start losing about 2 lengths and met interference at 800 meters and dropped back about 2 to 3 lengths.

BRILLIANT SCRIPT Md19-20 - 7¹²/₁₉79⁴ met interference passing 200 meters. 14¹/₂₀130⁵ jumped awkwardly inwards at the start.

SIFAN Md19-20 - 22¹/₂₀145⁵ Jockey was fined for dropping his hands before passing the post whereby he may have lost 4th place. 8²/₂₀172² met interference in 50 meters after the start. 14²/₂₀188⁰ was permitted to be withdrawn under Rule 62 of the Madras Race Club Rules of Racing.

ARAZAN'S DIAMOND Md19-20 - 8¹/₂₀127¹⁰ jumped awkwardly inwards. Md20-21 - 15¹/₂₀40⁷ fly jumped & was cautioned for negotiating the final bend wide for no apparent reason.

5th Race The J.H.Foley Memorial Cup

Cl-3y, Maiden

1400 Mts.

AWESOME GIFT Md19-20 - 2¹/₂₀116² jumped awkwardly outwards.

COUNTRY'S GENIUS Md19-20 - 13²/₂₀181⁹ was slow to start losing about 3 to 4 lengths and was lame on right hind during examination, was found to have wolf tooth on both sides of the upper jaw. Md20-21 - 14¹/₂₀32⁹ jumped awkwardly inwards bumped the inner gates and lost about 2 to 3 lengths in the process.

FLASH STAR Md19-20 - 9¹¹/₁₉26⁶ jumped awkwardly outwards and sustained a superficial injury on right fore pastern. 15¹/₂₀136⁴ met interference at the start. Md20-21 - 6¹¹/₂₀3⁸ bumped the starting stall and jumped awkwardly outwards losing about 2 lengths.

MAJESTIC CHARMER Md19-20 - 25¹/₁₉95⁴ was observed to be hanging out in the straight. 22¹/₂₀146⁵ was slow to start losing about 2 to 3 lengths. Md20-21 - 14¹/₂₀31⁴ slowly off losing about a length at the start.

SALVO M19-20 - 8¹²/₁₉29⁹ jumped outwards at the start. 26²/₂₀162⁶ met interference passing 150 metres.

SICHUAN Md19-20 - 13²/₂₀180⁰ was permitted to be withdrawn on Veterinary grounds, injury on right for fetlock.

STAR SYMBOL Md19-20 - 29¹/₂₀162⁷ veered out immediately after the start onto the outer railings and ran detached from the field till the 650 meters, returned lame on right fore after the race.

SUPREME EXCELSIOR Md19-20 - 8³/₂₀214⁶ returned lame on right fore after the race.

TENDER REBEL Md19-20 - 13²/₂₀180⁷ was slow to start and thereafter ran detached. Md20-21 - 20¹¹/₂₀17⁹ met interference at the start.

FAKHRUNISA Md19-20 - 1¹/₂₀111⁰ was permitted to be withdrawn on Veterinary grounds, trotting lame on left fore due to inflamed hoof. 8³/₂₀210³ Jockey was fined for improper use of the whip wherein he persisted with the use of whip on the right when his mount was shifting out.

FULL OF SURPRISE Md19-20 - 13²/₂₀181³ met interference passing the 350 metres. 8³/₂₀210⁸ Jockey reported that his mount stopped responding soon after the start and he felt that his mount was not sound. the filly was Trotting lame on left fore due to high suspensory desmitis during veterinary examination.

MAYFLOWER Md19-20 - 19¹²/₁₉87³ jumped awkwardly outwards and tried to run out before being eventually controlled by the Jockey, losing about 3 lengths Md20-21 - 20¹¹/₂₀18⁸ Jockey was reprimanded for not making sufficient efforts to stay with the field in the initial stages of the race. 14¹²/₂₀31² jumped awkwardly outwards at the start.

6th Race The Governor's Cup

CI-I, 80 and above

1400 Mts.

MEGASTHENES My19 - 11¹⁰/₁₉99⁹ met interference at the start & again passing the 1000 Metres . Md19-20 - 7²/₂₀169⁵ stumbled as the start was affected unbalancing the rider, stumbling and dropped back about 3 to 4 lengths.

HOPE AND GLORY D19-20 - 24¹⁰/₁₉(58) raced keen and shifted out to avoid clipping the front runner passing 900 metres.

GLORIOUS DESTINY Md19-20 - 23¹/₂₀156³ lugged in passing the 1350 meters.

7th Race The Peter & Hyacinth Gibson Memorial Cup Div - I

CI-IV, 20-45

1200 Mts.

COPPER QUEEN M19-20 - 27¹²/₁₉58³ jumped inwards at the start.

STAR FLING Md19-20 - 8²/₂₀175⁷ sustained superficial injury on left hind cannon.

SHIELD MAIDEN Md20-21 - 20¹¹/₂₀23⁰ was extremely fractious and refused to remain in the starting stall and was permitted to be withdrawn on veterinary grounds before coming under the Starter's orders due to injury on left hock.

SOARING HIGH M19-20 - 16¹/₂₀(92) had an abrasion at the left hind pastern. 12³/₂₀181³ met interference at the start and had checked his mount and changed course approaching 1000mts.

SHALEM Md20-21 - 20¹¹/₂₀(17) was observed to momentarily shift out passing the 200 meters.

WAKEFUL D19-20 - 30¹²/₁₉134⁰ was extremely fractious before being loaded, as such, was withdrawn before coming under starters order. 24¹/₂₀153⁵ was forced to travel wide approaching 900 meters. and took a fly jump. 25²/₂₀192⁶ took a fly jump at the start. Md20-21 - 6¹¹/₂₀(4) Jockey was fined for his negligence pertaining to weighing in. 14¹²/₂₀38³ Jockey questioned regarding the long lead taken by the jockey right from the 1000 metres.

PAPPA RICH Md20-21 - 20¹¹/₂₀19⁷ Jockey was cautioned to make better efforts in positioning his mount in the early stages of the race in future and met interference passing the 250 metres.

TRENDING PRINCESS Md19-20 - 23²/₂₀198² met interference at the start.

AMICUS CURIAE Md18-19 - 17³/₁₉209⁷ broke a blood vessel.

GREY TWILIGHT Md19-20 - 13¹²/₁₉83⁵ jumped awkwardly inwards.

HIGHLAND LIGHT Oty19 - 30⁵/₁₉93⁵ jumped awkwardly inwards. and Jockey reported that his mount was inclined to hang in for major part of the race.

8th Race The Peter & Hyacinth Gibson Memorial Cup Div - II

CI-IV, 20-45

1200 Mts.

FAREWELL Md19-20 - 22¹/₁₉42² jumped awkwardly outwards. 13¹²/₁₉84² jumped awkwardly inwards as the start was affected. 7³/₂₀207⁶ Jockey reported that his mount did not respond at any stage of the race, the filly sustained injury on upper gum.

FORT ST. GEORGE Md19-20 - 8¹/₂₀126⁶ jumped awkwardly inwards. 23²/₂₀197⁶ returned lame on right fore after the race.

GLORIOUS TRUST Md19-20 - 7³/₂₀207⁴ drifted wide out negotiating the final bend despite Jockey's efforts before returning to even keel entering the straight.

STRIKING DISTANCE Oty19 - 6⁶/₁₉105⁰ lost its hind action stumbled and dislodged the rider at about the 800 metres and met interference from the 750 metres till the 500 metres and trailed the field and sustained superficial injury on right fore pastern. 14⁶/₁₉130⁰ saddle slipped during the race whereby the filly could not be ridden out, took no part in the race. Md19-20 - 14²/₂₀189⁸ met interference and stumbled and dropped back soon after the start

SILVERMAN Md19-20 - 23¹/₂₀155⁵ met interference passing the 750 meters. 23²/₂₀197⁰ was permitted to be withdrawn on Veterinary grounds, lame on right fore due to sprained tendon.

KATAHDIN Md19-20 - 13¹²/₁₉(84) fly jumped as the start was affected losing about 2 to 3 lengths.

STEVE MCQUEEN Md19-20 - 8²/₂₀173⁴ was slow to start losing about a length or two. Md20-21 - 6¹/₂₀210¹⁰ Jockey reported that he lost his reigns entering the straight which he regained after travelling about 50 meters, whereby he lost position and dropped back.

LORD BUCKINGHAM Oty19 - 13⁶/₁₉126⁸ had broken a blood vessel during the race. Md19-20 - 8²/₂₀173⁸ Jockey reported that his mount was inclined to hang in for major part of the race. lugging in soon after after.

CAPE COD Md19-20 - 14¹/₂₀131¹⁰ broke a blood vessel. Md20-21 - 20¹/₂₀23⁴ was slow to start losing about 2 lengths.

INTOX Md19-20 - 7³/₂₀204⁶ received checked and dropped back by about 3 lengths. Md20-21 - 15¹²/₂₀(40) jumped awkwardly inwards as the start was affected.

MULLIGAN Oty19 - 15⁴/₁₉13⁰ was fractious, played up and was permitted to be withdrawn. 11⁵/₁₉53⁰ The bridle used on came undone in the starting stall as the gelding was fractious and therefore was permitted to be withdrawn. 13⁶/₁₉123⁰ ran loose during loading operations, was held and taken back to be loaded , however was fractious and could not be loaded and therefore was permitted to be withdrawn. Md19-20 - 29¹/₁₉62⁶ sustained bruises on both hind fetlock.

WELCOME CHAKKARAM Md19-20 - 22¹/₁₉46⁸ drifted out entering the straight. 26¹²/₁₉108⁸ slow to start losing about 3 lengths. 8¹/₂₀125¹⁰ jumped awkwardly inwards at the start was affected.

SUPREME COMMANDER Md19-20 - 8²/₂₀174⁵ met interference negotiating the bend.
