1 st Race The Flying Glance Handicap	CI-3H., 1-26, which were in station in Kolkata as on 31st March, 2020.	1100 Mts.
BEMUSE	CI20-21 - 1 ¹² / ₂₀ 14 ⁰ found to be lame on right hind. Under the circumstances the colt was permitted to be withdrawn on veterinary grounds.	
TIME AXX	CI20-21 - 12 ¹² / ₂₀ 23 ⁰ found to be lame on right hind. Under the circumstances, the gelding was permitted to be withdrawn on veterinary grounds.

TIA QUEEN	CI19-20 - 18 ¹ / ₂₀ 89 ⁴ Jockey was reprimanded for unnecessary calling out during the running of the race. CI20-21 - 12 ¹² / ₂₀ 25 ⁸ was fractious while being stalled jumped out awkwardly from the gates.	
BRILLIANT GOLD	Pn19 - 5 ¹⁰ / ₁₉ 114 ² received checked approaching the 100 metres. 26 ¹⁰ / ₁₉ 153 ⁸ received checked approaching the 600 metres. M19-20 - 1 ² / ₂₀ 119 ¹³ met interference passing the 1000 metres.	
SAN REMO	CI19-20 - 14 ¹ / ₁₉ 14 ⁹ was slow to begin.	
SPRING VALLEY	CI19-20 - 22 ² / ₂₀ 136 ⁴ App was reprimanded for allowing his mount to drift out during the final stages of the race.	
BEOWULF	CI19-20 - 19 ² / ₂₀ 130 ¹² met interference approaching the 800 metres.	
LESLEY	CI19-20 - 12 ¹ / ₂₀ 81 ⁵ fly jumped out from the gates.

SHIVALIK SIGHT	CMn19 - 29 ⁹ / ₁₉ 99 ⁸ received interference approaching the distance post.	
INCA	CI19-20 - 15 ² / ₂₀ (117) Jockey reported that his mount was inclined to run out during the final 400 metres of the race. CI20-21 - 12 ¹² / ₂₀ 27 ² Jockey was fined for the excessive use of the whip.	
ROSINA	CI19-20 - 12 ¹ / ₂₀ 86 ⁰ found to be lame on right fore. Under the circumstances the filly was permitted to be withdrawn.	
RAQS SHARQI	CI19-20 - 25 ² / ₂₀ (139) drifted outwards when placed under pressure in the final stages of the race.	
5 th Race The Ansbach Handicap	CI-III, 41-66, which were in station in Kolkata as on 31st March, 2020.	1600 Mts.
BIG STAR	CI20-21 - 5 ¹² / ₂₀ 21 ⁵ met interference soon after the start.	
KIMAYA	CI19-20 - 12 ¹ / ₂₀ 83 ⁰ was very unruly while being stalled in process the bridle came off. As there was insufficient time to replace the equipment, the filly was withdrawn.	

SUMMER AIR M19-20 - 22¹²/₁₉46⁵ met interference from the 400 metres. C120-21 - 5¹²/₂₀(21) met interference soon after the start & Jockey was reprimanded in the presence of Trainer for riding an over confidence race.

EXCELSIOR HyM19 - 23⁹/₁₉137⁶ App reported that his mount brushed the gates as start was effected in the process his right stirrup iron broke, as such he removed his left leg from stirrup iron and thereafter he could not offer any assistance to his mount. C119-20 - 12¹²/₁₉50⁰ was extremely fractious and refused to be stalled in spite of repeated attempts. Under the circumstances the filly was permitted to be withdrawn.

6th Race The D Khaitan Memorial Calcutta Gold Cup (gr li) CI-T, Terms 1600 Mts.

PSYCHIC FORCE My19 - 10¹⁰/₁₉92⁴ accidentally brushed the railings, shied away and leapt outwards. My19-20 - 18¹²/₁₉40⁶ Jockey reported that the horse was hanging 'out' throughout the Race.

SHIVANSH C119-20 - 21¹²/₁₉55⁶ Jockey reported that his mount was inclined to hang out during the major part of the race and on passing the 400 metres the colt shifted inwards. 11²⁰/₇₀⁶ Jockey reported that his mount was running under distress passing the 600 metres and wobbled during the final stages of the race. C120-21 - 5¹²/₂₀20³ was denied a clear run on the inside approaching the distance post.

STAR SUPERIOR BgS19 - 16⁶/₁₉(68) sustained bleeding injury on left hind cannon. 14⁷/₁₉(124) sustained bleeding injury on left hind cannon. C119-20 - 21¹²/₁₉(55) met interference passing the 400 metres.

TRAFALGAR C119-20 - 7¹²/₁₉42⁰ was extremely fractious and refused to be stalled. Under the circumstances the rig was permitted to be withdrawn. M19-20 - 2²/₂₀125¹³ met interference at the start.

AWESOME ONE M19-20 - 17¹¹/₁₉93³ Jockey reported that EXCELLENT GOLD shifted out at the final bend and carried him outwards deliberately. Due to this, his mount shied and hung out from there on. 5¹/₂₀78³ jumped outwards at the start.

ARROWFIELD Pn19 - 21⁹/₁₉95³ had right eye injury (sore eye). C119-20 - 7¹²/₁₉(38) was slow to begin.

HERE AND NOW BgS19 - 2⁸/₁₉168⁶ planted and lost many lengths at the start. Bg19-20 - 22¹¹/₁₉13² met interference on his outside approaching 600 Metres. C120-21 - 1¹²/₂₀12⁴ was slow to begin.

SWEET MUSIC C119-20 - 11³/₂₀158⁴ drifted outwards when placed under pressure in the final stages of the race. C120-21 - 5¹²/₂₀20⁷ met interference Passing the 800 metres.

7th Race The Snow Forest Handicap CI-IV, 21-46, which were in station in Kolkata as on 31st March, 2020. 1400 Mts.

MR GUCCI CMn19 - 11⁰/₁₉104⁴ Jockey suspend for unsatisfactory riding. C120-21 - 11²/₂₀9⁶ ran into the heels of RAQS SHARQI approaching the 1200 metres and had to be steadied.

VIAREGGIO C118-19 - 9²/₁₉135⁵ returned with cut injury on right fore. C119-20 - 26¹²/₁₉62⁵ returned bleeding from nostrils.

DESPACITO Pn19 - 25¹⁰/₁₉147² met interference approaching the 1000 metres. M19-20 - 27¹²/₁₉57² jumped outwards at the start.

FANCOURT C119-20 - 21¹/₁₉4³ was slow to begin. 8²/₂₀112⁸ ran into the heels of MR FOGGS soon after entering the straight. C120-21 - 24¹¹/₂₀3⁷ was slow to begin.

XILE C119-20 - 11¹/₂₀75⁹ was brought to a halt soon after passing the winning post. On immediate examination the filly was found to have bled from its nostrils.

DARING HEART C119-20 - 7¹²/₁₉40⁴ was running green throughout the race. C120-21 - 12¹²/₂₀25³ was squeezed out for room after the jump out.
