FALCONETTE	Pn19 - 13 ¹⁰ / ₁₉ 141 ⁴ met interference Passing the 700 metres & was found to be sore by the right fore leg. 26 ¹⁰ / ₁₉ 156 ¹¹ received checked approaching the 800 metres & was found to be sore by the right fore leg. Also, the filly had an abrasion at the left hind above the hock and right hind coronet. M19-20 - 5 ¹ / ₂₀ 76 ⁵ was found to be sore by the right fore leg. 18 ¹ / ₂₀ 98 ³ was found to be sore by the right fore leg. 26 ² / ₂₀ 159 ⁵ met interference soon after the start and was found to be sore by the right fore leg.

LITTLE MORE	M19-20 - 16 ¹ / ₂₀ 92 ⁵ met interference and had to be steadied approaching the 800 metres. and hung out despite the riders efforts approaching the 200 metres. 12 ² / ₂₀ 116 ⁶ Jockey stated that his mount was very keen at that stage and in his effort to settle the filly, she had shifted out. and met interference passing the 400 metres Pn20 - 27 ¹ / ₂₀ 6 ⁹ was observed to have broken a blood vessel & had left eye injury (sore).

IN IT TO WIN IT	Pn19 - 3 ⁸ / ₁₉ 17 ⁶ had to be checked at the start & met interference approaching 550mts & Trainer fine for comparative performance. 24 ⁸ / ₁₉ (47) An enquiry has been initiated into the improved performance. M19-20 - 22 ¹ / ₂₀ 49 ⁴ App reported that his mount hung-in in the straight.	
SQUARE MOON	Pn19 - 14 ⁹ / ₁₉ 81 ² met interference and had to be steadied approaching the 200 metres.	
GLORIOSUS	Pn20 - 27 ¹ / ₂₀ 3 ⁹ Jockey reported that passing the 800 metres, his mount lost its footing and did not gallop freely post that & was found to be sore by the right fore leg.	
GOLDEN ERA	M19-20 - 8 ¹ / ₂₀ 27 ² was observed to have drifted out. from the 200 metres. Pn20 - 27 ¹ / ₂₀ 3 ⁷ was tightened for room and had to be checked and dropped back passing 1000 metres.

DESERT FIRE	M19-20 - 18 ¹ / ₂₀ 101 ³ met interference and had to be steadied approaching the 900 metres. and Jockey reported that his mount hung out in the early part of the race and had right eye injury (sore).	

MARKET KING M19-20 - 1²/₂₀116² bumped approaching the 600 metres. 2³/₂₀153² jumped inwards at the start and Jockey reported that his mount maintained an erratic course in the straight. Pn20 - 11¹/₂₀28² Jockey reported that in the last 150 metres his mount was inclined outwards despite his efforts.

ROYAL CASTLE M19-20 - 13²/₂₀141⁹ met interference at the start. Pn20 - 29¹/₂₀9⁷ met interference at the start.

FARAHNAAZ M19-20 - 29¹/₂₀61⁰ found to have cut injury on right shoulder; as such the filly was certified unfit to race. 12³/₂₀181⁵ was inclined outwards despite which App. used the whip from the right thereby causing the filly to further shift out and in an attempt to correct the outward shift of his mount, App was observed to have lost his whip. Pn20 - 29¹/₂₀11⁵ met interference at the start & had right eye injury (mild ulcer).

ISLE OF SKYE M19-20 - 2¹/₂₀71³ had a cut injury at the right hind pastern and an abrasion at both hind fetlock. 2²/₂₀124⁴ received checked and drop back passing the 400 metres. and Jockey reported the loss of whip near 200 metres.

SMOKIN' HOT M19-20 - 13²/₂₀141⁵ received checked passing the 450 metres.

SPARKLING GLORY Pn20 - 11¹/₂₀26¹⁰ had left eye injury.

SPRINGBOK Pn20 - 6¹/₂₀22¹¹ had injuries to both eyes.

4th Race The Siachen Plate

CI-IV, 20-46, 4 years old only,(0 to 19 eligible). 1200 Mts.

SPEED AIR M18-19 - 12¹/₁₉98⁴ was lethargic in the early part of the race and also ran green. 3²/₁₉131⁸ met interference soon after the start and was held up for room along the rails and had to be steadied Passing 900 metres, came back in distress. M19-20 - 13²/₂₀140² met interference soon after the start. Pn20 - 6¹/₂₀(18) met interference soon after the start.

BELENUS Pn19 - 21⁹/₁₉98² met interference soon after the start. 13¹⁰/₁₉137⁶ met interference at the start. M19-20 - 27¹/₁₉58⁶ jumped inwards at the start and had to be checked soon after the start.

OUI SAUVAGE Pn19 - 10⁸/₁₉26⁷ jumped outwards at the start and was denied a clear passage and had to be held approaching 300 metres. M19-20 - 24¹/₂₀110⁴ After being stalled Jockey reported that the bit on his mount shifted to one side, as such the same was corrected. and bumped approaching the 300 metres.

SANDMAN Pn19 - 31⁸/₁₉(65) jumped outwards at the start. 6¹⁰/₁₉123² jumped inwards at the start and had right eye injury (sore eye). and had lost its left fore shoe. M19-20 - 24¹/₁₉12² received checked at the start and Jockey stated that passing the 700 metres, the front runners weakened and dropped back, as such, he shifted out due to which his mount swung out wide. 2²/₂₀127¹³ was held up due to lack of room passing the 200 metres.

PROPERLY POSH M19-20 - 24¹/₂₀110² met interference approaching the 400 metres and again passing the 300 metres. 23²/₂₀156³ was inclined inwards from the 350 metres and Jockey reported his mount hung-in despite his efforts.

MS BOSS Pn19 - 13¹⁰/₁₉137⁷ met interference at the start. M19-20 - 18¹/₂₀102⁶ bumped at the start. 23²/₂₀156⁸ met interference approaching the 600 metres and again passing the 200 metres. 12³/₂₀184¹⁰ was observed to have a cut injury at the left fore.

CIPHER Pn19 - 21⁹/₁₉(96) met interference along the rails approaching the 600 metres. 26¹⁰/₁₉156⁴ was observed to have jumped out awkwardly brushing against its stall. M19-20 - 24¹/₂₀110⁰ was permitted to be withdrawn on compassionate grounds. Pn20 - 6¹/₂₀22⁷ was tightened for room and had to be checked approaching 1400 metres & had right eye injury.

TWINSPIRE Pn19 - 26¹⁰/₁₉150² jumped outwards at the start & had injury to both eyes (sore, lacrimation) Apprentice suspend unatisfactory riding on his mount in that entering the straight.

BETWEEN FRIENDS	M19-20 - 8³/₂₀173⁸ met interference at the start and had to be steadied approaching 200 metres.
MIKAYLA'S PRIDE	Pn19 - 25¹⁰/₁₉147⁷ met interference passing the 250 metres. M19-20 - 1²/₂₀119² bumped at the start. 12³/₂₀184³ was observed to have stumbled and was steadied at the start. and met interference negotiating the final bend. Pn20 - 27¹¹/₂₀2⁵ met interference at the start & had right eye injury (sore, lacrimation).
MARIANNE	Pn20 - 27¹¹/₂₀2¹³ Jockey reported that his mount hung out throughout the race.
THUNDERCLAP	Pn19 - 26¹⁰/₁₉153¹¹ received checked approaching the 600 metres. M19-20 - 2¹/₂₀66⁷ jumped outwards at the start and met interference at the top of the straight.
ELLYSIA	M19-20 - 9¹/₂₀84⁶ met interference passing the 300mts. 23²/₂₀156⁷ shifted out and had to be steadied passing the 550 metres. Pn20 - 29¹¹/₂₀9⁵ had right eye injury (sore).
SEHMAT	Pn20 - 11¹²/₂₀29¹⁰ had to be checked passing 800 metres.
5th Race The M M T Pandole Plate	Cl-III, 40-66, 5 years old and over, (20 to 39 eligible Mts.)
SHARAREH	M19-20 - 15¹²/₁₉(35) met interference passing the 600 metres. 27¹²/₁₉56⁴ received checked passing the 100mts. Pn20 - 11¹²/₂₀25³ met interference and had to be steadied at the start.
BARACK	Pn19 - 15⁹/₁₉87² Jockey reported that his mount was erratic in the straight & Jockey reported the loss of whip in the final stages of the race, had lost its right fore shoe. M19-20 - 2¹/₂₀(69) met interference at the start. Pn20 - 6¹²/₂₀19⁵ met interference soon after the start.
HIGHLAND LASS	M19-20 - 5¹/₂₀80² met interference approaching the 800mts. 23²/₂₀156⁵ jumped inwards at the start.
SEA QUEST	BgS18 - 2⁸/₁₈166⁰ reared up and fell over in the saddling yard and injured its left hind hock. Under the circumstances, it was permitted to be withdrawn. Bg18-19 - 15¹²/₁₈70⁹ it was found to be lame on left fore. BgS19 - 18⁹/₁₉4¹ burst its blood vessels. Pn19 - 12¹⁰/₁₉131⁰ reared up and flipped over in the stall. As such the gelding was taken out and was withdrawn. Pn20 - 6¹²/₂₀17³ jumped outward at the start & was observed to have a gum injury.
EBONY	Pn19 - 28⁹/₁₉111² met interference soon after the start and again from the 250 metres onwards. 25¹⁰/₁₉(142) met interference approaching the 800 metres. M19-20 - 15¹²/₁₉(36) jumped outwards at the start.
POKERFACE	Pn19 - 15⁹/₁₉89⁸ met interference approaching the 600 metres & App reported that his mount hung-in in the straight despite his efforts. M19-20 - 15¹²/₁₉35⁶ leaned inwards passing the 600 metres. Pn20 - 29¹¹/₂₀14⁷ met interference soon after the start.
AUSPICIOUS	M19-20 - 17¹¹/₁₉(5) had right eye injury (sore, lacrimation). 8¹²/₁₉25⁶ shifted in despite which Jockey persisted with the use of whip from the left passing the 100 metres.
RED CARNATION	M19-20 - 1²/₂₀118⁴ shifted in soon after the start. 26²/₂₀159² met interference at the start.
UNTITLED	Pn20 - 6¹²/₂₀21⁶ along the rails received check passing 700 metres.
ARC SHINE	M19-20 - 23²/₂₀155⁸ bumped at the start.
EPIPHANY	Pn19 - 26⁷/₁₉13⁰ refused to be stalled despite substantial efforts and in the process the mare fell backwards, as such, EPIPHANY was withdrawn. 22⁹/₁₉104⁰ refused to be stalled despite substantial efforts, as such, the mare was withdrawn. M19-20 - 16²/₂₀148⁴ was bumped and had to be steadied soon after the start. Pn20 - 13¹²/₂₀32³ met interference & bumped and unbalanced passing 800 metres.

AGRAMI M18-19 - 7³/₁₉(175) met interference soon after the start and was observed to have drifted out. Despite the horse drifting out App. did not take corrective measures and persisted with the whip from the right thereby aggravating the outward movement From top of the straight. M19-20 - 2¹/₂₀70⁷ met interference at the start. 9²/₂₀133³ jumped inwards at the start. Pn20 - 13¹/₂₀32² bumped and passing 800 metres & An enquiry has been initiated into the running and riding.

6th Race The Mrs Patmore Plate

CI-V', 4-30, 4 years old and over

1600 Mts.

SACHERTORTE Pn19 - 21⁹/₁₉98⁸ Jockey stated that his mount had ducked in immediately after the start, had left eye injury (sore eye, lacrimation) & had lost its left hind shoe. 13¹⁰/₁₉137¹⁰ met interference at the start. M19-20 - 11²/₁₉18⁴ showed signs of distress after returning from the race. 5¹/₂₀77⁵ bumped approaching 300mts and showed signs of distress. After cold water hosing and First Aid treatment the gelding recovered and was sent to the stables. 13²/₂₀140⁷ had to be checked soon after the start and again passing the 1100 Metres.

ARRECIFE Pn19 - 5¹⁰/₁₉116⁷ had left eye injury (corneal opacity and sore eye) 26¹⁰/₁₉155⁷ was observed to have lost its footing. M19-20 - 26²/₂₀161⁵ bumped soon after the start.

GRACIDA M19-20 - 24¹/₂₀109⁹ App. reported that his mount was slow at the start. 13²/₂₀139¹³ marginally slow to begin and met interference at the start. 12³/₂₀182¹⁰ met interference passing 1400mts. Pn20 - 11¹/₂₀24¹¹ was slowly off and met interference at the start.

VICTORIOUS SPIRIT Pn19 - 28⁹/₁₉107⁸ had a gum injury. Pn20 - 27¹/₂₀2⁸ leaned outwards passing 300 metres.

BRIANNA M19-20 - 29¹/₂₀1965⁹ was steadied at the start. 12³/₂₀182⁴ leaned inwards passing 1400mts. Pn20 - 29¹/₂₀12⁰ found to be sore by the left hind leg, as such, the filly was certified unfit to race and was withdrawn.

DOWSABEL M19-20 - 16¹/₂₀91⁸ Jockey reported that his mount was hesitant to raise a fluent gallop throughout the race despite his efforts.

MISS SCARLETT M19-20 - 24¹/₁₉11³ had right eye injury (sore, lacrimation). 21¹/₁₉41² Jockey was observed to have used the whip in excess of the prescribed limit on his mount. 18¹/₂₀104⁵ had to be steadied and met interference at the start and again passing the 300 metres. 13²/₂₀139⁵ received checked passing the 1000 Metres and again passing the 250 Metres and had to be steadied.

SO SPLENDID M19-20 - 5¹/₂₀73³ jumped inwards at the start.

TAKE IT EASY Pn19 - 25¹⁰/₁₉147⁶ had to be checked approaching the 1000 metres. Pn20 - 27¹/₂₀2⁹ jumped inwards at the start.

PRINCIPESSA M19-20 - 29¹/₂₀1965⁷ met interference passing the red marker. 1²/₂₀119¹⁰ met interference passing the 1000 metres. 23²/₂₀158⁴ was observed to have lost its left hind shoe.

BIG BEN M19-20 - 18¹/₂₀104⁶ was marginally slow to begin and met interference at the start. 1²/₂₀113³ received checked and drop back before passing the red marker. 13²/₂₀139⁵ marginally slow to begin and met interference at the start.

CRISTO BOSS Pn19 - 12¹⁰/₁₉132⁰ met interference at the start.

7th Race The Vijays Pride Plate Div - I

CI-IV, 20-46, (0 to 19 eligible).

1000 Mts.

GODSWORD M19-20 - 17¹/₁₉1⁴ jumped outwards at the start and Trainer reported that he was not satisfied with the riding of App. on his charge. 11²/₁₉(23) jumped outwards at the start. 8¹/₁₉24⁶ jumped inwards at the start and was observed to have broken a blood vessel. 18¹/₂₀102⁸ was observed to have broken a blood vessel.

EXOTIC QUEEN M19-20 - 12³/₂₀181⁸ bumped at the start and had checked his mount and changed course approaching 1000mts.

INTENSE APPROACH Hy19-20 - 19¹/₂₀137⁹ met interference at about the 200 mtrs.

WARRIOR CLAN Pn19 - 26¹⁰/₁₉(152) was observed to have an abrasion at the right hind fetlock.

JULIO CESARO M19-20 - 5¹/₂₀80⁷ had to be checked approaching the 800mts. 18¹/₂₀102⁷ received check approaching the 800 metres.

C' EST L' AMOUR M19-20 - 27¹²/₁₉57⁵ met interference at the start. 9¹/₂₀87² jumped outwards at the start. 5³/₂₀169⁵ App reported that his mount hung-in in the straight. and was found to be sore by the right fore leg.

ALAUDDIN KHILJI Pn19 - 16⁸/₁₉45¹² jumped out slow losing about 2 lengths. 13¹⁰/₁₉(136) met interference at about 200 mts. M19-20 - 15¹²/₁₉38⁵ Jockey reported that his mount was running green in the straight. 1²/₂₀115¹⁰ met interference approaching the 300 metres.

POWER OF NEATH M19-20 - 29¹²/₁₉60³ was observed to have broken a blood vessel. Pn20 - 27¹¹/₂₀8⁹ met interference passing 1000 metres and again approaching 300 metres. 11¹²/₂₀24⁶ was slowly off and met interference at the start.

FIRE PRINCESS Pn19 - 31⁸/₁₉65⁹ met interference approaching the 800 metres and again Approaching the 700 metres. Pn20 - 13¹²/₂₀30¹⁴ planted, taking no practical part in the race.
