IN BRIEF OF IMMEDIATE PAST 6 RUNS**

1st Race The Spark Of Life Plate Div - III

CI-V, 0-25

1200 Mts.

MOONSTRUCK My19 - 26⁹/₁₉66¹¹ Jockey reported that his mount was not galloping fluently through the Race. 10¹⁰/₁₉88⁸ met interference at the start & again and brushed the railings approaching 1200 metres. 30¹⁰/₁₉128¹⁰ Jockey reported that the horse was hanging 'in' after entering the straight. My19-20 - 13¹¹/₁₉2⁹ met interference soon after the start.

WOOD CUTTER My18-19 - 17¹/₁₉58⁷ met interference passing the 300 metres. MyS19 - 22⁵/₁₉1³ Jockey was cautioned to be more judicious in the handling of his mount in future and that a similar manner of riding. My19 - 4⁹/₁₉15⁸ met interference soon after the start & Jockey reported that his mount was reluctant to gallop due to the kickback received during the race, was slowly away.

GABINO MyS19 - 22⁵/₁₉3⁹ sustained bruise on left chest-wall behind girth.

COUNTRY'S SHER My17-18 - 19¹/₁₈67¹³ accidentally brushed the Gates, while coming out of it, at the Start. met interference passing the 400 Metres. My18-19 - 13²/₁₉86⁶ met interference at the start and Jockey was fined for not persevering with his mount, during the Race.

GOLDEN CRUISE My19 - 11¹⁰/₁₉96⁵ pulled up lame on right fore.

TOBIN My18-19 - 13²/₁₉86⁸ pulled up lame on left hind.

PRECIOUS SCRIPT My18-19 - 30¹/₁₉71⁶ met interference at the start. My19-20 - 11¹²/₁₉29⁹ pulled up lame on left fore.

TIME ALWAYS My19 - 11¹⁰/₁₉96¹⁰ planted and lost many lengths at the start. My19-20 - 27¹¹/₁₉16⁵ was racing right next to him and hence jockey could not completely ride out his mount. 8¹/₂₀56⁵ reared up as the gates opened and took a fly jump.

VROOM VROOM My19 - 11¹⁰/₁₉96² It was observed in the Race that the cross-nose band on got unfastened during the Race & sustained cut injury on right hind outer cannon. My19-20 - 27¹¹/₁₉16⁴ Jockey reported that his mount was hanging 'in' throughout the race. 11¹²/₁₉29⁴ Jockey reported that his mount drifted 'out' in the last 300 Metres of the Race.

JAMAIS VU My18-19 - 13²/₁₉86⁰ withdraw on veterinary grounds as it was observed to be trotting lame on left fore due to nail puncture. My19 - 11¹⁰/₁₉96⁰ it was observed to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn. My19-20 - 27¹¹/₁₉16⁶ met interference between 350 mtrs to 150 mtrs.

ELA HARIKA My19 - 19¹⁰/₁₉103³ sustained injury over right hind inner bulb of heel.

MICRON YAACOW My19 - 11⁹/₁₉28⁶ sustained cut below left hock and clipped injury on left hind medial bulb of heel. 19¹⁰/₁₉103⁰ on veterinary grounds as it was observed to be trotting lame on left fore due to hoof abscess. My19-20 - 11¹²/₁₉30¹⁰ met interference passing 400 metres. 31¹²/₁₉52⁷ Jockey was reprimanded for dropping hands before passing the Winning Post.

VIRGINIA QUEEN My19 - 11¹⁰/₁₉97⁶ met interference at the start. My19-20 - 8¹/₂₀57⁰ withdraw on veterinary grounds, from the above Race, as it was observed to be trotting lame on right fore due to hoof abscess.

AROMATIC My19 - 20⁹/₁₉53¹¹ sustained cut injury on left hind outer cannon. My19-20 - 31¹²/₁₉52⁹ stumbled, passing the 1200 Metres. and sustained a small injury inside right hind cannon.

AT THE TOP My19 - 11¹⁰/₁₉95³ met interference before passing the red marker post & Jockey reported that the horse was hanging 'in' after entering the straight. My19-20 - 27¹¹/₁₉16⁷ met interference between the 350 Metres and the 150 Metres. 31¹²/₁₉(51) Jockey reported that his mount was inclined to run 'out' in the back stretch. and sustained small cut on left fore knee.

BIG TIME BAY My19-20 - 25¹²/₁₉43⁴ sustained cut injury on inside left fore cannon.

CATCHY CHARGER My19-20 - 8¹/₂₀56² slowly away.

FELIX LEGION My19-20 - 13¹¹/₁₉1⁷ was hanging 'in' throughout the Race.

WELCARE MyS18 - 22⁶/₁₈29⁷ sustained clipped injury on left fore medial bulb of heel. 1⁸/₁₈73⁹ met interference approaching the 800mts. My18 - 21¹⁰/₁₈107¹³ met interference on its outside at the start. My18-19 - 5¹²/₁₈17⁰ withdraw on veterinary grounds as it was observed to be suffering from left fore tendon inflammation.

HONEY QUEEN MyS19 - 3⁷/₁₉47⁶ jumped awkwardly 'inwards'. 17⁷/₁₉58⁶ Jockey was fined for not being alert at the Start, met interference approaching the 1000 Metres. My19 - 3¹⁰/₁₉76¹⁰ was slowly away.

SWISS BAY My19 - 27⁹/₁₉73⁶ burst its blood vessels. My19-20 - 11¹²/₁₉30⁷ jumped awkwardly 'outwards' at the start. 25¹²/₁₉43⁸ met interference at the start. 31¹²/₁₉52⁴ met interference passing the 1200 Metres. and Jockey was reprimanded for travelling wide rounding the final bend, for no apparent reason.

AMAZING BEAUTY My19 - 20⁹/₁₉53⁸ sustained cut injury on left hind coronet.

CASHWIN MyS18 - 22⁶/₁₈29⁰ was running behind clipped the heels of DRAUGEN the frontrunner, dislodging the rider, met interference rounding the final bend, sustained bruise on left hind planter fetlock. MyS19 - 29⁵/₁₉8⁶ stumbled soon after the jumping out of the Starting Gates. My19-20 - 8¹/₂₀56⁷ slowly away.

3rd Race The Indi Plate Div - II**CI-IV, 20-45****1400 Mts.**

CELESTAR My19-20 - 13¹/₁₉1² Jockey was reprimanded for dropping hands before passing the winning post. 11¹²/₁₉30⁵ jumped awkwardly 'inwards' at the start & Jockey reported that his mount was hanging 'in' after entering the straight.

FESTIVE STAR MyS19 - 19⁶/₁₉34⁹ met interference before passing the Red Marker Post & passing the 1100 Metres. My19 - 11⁹/₁₉30⁶ Jockey reported that his mount was hanging 'out' throughout the Race. 19¹⁰/₁₉102⁹ jumped awkwardly inwards at the start & met interference between the 1300 Metres and the 1200 Metres, Jockey reported that his mount was hanging 'in' throughout the Race. sustained bruise on right hind back of pastern. My19-20 - 11¹²/₁₉31² drifted 'out' after entering the straight.

FLAMBOYANT BgS19 - 27⁷/₁₉149⁰ dropped the rider on the way to the starting gates, whereby the Jockey was injured. Under the circumstances, it was permitted to be withdrawn. 28⁸/₁₉164⁸ was slowly away, lost many lengths.

BIRTHDAY BABE My19 - 20⁹/₁₉52¹⁰ met interference approaching 1000 metres & Jockey reported that his mount was inclined to run 'out' approaching the 1000 metres and the mouth of the horse revealed sharp molars. My19-20 - 13¹/₁₉2⁴ Jockey was reprimanded for not being alert at the Start, thereby shifting awkwardly outwards. 27¹/₁₉17⁸ Jockey reported that his mount was hanging 'in' after entering the straight. 8¹/₂₀57⁶ was inclined to run out, rounding the final bend and in the Straight.

SEGERA My19 - 11¹⁰/₁₉97⁰ withdraw was observed to be suffering from generalized urticaria all over the body. 30¹⁰/₁₉129⁹ drifted out under pressure, in the straight and was slowly away and lost about two lengths. My19-20 - 13¹/₁₉195⁷ Jockey reported that his mount was hanging in after entering the Straight.

AMAZING My18 - 20⁹/₁₈(52) slowly away. 3¹⁰/₁₈77⁹ was slowly away at the start. My18-19 - 31¹/₁₉81⁶ threw its head up, while jumping out of the Starting Gate and met interference soon after the start. My19-20 - 13¹/₁₉2⁰ withdraw on veterinary grounds as it was trotting lame on left hind due to hoof abscess.

GREEN MEADOW My19-20 - 18¹²/₁₉38⁴ met interference soon after the start.

MY QUEEN My19 - 11¹⁰/₁₉97³ had to be pulled out and steadied, between the 900 Metres and the 700 Metres. My19-20 - 20¹¹/₁₉12⁰ fell on the way to the Starting Gates. On examination, it was found to be lame on left hind. Under the Circumstances, it was permitted to be withdrawn. 4¹²/₁₉25² met interference before passing the red marker post.

SWISS TIGRESS My19-20 - 27¹¹/₁₉17² jockey was reprimanded for not making sufficient effort to improve his position between 1000 and 600 Metres. 18¹²/₁₉41⁷ accidentally brushed the railings approaching 1000 Metres.

ROYAL DESIGN My19 - 19¹⁰/₁₉102⁷ met interference at the start & Jockey was reprimanded for travelling wide rounding the final bend, for no apparent reason. My19-20 - 20¹¹/₁₉12⁶ Jockey reported that the saddle of his mount shifted over the Withers, rounding the bend and Was slowly away. 4¹²/₁₉25⁶ Jockey reported that his mount was hanging 'out' rounding the final bend. 31¹²/₁₉54⁰ withdraw as it was observed to be trotting lame on left fore.

STAR HOLIDAY My19 - 19⁹/₁₉51⁰ was permitted to be withdrawn on veterinary grounds before coming under Starter's Order & an enquiry is being held into the circumstances under which b g STAR HOLIDAY -withdrawn. My19-20 - 25¹²/₁₉45⁶ met interference passing the 150 Metres.

4th Race The Spark Of Life Plate Div - I**CI-V, 0-25****1200 Mts.**

SAFE BET My19-20 - 20¹¹/₁₉12⁵ an enquiry is being into the riding. 4¹²/₁₉25¹¹ met interference before passing the red marker post.

STAR LAGOON My19 - 3¹⁰/₁₉76⁵ Jockey reported that his mount was hanging 'out', rounding the bend. and slowly away. 11¹⁰/₁₉96³ Jockey was fined for juggling with his reins resulting in him momentarily losing his left rein in the closing stages of the Race. My19-20 - 20¹¹/₁₉10² met interference at the start. 25¹²/₁₉43³ Jockey reported that his mount was hanging 'in' after entering the straight.

SUMMER MyS19 - 10⁷/₁₉50⁹ jumped 'out' awkwardly. My19 - 30¹⁰/₁₉129¹⁰ Jockey reported that his mount was hanging 'out' throughout the race.

SPIRITUALQUEEN My19 - 4¹⁰/₁₉87² was inclined to run 'out' passing 800 Metres. My19-20 - 27¹¹/₁₉17¹⁰ jumped awkwardly 'outwards' at the start and slowly away lost few length. 18¹²/₁₉38⁷ jumped awkwardly inwards at the start & met interference at the start. 25¹²/₁₉44⁹ planted and lost many lengths at the start.

STAR STYLE My19-20 - 20¹¹/₁₉12² Jockey reported that his mount was hanging in after entering the Straight. 27¹/₁₉(16) Jockey was fined for the excessive use of the whip on his mount during the Race.

SO FAR My19 - 30⁸/₁₉9⁰ was observed to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn.

KING'S COMMAND My19-20 - 13¹/₁₉2⁸ met interference soon after the start. 25¹²/₁₉43⁶ met interference at the start and again passing the 800 Metres. 31¹²/₁₉52³ drifted 'out' in the straight.

AKIMBO My19 - 3¹⁰/₁₉75¹¹ met interference at the start. My19-20 - 25¹²/₁₉43⁹ met interference passing the 800 Metres.

NAVAL GLORY My19-20 - 25¹²/₁₉43⁷ met interference at the start.

THE IMPOSTER My18-19 - 31¹/₁₉80³ An enquiry is being held into the manner of riding. 20²/₁₉102⁸ met interference at the start, and accidentally stumbled within 50 Metres from the start. Jockey reported that his mount was hanging 'in' throughout the Race. MyS19 - 12⁶/₁₉23⁴ sustained bleeding cut on right hind below stifle. My19-20 - 11¹²/₁₉30² jumped awkwardly 'outwards' at the start and lost its left fore shoe during the Race.

KOROL	My19-20 - 20 ¹¹ / ₁₉ 14 ⁵ met interference approaching the 400 Metres.
ILLUMINATE	Md18-19 - 11 ¹¹ / ₁₈ (17) hang in passing the 350mts. 15 ¹¹ / ₁₈ (37) got keen while negotiating the bend, Jockey A.Imran Khan tried to prevent his mount from clipping the front runner. 7 ¹² / ₁₈ 69 ⁴ bumped at about the 250 metres. My19-20 - 13 ¹¹ / ₁₉ (7) met interference at the start and was slowly away. 11 ¹² / ₁₉ (33) drifted 'out' under pressure in the straight.
TREMENDOUS	My19 - 20 ¹⁰ / ₁₉ (114) Jockey was fined for taking an unduly long lead till rounding the final bend.
BRABOURNE	My19 - 30 ¹⁰ / ₁₉ 130 ² planted and lost many lengths. My19-20 - 27 ¹¹ / ₁₉ 19 ⁵ Jockey reported that he accidentally lost his whip, passing the 150 Metres and was slowly away and lost about two lengths. 11 ¹² / ₁₉ 32 ⁸ was slowly away and lost few lengths at the start. 25 ¹² / ₁₉ (49) was slowly away and lost about two lengths.
SCRIPT WRITER	My19 - 20 ⁹ / ₁₉ 56 ⁰ sustained bleeding cut injury on left hind outer hock. Under the circumstances, it was permitted to be withdrawn. My19-20 - 25 ¹² / ₁₉ 48 ⁴ burst its blood vessels.
MADURO	My19-20 - 13 ¹¹ / ₁₉ 6 ⁰ was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn.
TURF LEGEND	My19 - 12 ⁹ / ₁₉ 43 ⁶ met interference at the start. 19 ⁹ / ₁₉ (47) met interference passing 1000 metres. 26 ⁹ / ₁₉ 63 ⁷ Jockey reported that the horse was not galloping fluently in the straight examination of the mouth of the horse revealed fresh injuries at both oral commissure.
RAPUNZEL	MyS19 - 29 ⁵ / ₁₉ 13 ⁸ Jockey reported that he accidentally lost his left stirrup, approaching the 1000 Metres, which he regained within a few strides.
BLUE BLAZER	My19 - 11 ⁹ / ₁₉ 34 ⁸ met interference approaching 1100 Metres.
EL TYCOON	My19 - 3 ¹⁰ / ₁₉ 77 ⁴ met interference within the 100 Metres from the start. My19-20 - 25 ¹² / ₁₉ (47) sustained small injury inside right fore fetlock. 8 ¹ / ₂₀ 61 ¹⁰ met interference passing the 800 Metres.
MIRACLE KING	My19-20 - 11 ¹² / ₁₉ 33 ⁰ was extremely fractious at the gates and refused to be stalled, thereby considerably delaying the start of the Race; Under the circumstances, it was permitted to be withdrawn.
SEA LAGOON	My19 - 4 ¹⁰ / ₁₉ 85 ³ sustained small injury on right hind outer cannon.

6th Race The Aperitivo Plate**CI-III, 40-65****1800 Mts.**

DONT TRUST ANYONE	My19-20 - 27 ¹¹ / ₁₉ 19 ⁸ met interference approaching 1300 Metres and Jockey was reprimanded for momentarily losing his right reins, which he regained within a few strides, passing 300 Metres. He was informed to be more cautious in future. 31 ¹² / ₁₉ 55 ⁸ accidentally brushed the railings, passing the 1000 Metres. and was slowly away.
IMITATION GAME	My19 - 20 ⁹ / ₁₉ 57 ⁹ met interference at the start. My19-20 - 13 ¹¹ / ₁₉ 7 ³ was slowly away. 11 ¹² / ₁₉ 34 ¹¹ was slowly away.
GINTOKI	MyS19 - 22 ⁵ / ₁₉ 4 ⁰ withdraw on veterinary grounds as it was observed to be trotting lame on left fore due to capped elbow. 12 ⁶ / ₁₉ (27) Jockey was reprimanded for repeatedly looking back in the straight, for no apparent reason. My19 - 20 ⁹ / ₁₉ 55 ⁶ Jockey reported that his mount drifted 'out' rounding the final bend.
CELESTIAL LIGHT	M18-19 - 29 ³ / ₁₉ 214 ¹⁰ met interference at the start. My19 - 4 ¹⁰ / ₁₉ 83 ⁷ jumped out awkwardly. My19-20 - 13 ¹¹ / ₁₉ 7 ⁹ jumped out awkwardly. 25 ¹² / ₁₉ 47 ¹² did not raise a fluent gallop, soon after jumping out of the Starting Gates, thereby losing many lengths at the start.
DEIMUS	My19 - 4 ¹⁰ / ₁₉ 83 ⁴ Jockey was fined for excessive use of whip. 10 ¹⁰ / ₁₉ 94 ³ met interference at the start. 19 ¹⁰ / ₁₉ 105 ⁹ had to be checked and steadied by its rider to avoid striking the front runner, LAWRENCE OF ARABIA approaching the 1000 Metres. My19-20 - 4 ¹² / ₁₉ 27 ⁹ met interference before passing the red marker post.
ASCENDENCY	My19-20 - 4 ¹² / ₁₉ 27 ⁶ met interference passing 300 Metres. 8 ¹ / ₂₀ 60 ⁸ had apparently lost its left fore shoe, during the Race.
ORDER ORDER	My19 - 4 ¹⁰ / ₁₉ 84 ² Jockey reported that his mount was hanging 'out' throughout the race.
VENI VIDI VICI	My19-20 - 13 ¹¹ / ₁₉ (3) burst its blood vessels. 8 ¹ / ₂₀ 60 ⁷ stumbled, soon after jumping out of the starting gate. and met interference red marker post.
SAN VINTO	My19-20 - 4 ¹² / ₁₉ 27 ³ met interference approaching 1000 Metres. 25 ¹² / ₁₉ 45 ⁹ slowly away and lost few lengths.

7th Race The Indi Plate Div - I**CI-IV, 20-45****1400 Mts.**

HELLS BELLS	Pn19 - 14 ⁹ / ₁₉ 83 ² Jockey reported that his mount was lugging-in in the straight. My19-20 - 8 ¹ / ₂₀ 59 ⁶ Jockey reported that his mount was hanging 'out' throughout the Race.
PERFECT LEGACY	My19-20 - 27 ¹¹ / ₁₉ 22 ⁵ met interference passing 1100 Metres.
KAZURI	My19 - 27 ⁹ / ₁₉ 67 ¹¹ had apparently lost its right fore shoe, during the race. My19-20 - 20 ¹¹ / ₁₉ 11 ⁴ took a fly jump, at the Start and Was slowly away and lost about 2 lengths. 4 ¹² / ₁₉ 24 ¹² planted and lost many lengths at the start & Jockey was reprimanded for travelling wide rounding the final bend for no apparent reason. 18 ¹² / ₁₉ (37) Jockey reported that he accidentally lost his whip approaching 200 Metres & sustained linear injury on right hock. 8 ¹ / ₂₀ 62 ² accidentally brushed the Railings, passing the 1200 Metres.
DAGOBERT	Bg18-19 - 22 ³ / ₁₉ 192 ⁵ met interference passing the 450 metres.

INTREPID WARRIOR

My19 - 20¹⁰/₁₉112¹² could not get a clear run rounding the final bend due to a wall of horses in front of it and as such, had to travel wide. burst its blood vessels. **My19-20 - 18¹²/₁₉38⁵** the horse pulled up lame on right fore;

BREAKING NEWS

My19-20 - 13¹¹/₁₉5⁸ Jockey was fined for not making sufficient effort on his mount to improve his position rounding the bend and met interference passing the 600 Metres. **8¹/₂₀(57)** was drifting out under pressure, after entering the Straight.

CELTIC MIST

My19 - 30⁸/₁₉9³ did not get a clear run in the closing stages of the Race.

RED FEATHER

Bg18-19 - 7¹²/₁₈55¹² met interference soon after jumping of the starting gates and Jockey reported that his mount was hanging out badly after passing the 700 Metres and raced on the outer portion of the track it was found to have pulled up lame on left fore. **BgS19 - 25⁹/₁₉17⁸** was inclined to run out from 700 Metres despite the best efforts of the Jockey. **My19 - 20⁹/₁₉54¹²** was observed to be hanging 'out' rounding the final bend and after entering the straight, drifted 'out' to the outer portion of the Race Track and thereafter finished the race on the Outer Sand Track. **My19-20 - 25¹²/₁₉44¹²** veered out alarmingly towards the outer sand track, approaching 800 Metres.

SPEED QUEEN

My19 - 4¹⁰/₁₉87⁰ withdraw as it was observed to be trotting lame on right hind due to infected cellulitis of cannon region.

WIND POWER

Hy18-19 - 26¹¹/₁₈32⁶ met interference about the 100 mtrs. **10¹²/₁₈61⁰** was fractious and reared up inside the gates, as such the colt has been permitted to be withdrawn before coming under starters orders. **HyM19 - 9⁹/₁₉107⁶** met interference approaching the 800 mtrs. **16⁹/₁₉123⁸** the gelding returned bleeding from both the nostrils. **Hy19-20 - 24¹¹/₁₉29⁶** Jockey reported loss of whip at about the 300 mtrs and met severe interference again at about the 250 mtrs.

PILGRIM

My19 - 19¹⁰/₁₉102¹⁰ met interference at the start & got momentarily unbalanced. **30¹⁰/₁₉129⁰** suddenly slowed down and pulled up lame, nearing the 1100 metres and was found to have stifle lock on right hind and has sustained bruise on hock. **My19-20 - 27¹¹/₁₉17⁰** was examined at the Gates and was observed to be trotting lame right hind. Under the circumstances, it was permitted to be withdrawn.
