1 st Race The Crown Treasure Plate	CI-V, 00-25, 6 years old and over	1400 Mts.
TOUGH SUSSEX	My19 - 11 ⁹ / ₁₉ 35 ⁷ met interference at the start. 20 ¹⁰ / ₁₉ 112 ⁷ jumped awkwardly 'outwards & met interference passing 900 Metres and again had to be checked and steadied as it collided with the railings, passing the 250 metres. My19-20 - 4 ¹² / ₁₉ 24 ⁷ Jockey reported that he accidentally lost his whip passing 300 Metres.	
SENATOR	My20-21 - 2 ¹² / ₂₀ (25) Jockey was fined for allowing his mount to drift "out" under the use of whip. 16 ¹² / ₂₀ 37 ⁶ met interference at the start. 8 ² / ₂₁ 52 ⁴ met interference passing the Red Marker post.	
ITALIAN STALLION	My19-20 - 11 ¹² / ₁₉ 29 ⁵ accidentally brushed the railings, rounding the final bend & was slowly away. My20-21 - 25 ¹ / ₂₀ 16 ⁷ pulled up lame on right fore after the race. 8 ² / ₂₁ 53 ⁶ met interference at the start.	
EVERLASTING MEMORY	MyS19 - 3 ⁷ / ₁₉ 45 ¹¹ jumped awkwardly 'inwards. My20-21 - 23 ² / ₂₁ 168 ⁴ pulled up lame on left fore.	
RUSSIAN SPY	My19 - 3 ¹⁰ / ₁₉ 76 ⁰ fell at the saddling yard after being saddled and suffered multiple bruises on left hock and was observed to be lame on left hind. Under the circumstances it was permitted to be withdrawn. My19-20 - 12 ² / ₂₀ 96 ⁰ withdraw as it was trotting lame on right fore due to hoof abscess.	
SWISS BAY	My20-21 - 16 ¹² / ₂₀ 38 ⁹ was slowly away and lost few lengths at the start;	
SMART SIGNS	My20-21 - 2 ¹² / ₂₀ 23 ⁶ Jockey was reprimanded for dropping hands, in the last 100 Metres of the Race. 8 ² / ₂₁ 52 ⁵ accidentally brushed the railings, at 1000 Metres.

D DARLING	My19 - 27 ⁹ / ₁₉ 70 ⁰ withdraw on veterinary grounds as it was observed to be suffering from colic; My19-20 - 18 ¹² / ₁₉ 42 ² Jockey reported that his mount was hanging 'out' till entering the straight. 21 ¹ / ₂₀ 69 ⁸ travelling along the railings got keen and had to be checked by its rider to avoid striking the front runner. and met interference between the 700 Metres and the 600 Metres.	
HALOWEEN'S WAY	My19-20 - 22 ¹ / ₂₀ 76 ¹⁰ had to be checked and steadied and shifted out approaching the 1000 Metres.	
ORDER ORDER	My20-21 - 2 ¹² / ₂₀ 29 ⁶ met interference approaching the 700 Metres.	
HUKUM	My20-21 - 8 ¹² / ₂₀ 34 ⁶ Jockey was reprimanded for taking an unduly long lead, rounding the bend. and sustained injury on left fore outer bulb of heel.	
ASHWA VIKRANT	My19 - 20 ¹⁰ / ₁₉ 112 ⁴ met interference had to be checked and steadied as it collided with the railings, passing the 250 metres. My20-21 - 11 ¹¹ / ₂₀ 24 ⁴ took a fly jump, at the start & met interference at the last 150 Metres of the race. 8 ¹² / ₂₀ (36) met interference at the start. 8 ² / ₂₁ 57 ² Jockey was fined for excessive use of whip, on his mount.	
TRAVIESO	My19 - 26 ⁹ / ₁₉ 62 ⁴ sustained small cuts on right hind pastern.	
CELESTIAL LIGHT	My19-20 - 29 ¹ / ₂₀ 83 ¹¹ met interference passing the 1500 Meters. and sustained bleeding cut on right fore outer cannon. My20-21 - 8 ¹² / ₂₀ 34 ¹¹ jumped 'out' awkwardly, at the start. and was slowly away and lost few lengths. 1 ² / ₂₁ 47 ⁴ jumped awkwardly outwards & met interference approaching the 1000 Metres.	

3rd Race The Gonikoppa Plate

CI-V, 00-25

1200 Mts.

BLUE POINT My19-20 - 5²/₂₀90⁶ jumped awkwardly 'outwards', at the start. My20-21 - 1²/₂₁44⁷ Jockey was reprimanded for dropping his hands before passing the Winning Post.

COUNTRY'S SONG My20-21 - 23²/₂₁68⁶ met interference at the start.

STIGMATA My19-20 - 20¹¹/₁₉9⁵ veered out towards the Outer Sand Track, soon after jumping out of the Starting Gates. 4¹²/₁₉23⁶ brushed railings approaching 1000 Metres and Jockey reported that his mount was hanging 'in' throughout the Race.

VIRGINIA QUEEN My19 - 11¹⁰/₁₉97⁶ met interference at the start. My19-20 - 8¹/₂₀57⁰ withdraw on veterinary grounds, from the above Race, as it was observed to be trotting lame on right fore due to hoof abscess. 29¹/₂₀79¹² met interference at the start and slowly away. My20-21 - 1²/₂₁44⁰ was extremely fractious and refused to remain inside the Stall. Under the circumstances it was permitted to be withdrawn.

ORION PRINCESS My20-21 - 11¹¹/₂₀3¹⁰ Jockey reported that his mount was hanging 'out' throughout the race; 8¹²/₂₀33⁷ met interference passing the 1000 Metres. 1²/₂₁44⁵ met interference before passing the Red Marker post.

RAPTOR My20-21 - 11¹¹/₂₀1⁴ Jockey reported that his mount suddenly shied away from the railings, approaching the 300 Metres & sustained small cut on right fore outer cannon.

STRONG RESEMBLANCE My18-19 - 17¹/₁₉59⁶ Jockey reported that his mount was hanging 'in' in throughout the race. 31¹/₁₉80⁸ Was slowly away. 13²/₁₉87⁹ Was slowly away. MyS19 - 29⁵/₁₉10¹⁰ was slowly away and lost a few lengths at the start. My20-21 - 16¹²/₂₀38⁰ withdraw on veterinary grounds, as it was suffering from colic. 8²/₂₁52⁹ was slowly away and lost few lengths at the start.

TOBIN My19-20 - 12²/₂₀93⁰ met interference and stumbled and dislodged its rider, passing the 1100 Metres.

BIG TIME BAY My20-21 - 2¹²/₂₀25⁵ met interference in the final 150 Metres of the race & Jockey was reprimanded for dropping hands before passing the Winning Post. 1²/₂₁44⁴ met interference before passing the Red Marker post.

WOOD CUTTER My19 - 4⁹/₁₉15⁸ met interference soon after the start & Jockey reported that his mount was reluctant to gallop due to the kickback received during the race, was slowly away. My19-20 - 29¹/₂₀78⁶ was slowly away and lost few lengths at the start.

HONEY QUEEN My19-20 - 12²/₂₀95⁹ jumped awkwardly 'inwards', at the start. My20-21 - 2¹²/₂₀23⁸ met interference and had to be checked and steadied approaching the 1000 metres.

4th Race The Fantasy Dream Plate

CI-IV, 20-45, 6 years old and over

1200 Mts.

MARCH TO VICTORY My20-21 - 16¹²/₂₀41⁶ Jockey reported that his mount was hanging 'in' throughout the Race.

BROWN BEAUTY MyS19 - 3⁷/₁₉48⁷ met interference at the start. My19-20 - 22¹/₂₀(72) was slowly away.

D SMILE My19-20 - 22¹/₂₀76⁰ suffered from temporary stifle lock on the left hind, between the 1000 Metres and the 900 Metres, slowed down approaching the 700 Metres. 12²/₂₀97⁰ withdraw on veterinary grounds, as it was trotting stiff in both fore and hind legs.

ROYAL COMMAND My20-21 - 25¹/₂₀18¹¹ met interference in the last 100 Metres of the Race. 2¹²/₂₀29¹⁰ met interference passing 800 Metres. 16¹²/₂₀41¹⁰ met interference before the red marker post.

ELOIKA My19-20 - 4¹²/₁₉25³ jumped awkwardly inwards. 25¹²/₁₉47⁴ met interference passing the 800 Metres. 5²/₂₀88⁰ withdraw from the above race as it was observed to have sustained clipped injury over right hind coronet.

DARE THE DON My20-21 - 16¹²/₂₀41¹¹ met severe interference before the red marker post.

GOOD OPINION MyS19 - 37¹/₁₉48¹¹ met interference at the start & sustained injury on left fore coronet. My19-20 - 27¹/₁₉18⁸ was slowly away and lost about two lengths. 29²/₂₀109⁰ was very fractious and refused to be stalled, thereby considerably delaying the start of the Race; Under the circumstances it was permitted to be withdrawn.

SCARLET PRINCESS My20-21 - 25¹/₂₀17⁰ clipped the front runner, stumbled & dropped the rider rounding the final bend. 15²/₂₁61⁴ met interference in the last 50 Metres of the Race.

TIME ALWAYS My19-20 - 29¹/₂₀78⁴ met severe interference passing the 1000 Metres. My20-21 - 16¹/₂₀38⁴ had lost its right hind shoe, during the race.

SCORPENE My19-20 - 13¹/₁₉(2) sustained small bleeding cut inside right hind hock. 18¹/₁₉38² burst its blood vessels. My20-21 - 21²/₂₀24⁶ jumped awkwardly 'outwards' & sustained gum injury.

CLASSIC JEWEL My20-21 - 16¹/₂₀39⁷ met interference between the 900 Metres and the 800 Metres.

5th Race The Siachin Plate

CI-II, 60 and above

1200 Mts.

D HUNTER Pn19 - 26⁷/₁₉13¹³ had right eye injury. 7⁹/₁₉77⁴ leaned inwards approaching the 700 metres & was observed to have lost its left fore shoe. M19-20 - 16¹/₂₀(93) met interference at the start and was observed to have a clip injury at the left hind fetlock.

STAR OF THEA My20-21 - 21²/₂₀28¹¹ jumped awkwardly outwards. 15²/₂₁(65) met interference passing the 1000 Metres & An enquiry is being held into the improved performance. 23²/₂₁70² Jockey was reprimanded for dropping hands before passing the Winning Post.

LORD COMMANDER My19-20 - 5²/₂₀88⁴ Jockey reported that his mount was hanging 'in' after entering the straight. My20-21 - 21²/₂₀(29) sustained clipped injury on right hind outer bulb of heel. 16¹/₂₀41⁰ withdraw on veterinary grounds, as it was observed to be trotting lame on right hind due to hoof abscess. 8²/₂₁(58) met interference at the start.

SADEEK My19-20 - 18¹/₁₉40³ accidentally brushed the railings approaching 1000 Metres & Jockey was fined for the excessive use of whip on his mount in the above Race. My20-21 - 16¹/₂₀42³ An enquiry is being held into the manner of riding & sustained clipped injury on right hind fetlock.

D WARRIOR My19-20 - 8¹/₂₀(61) was running erratically, in the last 250 Metres of the Race. My20-21 - 8¹/₂₀35⁷ was found to have suffered from Grade IV EIPH.

NEWPORT Hy18-19 - 11²/₁₉191⁹ met interference soon after the start. HyM19 - 29⁷/₁₉30⁰ The stirrup iron of broke after being loaded in the starting gates, as such the gelding has been permitted to be withdrawn.

QUEEN OF TURF My19 - 11⁹/₁₉29⁸ severe interference in the straight course.

NEW BEGINNING My20-21 - 1²/₂₁49⁷ stumbled, soon after jumping out of the Starting Gates.

RARE AND BOLD My19-20 - 25¹/₁₉(46) stumbled while jumping out.

SILVER DAYS AGAIN My20-21 - 8¹/₂₀36⁰ withdraw on veterinary grounds as it was suffering from fever and infection.

KINGOF THE JUNGLE My20-21 - 16¹/₂₀(41) met interference before the red marker post. 1²/₂₁48² Jockey was fined for allowing his mount to drift out, with the use of the Whip, in the last 100 Metres of the Race, wherein his mount finished the Race on the outer portion of the Race Track.

7th Race The Aperitivo Plate

CI-IV, 20-45

1400 Mts.

CEFFINA My20-21 - 11¹/₂₀1² Jockey reported that the right reins momentarily slipped from his hands, in the last 150 Metres of the Race.

ASCENDENCY My19-20 - 1³/₂₀111⁰ was examined at the Starting Gates and it was found to be trotting lame on right hind; Under the circumstances it was permitted to be withdrawn. My20-21 - 11¹¹/₂₀7⁸ met interference and stumbled passing 1200 Metres. 25¹¹/₂₀19¹⁰ Jockey reported that his mount was hanging in throughout the race.

NEXT LEVEL My19-20 - 20¹¹/₁₉9³ was extremely playful at the Saddling Enclosure and hence the Tongue Strap could not be fastened, despite his repeated efforts to put it on. Under the circumstances, it was permitted to run without the Tongue Strap and Jockey reported that his mount was running green, throughout the Race. 4¹²/₁₉23² jumped awkwardly outwards at the start. My20-21 - 8¹²/₂₀30² Jockey was fined by the Stipendiary Stewards for the inept handling of his mount.

EXPORT QUALITY My19-20 - 22¹/₂₀(74) met interference rounding the bend and was slowly away at the start. 5²/₂₀91⁷ was slowly away. 1³/₂₀117⁹ met interference passing the 700 Metres. My20-21 - 1²/₂₁46⁵ met interference approaching the 300 Metres & was slowly away. 15²/₂₁61² met severe interference soon after the start and again passing 1100 Metres & Was slowly away

THEA'S DREAM My19-20 - 12²/₂₀96⁷ Jockey reported that his mount was hanging in throughout the race. My20-21 - 11¹¹/₂₀3⁹ was slowly away, jumped awkwardly outwards thereby losing few lengths at the start. sustained bruise on left chest wall. 25¹¹/₂₀22⁸ Planted and lost many lengths. 16¹²/₂₀37¹⁰ met interference at the start. 15²/₂₁(60) An enquiry is being held into the improved performance.

KING'S COMMAND My19-20 - 12²/₂₀98⁶ met interference passing the 350 metres. My20-21 - 2¹²/₂₀27³ met interference between the 800 Metres and the 600 Metres. 16¹²/₂₀37⁷ met interference passing the 1300 Metres.

SUSSEX PRIDE My20-21 - 8¹²/₂₀33⁰ withdraw on veterinary grounds as it was suffering from colic.

INTENSE COMMAND My19-20 - 20¹¹/₁₉9⁰ dropped its rider, on its way to the Starting Gates and bolted. Under the Circumstances, it was permitted to be withdrawn. 5²/₂₀90⁴ was inclined to run 'out', rounding the bend and till entering the straight and after passing 300 metres drifted 'out' on to the outer sand track and finished the race on the outer sand track and met interference at the start.

COUNTRY'S PACE My19-20 - 1³/₂₀117¹⁵ met interference passing the 700 Metres. My20-21 - 25¹¹/₂₀16³ met interference at the start. 8¹²/₂₀31⁵ sustained bleeding cut inside left hind coronet.

COUNTRY'S DELIGHT My18-19 - 19²/₁₉93⁶ met interference at the start. and was observed to be hanging 'out', rounding the final bend MyS19 - 29⁵/₁₉10⁰ stumbled, passing the 600 Metres, and dislodged its rider. and pulled up lame on right fore. My19-20 - 21¹/₂₀66³ met interference at the start.

8th Race The Star Angel Plate

CI-III, 40-65, 6 years old and over

1200 Mts.

BLUE BLAZER My20-21 - 15²/₂₁64⁰ Jockey reported after the Race, that his mount wobbled and he was not comfortable riding it, passing the 200 Metres and as such, he stopped riding and dismounted from his mount, was reported to be uncomfortable on right fore near the 200 Metres.

LEAP OF FAITH My19-20 - 11¹²/₁₉32⁴ sustained deep cut injury inside right hind hock. 8¹/₂₀60⁴ did not get a clear run, between the 400 Metres and the 250 Metres, due to a tightly packed field. My20-21 - 8¹²/₂₀34¹² Jockey reported that he accidentally lost his whip passing the 200 Metres.

MURCILAGO My20-21 - 11¹¹/₂₀6¹¹ Jockey reported that his mount was momentarily unbalanced, passing the 1000 Metres.

COUNTRY'S COURAGE MyS19 - 12⁶/₁₉26¹⁰ jumped awkwardly 'inwards'. 26⁶/₁₉40³ jumped awkwardly 'outwards', at the start. My19-20 - 13¹¹/₁₉6¹¹ pulled up lame on left fore. 29²/₂₀106⁷ met interference approaching 900 Metres.

FRINGE BENEFIT My19-20 - 31¹²/₁₉55¹⁰ met interference passing the 700 Metres. 21¹/₂₀69⁷ met interference passing the 1000 Metres. 12²/₂₀100¹⁰ met interference between the 200 Metres and the 100 Metres of the race.

WILLOW GLEN My19-20 - 5²/₂₀91⁴ Jockey was fined for cutting across the field, before passing the Red Marker Post. My20-21 - 11¹¹/₂₀5³ jumped awkwardly inwards and met interference passing the 300 Metres.

DALLAS

Bg19-20 - 7²/₂₀**143**¹⁰ Jockey was reprimanded for travelling wide from 700 Metres till about rounding the final bend. **My20-21** - 2¹/₂₀**(26)** accidentally brushed the railing passing 1100 metres.

ABERLOUR

Pn19 - 25⁸/₁₉**54**⁴ jumped outwards and met interference at the start & App suspend for riding an injudicious race. **My20-21** - 25¹/₂₀**19**² was slowly away and lost few lengths at the start. 23²/₂₁**71**³ met interference passing the 300 Metres.

D DON

Pn19 - 11⁸/₁₉**30**³ showed signs of respiratory distress after passing the winning post. 13¹⁰/₁₉**137**⁸ met interference approaching the 800 metres & came back in distress after the race. **M19-20** - 29¹/₂₀**63**² was inclined outwards passing the 800 metres. 18¹/₂₀**97**³ jumped inwards at the start. 26²/₂₀**161**³ showed symptoms of distress after the race. **My20-21** - 1²/₂₁**47**⁵ suffered from heat stress, showing signs of distress.

BLUE BIRD THE WORD

My19 - 30⁸/₁₉**14**⁴ met interference soon after the start. 3¹⁰/₁₉**80**⁹ was slowly away and lost about two lengths. **My20-21** - 1²/₂₁**48**¹¹ was slowly away.

EWANDOR

My19 - 30¹⁰/₁₉**131**⁹ jumped out awkwardly at the start. **My19-20** - 29²/₂₀**104**⁰ bolted while being loaded into the stalls and ran around the course on the reverse sand track; Under the circumstances it was permitted to be withdrawn. **My20-21** - 8²/₂₁**58**⁹ jumped awkwardly outwards, at the Start.

INDIAN DREAMS

My20-21 - 16¹/₂₀**41**⁵ met interference rounding the final bend & was slowly away. 8²/₂₁**54**⁴ Jockey was fined for not making sufficient effort to ride out his mount, during the race.
