

RACING INCIDENTS IN BRIEF OF IMMEDIATE PAST 6 RUNS

1st Race The Venus De Milo Plate Div - II	CI-IV, 20-46, (0 to 19 eligible). Foreign Jockeys Eligible	1200 Mts.
STICK TO THE PLAN	M19-20 - 15 ¹² / ₁₉ 38 ⁹ met interference passing the 250 metres. 9 ¹ / ₂₀ 84 ⁵ jumped outwards at the start and met interference in the final stages of the race. 9 ² / ₂₀ 133 ⁴ met interference at the start. 26 ² / ₂₀ 161 ⁴ App. Jockey reported that his whip was damaged and was left unserviceable. Pn20 - 27 ¹¹ / ₂₀ 27 jumped outwards at the start & had to be checked in the final stages of the race and was observed to have a cut injury at the left fore cannon, left eye injury (sore).	
GRAND SINATRA	M18-19 - 31 ³ / ₁₉ 220 ³ met interference at the start and Jockey stated that his mount was erratic in the straight. Pn19 - 10 ⁸ / ₁₉ 26 ⁹ jumped inwards at the start and was tightened and dropped back at the start and met interference Passing 100 metres. M19-20 - 1 ¹² / ₁₉ 23 ⁰ refused to be stalled despite substantial efforts, as such, the gelding was also withdrawn. 24 ¹ / ₂₀ 109 ² took an awkward fly jump and met interference approaching the 400 metres and Jockey reported that he was not ready while the start was effected. Pn20 - 13 ¹² / ₂₀ 32 ¹⁰ shifted in passing the 800 metres.	
RAMBLER	M19-20 - 13 ² / ₂₀ 141 ⁷ jumped outwards at the start. Pn20 - 6 ¹² / ₂₀ 18 ⁰ ducked the front gates and ran breaking the front barrier. In the process, Jockey was hurt and indisposed, as such was withdrawn After being stalled & was observed to have a gum injury.	
HIOCTANE	Pn20 - 27 ¹¹ / ₂₀ 7 ⁵ met interference approaching 1000 metres.	
HOLLYWOOD PARK	M19-20 - 18 ¹ / ₂₀ 98 ⁹ App reported that his mount hung-in in the straight. 13 ² / ₂₀ 142 ⁹ jumped out slow, losing about 5 lengths at the start.	
ROSPOMARE	M18-19 - 2 ² / ₁₉ 123 ³ met interference passing 350 metres. 14 ³ / ₁₉ 185 ⁵ an enquiry has been initiated into the running and riding.	
2nd Race The Sir Rahimtoola Chinoy Trophy	CI-II, 60-86, (40 to 59 eligible). Foreign Jockeys Eligible	1600 Mts.
FRIVOLOUS	Pn19 - 14 ⁹ / ₁₉ 81 ³ Jockey was observed to have used the whip in excess of the prescribed limit on his mount. M19-20 - 24 ¹ / ₂₀ 107 ⁴ was observed to have a cut injury at the right hind fetlock.	
VICTORIOUS SERMON	BgS19 - 20 ⁷ / ₁₉ (131) met interference passing the 1000 Metres. Pn19 - 15 ⁹ / ₁₉ 91 ³ was observed to have a cut injury at the right hind cannon. M19-20 - 22 ¹² / ₁₉ 51 ⁵ had to be checked and steadied approaching the 600 metres, due to a tightly packed field. 2 ² / ₂₀ 125 ¹² tightened for room and had to be checked soon after the start.	
GALLANTRY	CMn19 - 10 ⁹ / ₁₉ 78 ⁸ travelling along the rails was checked by its rider when squeezed for room by the fast improving horses on the outside passing the 800 metres. Pn20 - 6 ¹² / ₂₀ 19 ⁴ met interference soon after the start & had to be checked approaching 1000 metres.	
MOUNT MORIAH	M19-20 - 29 ¹² / ₁₉ 65 ² leaned outwards passing the red marker and Jockey reported the loss of whip passing the 500 metres. 18 ¹ / ₂₀ 96 ³ was found to be sore by the left fore leg. 13 ² / ₂₀ (140) Jockey reported that his mount was erratic in the straight and shied outwards in the final stages of the race. 12 ³ / ₂₀ (184) had lost its left fore shoe. Pn20 - 20 ¹² / ₂₀ (42) leaned outwards passing the 200 metres.	
ODESSA	Pn19 - 25 ¹⁰ / ₁₉ 144 ¹⁰ met interference soon after the start. M19-20 - 17 ¹¹ / ₁₉ 7 ³ App reported the loss of whip at about 150 metres.	
3rd Race The Lady In Lace Plate Div - I	CI-V', 4-30, Foreign Jockeys Eligible	1400 Mts.
POSSE	Pn20 - 11 ¹² / ₂₀ 26 ⁴ had right eye injury.	
NAXOS	Pn20 - 6 ¹² / ₂₀ 22 ⁰ lost about 2 lengths at the start and thereafter dislodged the rider.	

PATRIOTS DAY Pn19 - 16⁸/₁₉44⁸ had right eye injury (sore). 7⁹/₁₉79⁸ bumped and met interference approaching the 1000 metres & was observed to have broken a blood vessel. 12¹⁰/₁₉132⁹ was found to be sore by the right fore leg. M19-20 - 29¹²/₁₉65¹⁰ jumped inwards at the start and met interference passing the red marker. 16¹/₂₀94¹² was observed to have run detached from the field and was also inclined outwards.

SEASONS GREETINGS Pn20 - 11¹²/₂₀28⁰ was fractious and reluctant to be stalled, as such, the filly was withdrawn. 20¹²/₂₀40⁶ met interference & had to be steadied approaching 200 metres.

ADONIYAH Pn19 - 6¹⁰/₁₉121² Jockey was observed to have used the whip in excess of the prescribed limit on his mount. M19-20 - 2¹/₂₀70⁸ jumped out brushing against its stall and met interference at the start. Pn20 - 11¹²/₂₀24¹⁰ jumped outwards at the start.

POLARIS M18-19 - 2¹²/₁₈28⁹ was marginally slow met interference at the start. Pn19 - 10⁸/₁₉23² had an abrasion at the left hind pastern. 24⁸/₁₉49⁶ had left eye injury (sore). M19-20 - 5¹/₂₀73⁵ had to be checked and dropped back approaching the 1400mts.

XPONENTIAL Pn18 - 28¹⁰/₁₈170⁵ jumped out slow losing about 3Ls.

SHAPATH M19-20 - 2¹/₂₀68² met interference passing the 150 metres. 1²/₂₀119⁷ met interference passing the 1000 metres. 5³/₂₀172⁸ jumped inwards at the start.

5th Race The Uttam Singh Trophy CI-IV, 20-46, (0 to 19 eligible). Foreign Jockeys Eligible 2400 Mts.

MORISEIKI Pn19 - 14⁹/₁₉(80) was observed to have shied out under pressure passing the 400 metres. M19-20 - 1¹²/₁₉19⁴ was marginally slow to begin and met interference at the start. 1²/₂₀114⁴ The Stipendiary Stewards have initiated an enquiry into the running and riding. Pn20 - 20¹²/₂₀39⁵ bumped approaching 500 metres.

LORITO Pn20 - 13¹²/₂₀33⁶ met interference at the start.

HISTORIAN M19-20 - 16¹/₂₀91⁷ received checked in the final stages of the race. and App reported that his mount was running green throughout the race. Pn20 - 29¹¹/₂₀12⁵ jumped inwards at the start.

BRAZOS Pn20 - 13¹²/₂₀33¹⁰ shifted out soon after the start & met interference had to be steadied approaching the 1800 metres and again met interference at 700 mts.

FIRE N ICE Pn20 - 13¹²/₂₀33³ met interference soon after the start.

WALK THE TALK Pn19 - 12¹⁰/₁₉128³ met interference at the start. M19-20 - 26²/₂₀160⁴ jumped out and did not raise an effective gallop.

6th Race The Col. kaikhushroo Maneckji Bharucha Memorial Trophy CI-III, 40-66, (20 to 39 eligible), Foreign Jockeys Eligible 1000 Mts.

STORM BREAKER M19-20 - 1¹²/₁₉22⁵ lost its right fore shoe. 29¹²/₁₉62³ Jockey has been fined for having used the whip in excess of the prescribed limit on his mount.

HIDDEN GOLD M19-20 - 18¹/₂₀(102) bumped at the start and Jockey was observed to have used the whip in an improper manner causing his mount to maintain an erratic course. Pn20 - 6¹²/₂₀(21) met interference at the start.

IMPALA M19-20 - 29¹²/₁₉62² was observed to have hung-in in the straight. 24¹/₂₀111¹² bumped approaching the 400 metres. 16²/₂₀149⁴ Jockey reported his mount was inclined inwards throughout the race. 26²/₂₀163⁵ was found to be sore by the left fore leg. Pn20 - 6¹²/₂₀21⁰ left the paddock early and was to be led to the start riderless. Subsequently, Jockey Dashrath Singh reported unwell and was certified unfit to ride, was withdrawn from the race. 11¹²/₂₀25⁷ met interference at the start and again passing 700 metres.

NAMAQUA Pn19 - 19¹/₁₉69⁰ was observed to have shifted out and had to be steadied and was inclined outwards from 200mts. Thereafter, approaching the final stages of the race, the gelding shied in thereby dislodging its rider. 12¹⁰/₁₉131² was observed to have shied inwards despite the riders efforts & had an abrasion at the left hind fetlock. 25¹⁰/₁₉148⁴ was observed to have an abrasion at the left hind fetlock. M19-20 - 24¹/₂₀111⁷ jumped inwards at the start. Pn20 - 6¹²/₂₀21³ met interference passing 700 metres.

WILD FIRE M19-20 - 26²/₂₀163⁸ met interference approaching 100 metres. Pn20 - 6¹²/₂₀21⁴ jumped outwards at the start. 11¹²/₂₀25⁵ App reported the loss of whip passing the 150 metres.

MEMORABLE MEMORIES M18-19 - 12¹/₁₉98⁸ met interference passing 200 metres. Pn19 - 25¹⁰/₁₉147⁸ App reported that his mount hung out in the straight & was observed to have an abrasion at the right hind pastern. M19-20 - 9²/₂₀(133) jumped outwards at the start.

SLAM DUNK Pn19 - 25¹⁰/₁₉148³ bumped in the final stages of the race. M19-20 - 15¹²/₁₉38¹¹ met interference passing the 250 metres & had lost its left hind shoe. 16²/₂₀148¹² took a fly jump and met interference soon after the start.

USTAD PEDRO Pn19 - 28⁹/₁₉(111) jumped outwards at the start & Jockey reported that his mount hung out in the straight despite his efforts from the 250 metres onwards. 25¹⁰/₁₉142⁴ jumped outwards and met interference at the start and was inconvenienced. approaching the 800 metres. M19-20 - 1²/₂₀118¹³ shifted out soon after the start. 13²/₂₀(137) An enquiry has been initiated into the improved performance.

7th Race The Gool & Soli Poonawalla Indian 1000 Guineas (grade 1) CI-1G, Terms, Foreign Jockeys Eligible 1600 Mts.

ALLURING SILVER M19-20 - 5³/₂₀(171) jumped outwards at the start.

FOREST FLAME M19-20 - 23²/₂₀(154) observed to have an abrasion at the right hind bulb of heel.

MISS MUFFET M19-20 - 9²/₂₀(131) met interference throughout the race.

ONE WISH Pn20 - 27¹¹/₂₀6⁷ had injuries in both eyes (mild ulcer).

SUPER GIRL M19-20 - 23²/₂₀154⁹ jumped outwards and met interference soon after the start. and again in the final stages of the race. Pn20 - 29¹¹/₂₀11⁷ bumped passing the 200 metres. 25¹²/₂₀46³ met interference along the rails approaching 50 metres.

8th Race The Venus De Milo Plate Div - I CI-IV, 20-46, (0 to 19 eligible). Foreign Jockeys Eligible 1200 Mts.

BIRKIN BLOWER M19-20 - 22¹²/₁₉50⁶ Jockey reported that despite his mount being inclined outwards, he had persisted with the use of whip from the right. 2²/₂₀124⁰ found to be sore by the left fore leg, as such the colt was certified unfit to race and withdrawn.

MIGHTY WARRIOR M18-19 - 16¹²/₁₈(53) jumped out slow losing about 2 lengths at the start. 3²/₁₉136⁸ met interference at the start. M19-20 - 2²/₂₀127³ was held up due to lack of room passing the 400 metres.

CLARK KENT M19-20 - 17¹¹/₁₉5⁷ met interference passing the 250 metres. Pn20 - 29¹¹/₂₀10¹⁴ weakened along the rails and dropped back and in the process was tightened for room approaching 500 metres.

TASMAN M19-20 - 16²/₂₀143³ received checked approaching 1000 metres and again passing the 300 metres. Pn20 - 11¹²/₂₀24⁸ met interference at the start and met interference had to be steadied passing 400 metres.

WILD FLOWER M19-20 - 18¹/₂₀97⁷ met interference at the start. Pn20 - 27¹¹/₂₀8¹² jumped out slow losing about 3 lengths at the start. 13¹²/₂₀32⁰ planted and had to be ushered out of the gates.

ISTANBUL M18-19 - 17³/₁₉195⁵ met interference approaching 600 metres and Jockey reported that his mounts was running green. M19-20 - 9¹/₂₀84² App reported that his mount hung out in the straight passing the 300mts,

OFFICER IN COMMAND M19-20 - 17¹/₁₉1⁶ met interference at the start. 26²/₂₀165³ was scoped after the race at the Equine Hospital and found to be Grade-III EIPH. Pn20 - 20¹²/₂₀40⁵ had lost its left hind shoe.

9th Race The Lady In Lace Plate Div - II

CI-V', 4-30, Foreign Jockeys Eligible

1400 Mts.

SUMMER NIGHT Pn20 - 29¹/₂₀13⁵ took a fly jump thus losing about 2 lengths at the start. 25¹²/₂₀48⁰ dislodged its rider on the way to the starting point and bolted thereby delaying the start. The gelding was withdrawn before coming under the Starters order.

CAESAR Pn19 - 25⁸/₁₉59⁷ met interference at the start. M19-20 - 5¹/₂₀80³ jumped out and tried to whip around. and Jockey reported that his mount jumped outwards and had to be steadied. Pn20 - 27¹/₂₀4⁴ leaned inwards approaching 1000 metres.

TRINKET M19-20 - 29¹²/₁₉61⁵ had right eye injury (sore, lacrimation). Pn20 - 29¹/₂₀13⁶ had be checked and steadied along the rails approaching 800 metres.

IRISH EYES Pn20 - 29¹/₂₀11⁹ met interference passing 400 metres. 13¹²/₂₀31⁷ met interference and had to be steadied approaching 200 metres.

DONT MESS WITH ME Pn19 - 26¹⁰/₁₉153¹⁰ met interference soon after the start & was observed to have an abrasion at the right hind coronet . M19-20 - 16²/₂₀150¹⁴ met interference at the start and took a fly jump.

SOLDIER OF FORTUNE Pn19 - 13¹⁰/₁₉134⁵ Jockey reported that his mount lacked initial speed and thereafter trailed the field despite his efforts.

GANDALF M19-20 - 24¹/₂₀110⁷ jumped outwards at the start. Pn20 - 27¹/₂₀4⁷ had right eye injury (sore). 6¹²/₂₀16⁹ had right eye injury (sore eye & lacrimation). 20¹²/₂₀38⁵ shifted out approaching 800 metres.

SHADOWS M19-20 - 17¹/₁₉9⁹ met interference at the start. 21¹²/₁₉45¹¹ met interference Passing the 1000 metres. 16²/₂₀150⁵ jumped out awkwardly brushing against its stall and met interference soon after the start. Pn20 - 13¹²/₂₀30⁹ was observed to have a cut injury at the right hind tendon.

CRISTO BOSS Pn19 - 12¹⁰/₁₉132⁰ met interference at the start.
