

**RACING INCIDENTS
IN BRIEF OF IMMEDIATE PAST 6 RUNS**

1st Race The Hot Weather Plate

CI-4Y, Maiden

1100 Mts.

THE ADJUTANT D20-21 - 3²/₂₁13² Jockey reported that his mount was leaning inwards throughout the race. 5²/₂₁19² Jockey reported that his mount was inclined to lug-in in the straight and he found it difficult to ride out his mount. 23³/₂₁56⁶ met interference before the red marker.

MISS DAISY D20-21 - 22¹/₂₁12⁰ was withdrawn before coming under Starter Orders, as the filly was extremely fractious at the gates. 5²/₂₁19⁷ drifted outwards and was reluctantly into the strides, thereby losing ground & Jockey reported that his mount was inclined to lug-out throughout the race, Jockey has been cautioned for using his whip with the right hand in the straight, thereby aggravating the outward movement of his mount.

NANDINI D19-20 - 25²/₂₀192¹¹ jumped out awkwardly at the start.

QUEENSHIP Pn19 - 12¹⁰/₁₉130⁵ Jockey reported that his mount was running green throughout the race. M20-21 - 13¹/₂₀36⁸ met interference passing 300 metres. D20-21 - 23³/₂₁55⁷ did not raise a fluent gallop after jump-out and lost ground.

SAPPHIRE D19-20 - 25²/₂₀189⁵ stumbled and as the filly was steadied at the start. D20-21 - 5²/₂₁20⁰ withdrawn before coming under starters order on veterinary ground as found to be lame by their left-fore legs.

2nd Race The Amazing Fighter Plate

CI-III, 40-66, (Lower Class Eligible)

1100 Mts.

MISS MARMALADE D20-21 - 16²/₂₁134⁰ Since App Ankit Pal was injured in the 2nd race and was declared unfit to ride and a suitable replacement was not available for as such, with the permission of the Stewards, the filly was withdrawn.

KAFTAN D19-20 - 26¹/₁₉107² met interference passing 1000mts. and Jockey reported that his whip broke from the middle near 300 metres and dangled, rendering it ineffective.

ZELBET D19-20 - 18²/₂₀188¹⁴ App has been cautioned for travelling wide while negotiating the bend and in the straight. D20-21 - 4³/₂₁46⁷ was ridden in check for some distance in the final 100 meters.

ASHWA SABIRA D19-20 - 11²/₂₀176⁶ jumped awkwardly, met interference and lost ground soon after the start. 3³/₂₀196¹¹ was slowly away and and Jockey reprimanded for travelling wide and for his feeble riding effort during the race. D20-21 - 3²/₂₁15⁷ reared up a few times as the Gates opened and lost many lengths. 16²/₂₁(32) Jockey was cautioned for shifting IN at 100 meters. 30³/₂₁66⁸ met interference soon after the start.

BLACK BOXER D19-20 - 31¹/₂₀163³ Jockey has been cautioned for shifting in before the Red Marker and in the process went across the field on his inside. and Jockey has been fined for using his whip in excess of the prescribed limit on his mount. 11²/₂₀176⁸ was observed to have broken a blood vessel.

LODGE KEEPER D19-20 - 6²/₂₀167³ met interference soon after the start.

MASTER CAUSEWAY D19-20 - 30¹/₁₉134² was slowly away and met interference at the start. 7¹/₂₀144¹¹ Jockey has been asked to continue making an effort till past the Post. 6²/₂₀(167) Jockey reported that his mount ran green throughout the race.

MR SINGH D20-21 - 23³/₂₁59⁷ Jockey has been cautioned for allowing his mount to shift outwards under the use of the whip in the final 200 metres.

3rd Race The Silver Fortress Plate

CI-II, 60-86, (Lower Class Eligible)

1000 Mts.

RESPONSIBLEFORLOVE D19-20 - 26¹/₁₉106⁸ jumped awkwardly outwards and Jockey explained that this mount jumped outwards despite his efforts and he tried to pull his mount inwards at the start. and travelling some distance from the start and Jockey has been fined for using his whip in excess of the prescribed limit on his mount.

UNDISPUTED D19-20 - 19¹/₁₉92⁶ was tightened soon after the start and Jockey has been cautioned for travelling wide at the bend for no apparent reason. 18²/₂₀187⁷ met interference at the start.

MISS ARTS D19-20 - 6²/₂₀173¹¹ Jockey has been asked to continue riding his mount till past the Post.

BIG APPLE D19-20 - 24¹/₂₀154³ Jockey was cautioned for allowing his mount to drift out without taking corrective action.

COUP DE FOU DRE D20-21 - 3²/₂₁16⁴ was eased off the heels of THE CHEETAH and lost position Near 800 metres. 9²/₂₁29⁶ met interference Passing 1200 metres. 16²/₂₁32⁰ charged the Gates as the mare was being loaded, whereby App was injured and was unfit to ride. As such, COUP DE FOU DRE was withdrawn before coming under Starters order. 23³/₂₁41² Jockey has been given benefit of doubt with regard to his riding effort.

TREASURE D19-20 - 24¹/₂₀(157) took a fly jump at the start. 18²/₂₀188² met interference passing 200mts. D20-21 - 30³/₂₁62⁴ met interference passing 1000 metres.

ASHWA MAITHLI D19-20 - 30¹/₁₉136² Jockey has been fined for using his whip in excess of the prescribed limit on his mount. D20-21 - 23²/₂₁41⁸ Jockey reported loss of whip near 150 meters.

4th Race The Thunder Bird Plate Div - I

CI-IV, 20-46, (Lower Class Eligible)

1000 Mts.

DELUXE D19-20 - 26¹/₁₉106¹² met interference in the final 100 metres. D20-21 - 30³/₂₁61⁵ Jockey has been reprimanded for feeble handling of his mount during the race.

MISS COLOMBIANA D19-20 - 14¹/₂₀147⁸ Jockeys asked to continue riding his mount till past the post.

DHATOORA D19-20 - 21¹/₁₉101⁸ slowly away and have broken a blood vessel. D20-21 - 22¹/₂₁11⁹ planted and lost many lengths.

MERCI BEAUCOUP D19-20 - 11⁰/₁₉35⁴ was observed to have broken a blood vessel. 7¹/₁₉73³ met interference and was also steadied near 500 metres. 24¹/₁₉129⁰ was withdrawn on compassionate grounds. 14¹/₂₀150¹² was found to be lame by her rightfore leg.

RIOS PRINCESS D19-20 - 10¹/₁₉116⁵ Jockey has been fined and severely warned for the future. D20-21 - 19¹/₂₁6⁰ appeared to be dehydrated and exhausted, as such was withdrawn.

NICHE CURRENCY	D20-21 - 5²/₂₁23⁸ Jockey was reprimanded for not making any efforts on his mount throughout the race. 9 ² / ₂₁ 27 ⁶ met interference at the start & Due to the interference, lost his left stirrup, which he regained shortly. 23 ² / ₂₁ 38 ⁵ walked out of the Gates and was slowly away & Jockey has been fined for not the race not ridden his amount to complete advantage during the race and severely cautioned for the future.
BE CHAMPION	D17-18 - 15¹/₁₈154⁰ shied away from the whip Near 100 metres. revealed a mouth injury on right side.
AMAZING MELODY	D18-19 - 5⁴/₁₉248⁴ sustained an injury on its right hind hock. 30 ⁴ / ₁₉ 305 ² sustained injury on its right hind leg. D19-20 - 18¹⁰/₁₉52⁶ Jockey was severely reprimanded for not sufficiently persevering with his mount in the straight. 21 ¹¹ / ₁₉ 97 ⁵ observed to have broken a blood vessels. 6 ² / ₂₀ 172 ¹³ met interference passing 900 metres. and was observed to have broken a blood vessel.
NORTHERN TIGER	D18-19 - 27⁴/₁₉290⁹ met interference soon after the start.
TWINSPIRE	M20-21 - 27¹²/₂₀56⁸ met interference at the start.
5th Race The Thunder Bird Plate Div - II	CI-IV, 20-46, (Lower Class Eligible) 1000 Mts.
RAINFOREST	D19-20 - 25²/₂₀189⁰ was extremely fractious before being loaded, as such, was withdrawn before coming under Starters orders. D20-21 - 16²/₂₁(33) received check and lost position & Jockey has been cautioned for continuing to use the whip with his right hand as the filly was inclined to shift out under the use of the whip in the final 200 meters, had sustained a cut injury on her chest.
MASTER BECKET	D20-21 - 16²/₂₁31³ Jockey has been cautioned for failing to exhibit vigour on his mount in the straight. 30 ³ / ₂₁ 63 ³ Jockey has been fined for using his whip in excess of the prescribed limit on his mount.
FOREVER YOURS	D19-20 - 31¹⁰/₁₉66³ Jockey has been reprimanded for not sufficiently persevering with his mount during the race. 8 ¹ / ₁₉ 83 ² Jockey reported loss of whip passing 200 meters. 10 ¹² / ₁₉ 114 ¹⁰ met interference between 900 metres and 800 metres. 18 ² / ₂₀ 184 ⁰ was extremely fractious inside its Stall, as such, was withdrawn before coming under Starters order.
UDAAN	D20-21 - 9²/₂₁30⁷ jumped out awkwardly and was slow. 30 ³ / ₂₁ 63 ⁶ An enquiry has been initiated in to the running and riding.
SUPERSTAR SUPREME	D20-21 - 3²/₂₁16¹² jumped out awkwardly at the start. 23 ² / ₂₁ 40 ⁰ was withdrawn before coming under Starters order as the gelding was extremely fractious inside its Stall.
AMAZING JET	D20-21 - 23³/₂₁160⁷ met interference and was steadied Approaching 1000 metres.
ASHWA CALVARI	Hy19-20 - 30¹²/₁₉104¹⁰ returned bleeding from both the nostrils.
FARGO	D19-20 - 7¹/₂₀146¹⁰ was tightened and was steadied approaching 900 metres. and suddenly lost its position near 700 metres. 18 ² / ₂₀ 182 ⁰ was found to be lame by her right-fore leg and was certified unfit to race and the filly was withdrawn on veterinary grounds. D20-21 - 18³/₂₁(54) Jockey reported loss of whip near 300 metres.
MISS GLORIOUS	D19-20 - 6²/₂₀173² lugged out in the straight. 11 ² / ₂₀ 179 ¹⁰ saddle slipped during the race.
BALA	D20-21 - 5²/₂₁20⁰ withdrawn before coming under starters order on veterinary ground as found to be lame by their left-fore legs.
6th Race The Adler Star Plate Div - I	CI-V, 1-26 1200 Mts.
ASHWA KAHIRA	D19-20 - 25²/₂₀192¹⁰ jumped out awkwardly at the start. D20-21 - 3²/₂₁13⁰ was withdrawn on veterinary grounds before coming under the Starters orders, as the filly was extremely fractious while being loaded and fell, hitting the ground. The Veterinary Officer reported that the filly was in a state of shock after having hit her head on ground as she fell. 23 ² / ₂₁ 37 ⁰ was found to be suffering from Colic, as such, was withdrawn on Veterinary grounds. 23 ³ / ₂₁ (58) met interference at the start and again near 200 metres.
SPARTAN X	D20-21 - 23²/₂₁37³ met interference approaching 900 meters. 4 ³ / ₂₁ 45 ² jumped awkwardly outward at the start. 23 ³ / ₂₁ 58 ⁴ met interference between 1100 metres and 1000 metres.
BOLI	D20-21 - 3²/₂₁13⁴ met interference Near 400 meters. 16 ² / ₂₁ 33 ⁶ was tightened for room and slowed down and shifted in & received severe interference Approaching 800 meters. 23 ² / ₂₁ 38 ⁶ Jockey was not ridden his amount to complete advantage during the race.
MISS BLUE FAIRY	D20-21 - 5²/₂₁(24) jumped out awkwardly, losing ground. 9 ² / ₂₁ 27 ³ met interference at the start. 23 ² / ₂₁ 40 ⁵ jumped out awkwardly at the start & App reported that he lost his left stirrup due to the interference at the start and met interference negotiating the bend. 23 ³ / ₂₁ 58 ³ met interference at the start.
BELLA MIA	D19-20 - 3³/₂₀197⁵ was slowly away and Jockey has been for using his whip in excess of the prescribed limit on his mount. D20-21 - 19¹/₂₁2³ was slowly away & lost about 2 lengths. 4 ³ / ₂₁ 45 ⁴ met interference at the start. 23 ³ / ₂₁ 58 ⁹ met interference at the start.
NOOR	D19-20 - 18¹⁰/₁₉54² Jockey has been fined for using his whip in excess of the prescribed limit on his mount. 8 ¹ / ₁₉ 78 ⁰ had sustained an injury on its head while being saddled, as such, the mare was certified unfit to race. 25 ² / ₂₀ 193 ¹² was tightened for room and steadied at the start. D20-21 - 18³/₂₁49⁰ was withdrawn before coming under the Starters orders as the mare was extremely fractious inside her stall. 23 ³ / ₂₁ 58 ⁷ met interference and was steadied Travelling some distance and Jockey has been reprimanded for easing up his mount prematurely in the final 100 metres.
LUCKY LIPS	D20-21 - 19¹/₂₁6⁰ was withdrawn before coming under Starters Orders due to the Jockey being injured in the Gates as the filly was extremely fractious in her Stalls. 3 ² / ₂₁ 13 ³ met interference Near 400 meters. 18 ³ / ₂₁ 49 ⁷ met interference soon after the start.
SUN LIGHT	D19-20 - 26¹/₁₉105⁷ Jockey has been fined for failing to sufficiently persevere with his mount in the straight.

GOLDEN TICKET D19-20 - 17¹²/₁₉127¹³ jumped awkwardly inwards. 30¹²/₁₉138⁸ suddenly drifted outwards approaching 600 metres. 18²/₂₀182¹⁰ shifted outwards near 1100 meters and leaned out near 800 meters. and having kept an erratic course during the race. D20-21 - 19¹/₂₁4³ An enquiry has been initiated into running & riding. 5²/₂₁24⁴ suddenly ducked out whereby the Jockey lost his left stirrup which he regained shortly, Approaching 100 meters. 18³/₂₁49⁶ met interference soon after the start.

GOLDEN GUINEA D20-21 - 22¹/₂₁7⁶ took a fly jump, began awkwardly and was slow in the strides & Jockey reported that his mount drifted out in the straight despite of his best efforts. 5²/₂₁24⁶ lugged-out near 200 metres and again near 100 meters marker. 23²/₂₁38³ met interference Approaching 900 meters. 18³/₂₁49³ met interference and was steadied Passing 900 metres.

7th Race The Adler Star Plate Div - II

CI-V, 1-26

1200 Mts.

PRINCESS ELENA D19-20 - 11²/₂₀179⁶ jumped out awkwardly and lost about 2 lengths. 25²/₂₀194⁶ slowly away and Jockey was observed to be feeble in his riding effort, as such, the Jockey has been cautioned. 3³/₂₀197³ was slowly away and lost about three lengths. D20-21 - 5²/₂₁24³ met interference near 100 meters marker. 16²/₂₁35² jumped out awkwardly inwards at the start & met interference in the final stages of the race. 18³/₂₁54⁰ was found to be lame by its Right-Fore leg, as such, was withdrawn on Veterinary grounds.

DARING D19-20 - 24¹⁰/₁₉59⁵ Jockey has been fined for using his whip in excess of the prescribed limit on his mount.

SHAILIKA D19-20 - 25²/₂₀189⁶ met interference passing 900 metres and App reported that his mount lugged-out during the race.

NIGHT HAWK D18-19 - 5⁴/₁₉252⁴ was tightened and lost position soon after the start. D19-20 - 13⁹/₁₉17¹⁰ walked out of the Gate and thereafter, did not raise a fluent gallop. D20-21 - 23³/₂₁58² jumped out awkwardly outwards at the start & was inclined to lug out near 200 metres.

ORGANIC GREY D20-21 - 3²/₂₁17⁸ jumped out awkwardly and was slow into its strides. 9²/₂₁27⁵ met interference at the start. 16²/₂₁35⁵ was slowly away and met interference at the start. 4³/₂₁45⁵ met interference at the start & Jockey has been fined unnecessarily restrained his mount and dropped to last position and was content to be in that position till well into the straight and travelled wide in the middle stages of the race and rode out in the straight when it was too late.

CIRCLE OF GOLD D18-19 - 26²/₁₉168⁸ met interference approaching 800 metres.

BOLD CHETAK D20-21 - 16²/₂₁36⁶ lost ground and met interference at the start.

EMBATTLED D19-20 - 6²/₂₀170² Jockey lugged out in the straight. D20-21 - 19¹/₂₁4⁶ met interference and lost ground.

MASTER FRANKEL D19-20 - 14¹/₂₀152⁶ was inconvenienced at the start. D20-21 - 9²/₂₁28⁵ was tightened for room and steadied, soon after the start & Jockey informed that his mount was inclined to run outwards throughout the race and he found it difficult to ride his mount. 23³/₂₁58¹³ met interference at the start.
