MASTER CAUSEWAY	D19-20 - 30 ¹² / ₁₉ 134 ³ was slowly away and met interference at the start. 7 ¹ / ₂₀ 144 ¹¹ Jockey has been asked to continue making an effort till past the Post.		
REAL IS RARE	D19-20 - 30 ¹² / ₁₉ 134 ⁵ met interference at the start.		
BLAINE	D19-20 - 17 ¹² / ₁₉ 121 ⁷ met interference soon after the start.		
KEEP THE CHANGE	D19-20 - 17 ¹² / ₁₉ 121 ⁵ jumped awkwardly inwards and Jockey was observed to have prematurely eased up his mount as such he has been advised to continue riding his mount till past the Post.

SPARTAN X	D19-20 - 7 ¹⁰ / ₁₉ 42 ⁷ jumped out awkwardly and began slowly, losing about two lengths & Jockey has been cautioned for failing to sufficiently persevere with his mount in the straight. 18 ¹⁰ / ₁₉ 54 ⁹ reared up as the start was affected and lost many lengths. 19 ¹¹ / ₁₉ 91 ⁶ met interference soon after the start. 17 ¹² / ₁₉ 122 ⁸ stumbled and slowly away at the start. 7 ¹ / ₂₀ 145 ⁵ Jockey has been cautioned for not riding out his mount to complete advantage in the straight.		
ASHWA QUEEN	D18-19 - 20 ⁴ / ₁₉ 280 ⁰ was found be lame by its right-hind leg, as such, was withdrawn on veterinary grounds. D19-20 - 31 ¹⁰ / ₁₉ 66 ⁰ was found lame left fore. As such, the mare was certified unfit to race and was withdrawn on veterinary grounds. 24 ¹ / ₂₀ 158 ⁶ Jockey was severely reprimanded for his feeble riding.

FLAMING PASSION	D19-20 - 29 ¹⁰ / ₁₉ 64 ⁰ was suffering from fever. As such, the mare was certified unfit to race and was withdrawn on veterinary grounds. 21 ¹¹ / ₁₉ 98 ⁶ jumped out awkwardly at the start and was checked soon after the start. 30 ¹² / ₁₉ 139 ¹⁰ jumped out awkwardly at the start. and met interference passing 900 metres. 14 ¹ / ₂₀ 148 ⁸ jumped out awkwardly, threw her head thereby unbalancing her Rider and lost ground and Jockey has been asked to continue riding his mount till past the post. 31 ¹ / ₂₀ 165 ⁹ was steadied while on the inside of KING AND COUNTRY passing 1200 metres.		
SAUGAT	D18-19 - 26 ² / ₁₉ 168 ⁵ met interference approaching 800 metres.		
SURIAYA	D18-19 - 12 ² / ₁₉ 155 ⁸ was tightened for room and steadied, Soon after the start.

BLAVATSKY	D19-20 - 31 ¹ / ₂₀ 165 ⁸ jumped out awkwardly at the start.		
MAN MALHARI	D19-20 - 7 ¹ / ₂₀ 141 ⁵ met interference approaching 100 metres.		
ORGANIC GAMBLER	D18-19 - 21 ⁴ / ₁₉ 285 ⁸ was observed to have broken a blood vessel.		
TESORO	D19-20 - 7 ¹⁰ / ₁₉ 39 ⁹ was slowly away. 21 ¹¹ / ₁₉ 96 ⁶ met interference at the start.		
MAGIC QUEEN	D19-20 - 17 ¹⁰ / ₁₉ 43 ⁸ Jockey did not have any control over his mount, as he had lost his right stirrup, the mare shifted in passing 300 metres & Jockey was observed to have lost right stirrup at the start itself which Jockey suspended for giving misleading evidence during the enquiry 19 ¹¹ / ₁₉ 94 ⁸ planted and lost many lengths. 24 ¹² / ₁₉ 132 ⁸ sustained a cut injury on left-fore leg.		
LOVEABLE	D19-20 - 24 ¹² / ₁₉ 132 ⁶ was tightened while racing on the inside of DAZZLING GLORY and lost position, Passing 1000 meters.		
GOLDEN TRESPASS	D18-19 - 6 ¹¹ / ₁₈ 61 ¹¹ met interference passing 800 metres. 4 ¹² / ₁₈ 90 ⁴ met interference passing 1200 metres and again approaching 100 metres.		
JET	D19-20 - 7 ¹¹ / ₁₉ 77 ⁵ met interference after travelling some distance from the start and lost position. 17 ¹² / ₁₉ 122 ¹² Jockey was observed to have travelled wide while negotiating the bend and when questioned stated that his mount was inclined to lug out during the race. 14 ¹ / ₂₀ 151 ⁵ Jockeys fined for using his whips in excess of the prescribed limit on his mount.		
ARFFA	D16-17 - 22 ⁴ / ₁₇ 288 ³ Jockey was reprimanded for checking his mount approaching the 700 metres for no apparent reason.		
AMAZING FASTER	D19-20 - 17 ¹⁰ / ₁₉ 43 ⁴ was slowly away. 24 ¹⁰ / ₁₉ 60 ⁶ Jockey has been cautioned for failing to continue riding his mount till past the Post. 14 ¹ / ₂₀ 152 ⁹ was slowly away as the mare leaned to one side and lost about three lengths. and leaned-in in the straight.

EXCELLENT GIRL	D19-20 - 7 ¹¹ / ₁₉ 75 ¹¹ met interference approaching 1200 metres. 17 ¹² / ₁₉ 127 ¹¹ jumped out awkwardly at the start.		
GOLDEN GUINEA	D19-20 - 17 ⁹ / ₁₉ 20 ⁴ jumped awkwardly outwards & met interference at the start. 7 ¹⁰ / ₁₉ 37 ⁰ planted and took no part in the race. 7 ¹ / ₂₀ 145 ⁸ met interference approaching 600 metres.		
EMBATTLED	D18-19 - 20 ⁴ / ₁₉ 277 ⁶ jumped awkwardly inwards at the start. D19-20 - 7 ¹⁰ / ₁₉ 39 ⁷ was tightened at the start & approaching 400 metres, drifted out under the use of the whip and then continued to travel wide till about 200 metres & Jockey has been cautioned. 29 ¹⁰ / ₁₉ 61 ⁵ Jockey were reprimanded for not sufficiently persevering with his mount during the race.		

ASHWA JAWALA D19-20 - 25⁹/₁₉27² was checked near 1100 metres. 31¹⁰/₁₉71⁶ met interference at the start and again approaching 1200mts. 31¹/₂₀165² began awkwardly at the start.

MASTER FRANKEL D18-19 - 28³/₁₉229³ met interference near 1200 metres. D19-20 - 18¹⁰/₁₉53⁷ struggled to be with the field and then trailed till the end of the race. The gelding did not respond to the Jockeys urgings whereby the Jockey gave up riding his mount near 200 metres. 31¹⁰/₁₉71⁹ Jockey reported that the gelding had jumped out awkwardly and his leg brushed the Gates and he was unable to ride out completely due to the pain. 14¹/₂₀152⁶ was inconvenienced at the start.

BLACK ROSE D19-20 - 31¹⁰/₁₉71⁵ met interference approaching 1300mts. 17¹²/₁₉123³ met interference & leaned outwards at the start. 30¹²/₁₉135³ met interference soon after the start. 31¹/₂₀166⁷ Jockey has been fined for using his whip in excess of the prescribed limit on his mount.

NEBULOUS D19-20 - 7¹¹/₁₉75⁷ met interference approaching 1200 metres. 14¹¹/₁₉89² took a fly jump. 17¹²/₁₉123¹² jumped out awkwardly at the start. 31¹/₂₀166⁵ slowly away.

ROARING RASCAL D19-20 - 21¹¹/₁₉100⁶ Jockey reported loss of his whip near 400 meters. 17¹²/₁₉123⁶ met interference at the start and Jockey has been fined for using his whip in excess of the prescribed limit on his mount.

5th Race The Central Force Plate **CI-III, 40-66** **1400 Mts.**

MIDLEXESS D18-19 - 30⁴/₁₉304¹⁰ Jockey reported loss of his whip soon after the start. D19-20 - 8¹¹/₁₉82⁰ was found to be lame by her right-fore leg. As such, the mare was certified unfit to race and was withdrawn on veterinary grounds. 17¹²/₁₉125⁴ lugged-in in the final 200 metres. 14¹/₂₀150² jumped awkwardly outwards at the start.

MISS ZACHARY D19-20 - 24¹²/₁₉(129) Jockey has been fined for using his whip in excess of the prescribed limit.

MISS CINDRELLA D19-20 - 10¹²/₁₉116⁸ jumped awkwardly inwards, throwing her head, losing ground. 17¹²/₁₉125⁷ met interference in the final 200 metres. 7¹/₂₀143¹² jumped awkwardly inwards and was steadied off the heels of MISS BULLET at the start. 14¹/₂₀150⁷ was found to be lame by her left-fore leg. 31¹/₂₀163⁶ was slowly away.

WARRIOR THRIVE D18-19 - 27⁴/₁₉293² lost its shoe on the Left hind leg. D19-20 - 19¹¹/₁₉91² Jockey suspend for unsatisfactory riding. 17¹²/₁₉125² was observed to have broken a blood vessel.

GLOBAL TARGET D19-20 - 19¹¹/₁₉95⁸ began awkwardly at the start. 10¹²/₁₉118⁶ jumped out awkwardly at the start. 14¹/₂₀150⁵ Jockey has been fined for using his whip in excess of the prescribed limit on his mount.

SPECIAL FIGHTER D19-20 - 14¹/₂₀(147) met interference approaching 400 meters.

DARJEELING D19-20 - 26¹¹/₁₉102³ met interference near 900 metres. and lugged-out in the straight and had sharp molars.

PROMISE OF LOVE D18-19 - 18³/₁₉208⁴ met interference soon after the start. D19-20 - 3⁹/₁₉10⁸ bumped at the start & Jockey cautioned for travelling wide while negotiating the bend and in the straight. 17¹²/₁₉126³ Jockey suspend for unsatisfactory riding on his mount.

MR STUNNING D19-20 - 17¹²/₁₉125⁹ was held up due to lack of room near 100 metres.

6th Race The Rapid Action Plate Div - I **CI-IV, 20-46** **1000 Mts.**

CUNCHO D19-20 - 19¹¹/₁₉95⁹ Jockey has been cautioned for travelling wide during the race. 26¹¹/₁₉103⁴ Jockey reported that his mount lugged-out during the race and his mount travelled wide in the middle stages of the race. 30¹²/₁₉138² travelled wide Between 600 metres and 400 metres. 7¹/₂₀143⁰ was found to have an injury on the right hind leg- withdrawn.

RAXION D19-20 - 24¹⁰/₁₉59⁷ was slowly away and lost about two lengths. 14¹/₂₀150¹⁰ met interference at the start and Jockey reported that he did not get a clear run on a couple of occasions in the straight.

MASTER NOVAK D19-20 - 24¹²/₁₉128⁰ was extremely fractious before being loaded and was withdrawn before coming under starters orders. 7¹/₂₀143⁹ met interference soon after the start and again Approaching 900 metres.

LOVELY GIRL D19-20 - 7¹/₂₀143¹⁰ met interference approaching 900 metres. 24¹/₂₀155¹³ Jockey unnecessarily restrained his mount thereby resulting in it getting its head up and losing ground shortly after the start. He was fined.

AMAZING MELODY D18-19 - 31¹²/₁₈117³ was found to be lame by its right-Hind leg. 5⁴/₁₉248⁴ sustained an injury on its right hind hock. 30⁴/₁₉305² sustained injury on its right hind leg. D19-20 - 18¹⁰/₁₉52⁶ Jockey was severely reprimanded for not sufficiently persevering with his mount in the straight. 21¹¹/₁₉97⁵ observed to have broken a blood vessels.

FAR AWAY D18-19 - 2⁴/₁₉242⁰ was extremely fractious before being loaded and was withdrawn before coming in under starters order. 15⁴/₁₉268⁵ met interference approaching 800 metres. 27⁴/₁₉294⁰ found to be lame on left-fore leg. As such, the mare was certified unfit to race and was withdrawn on veterinary grounds. D19-20 - 27⁸/₁₉1³ Jockey cautioned for failing to exhibit vigorousness on his mount during the race. 24¹/₂₀155⁰ was extremely fractious before being loaded as such was withdrawn before coming under starters orders.

MISS COLOMBIANA D19-20 - 14¹/₂₀147⁸ Jockeys asked to continue riding his mount till past the post.

CONQUERING BID D19-20 - 10¹²/₁₉120³ Jockey reported that his mount lugged-in in the straight. 24¹²/₁₉(132) App reported that his mount was inclined to lean in throughout the race and at the start 31¹/₂₀160⁵ jumped out awkwardly at the start and Jockey reported that his mount jumped out awkwardly due to which he lost his right stirrup, which he regained shortly. and Jockey has been reprimanded for his feeble riding in the straight. He has been informed that a similar riding effort will attract disciplinary action against him.

EXTREME DESIRE D19-20 - 17⁹/₁₉22⁶ jumped out awkwardly and was slowly away & was inclined to lug-in in near 300 metres for a brief period. 1¹⁰/₁₉32⁶ met interference at the start. 31¹⁰/₁₉66⁷ was observed to have broken a blood vessel.

MISS DUNCAN D19-20 - 21¹¹/₁₉97⁰ bumped and due to which App lost his stirrups which he could not regain near 400metres. 30¹²/₁₉138¹² met interference approaching 600 metres.

SOLARIUM D19-20 - 10¹²/₁₉120² Jockey has been fined for using his whip in excess of the prescribed limit of his mount. 24¹²/₁₉133² Jockey suspend for excess used of whip. 24¹/₂₀(158) Jockey reported loss of whip near 150 meters.

WHIZZ D18-19 - 15¹¹/₁₈73⁹ observed to have broken a blood vessel. 27¹²/₁₈110⁶ was observed to have broken a blood vessel.

7th Race The Rapid Action Plate Div - II **CI-IV, 20-46** **1000 Mts.**

AMAZING JET D19-20 - 10¹²/₁₉115⁵ Jockey reported loss of his whip approaching 300 meters.

MISS ARTS D18-19 - 30⁴/₁₉303⁴ jumped out awkwardly at the start. D19-20 - 21¹¹/₁₉96³ jumped awkwardly outwards and met interference at the start.

SKY MINE D18-19 - 21¹/₁₉145⁰ was found to be lame by its left-hind leg, as such, was withdrawn before coming under Starters order.

ALIZAA D18-19 - 27⁴/₁₉293⁷ was slowly away. D19-20 - 3⁹/₁₉10² bumped at the start & met interference passing 1000 metres. 17⁹/₁₉(22) met interference near 1100 metres.

NICHE ORGANIC D19-20 - 17¹²/₁₉(123) met interference at the start.

MIZILLA GOLD D19-20 - 21¹¹/₁₉97⁴ met interference passing 1000 metres and shifted in soon after the start. and observed to have broken a blood vessels.

PERSONAL LEGEND D19-20 - 7¹⁰/₁₉42³ Jockey was observed to have ridden his mount feebly in the straight. 31¹⁰/₁₉66⁰ was found to be lame by the left-fore leg. As such, the mare was certified unfit to race and was withdrawn on veterinary grounds. 10¹²/₁₉115⁷ Jockey, has been fined for failing to follow the instructions and warned for the future. 7¹/₂₀141² Jockey was observed to have dropped his hands before passing the Post. 24¹/₂₀156⁹ Jockey reported that his mount was fractious inside the stall as the start was effected.

PRINCESS BEAUTY D19-20 - 8¹¹/₁₉83⁶ jumped out awkwardly at the start. 17¹²/₁₉127⁵ jumped out awkwardly at the start. 7¹/₂₀141¹⁰ was slowly away. 14¹/₂₀148¹⁰ planted and took no practical part in the race.

MISS GLORIOUS D19-20 - 8¹¹/₁₉79³ Jockey reported that his mount was inclined to lug-in during the race and he found it difficult to pull his mount out.

SUN LIGHT D19-20 - 24¹⁰/₁₉55⁵ Jockey has been fined for not sufficiently persevering with his mount throughout the race and has been reprimanded for the future. 26¹/₁₉105⁷ Jockey has been fined for failing to sufficiently persevere with his mount in the straight.

SEPAL D18-19 - 26²/₁₉168⁴ Jockey has been cautioned for losing his position while negotiating the bend. 20⁴/₁₉277³ was observed to have broken a blood vessel. D19-20 - 3⁹/₁₉(7) lugged in during the race and as the Jockey tried to gain control of his mount, the bridle shifted slightly. 17⁹/₁₉24⁶ was tightened due to a tightly pack field soon after the start. 24¹²/₁₉130⁷ was received checked Near 1100 metres.

HAKUNA MATATA D18-19 - 26³/₁₉223³ met interference approaching 200 metres. D19-20 - 7¹¹/₁₉77⁰ was found to have broken a blood vessel was certified unfit to race. 14¹/₂₀(152) An enquiry has been initiated in to the improved performance.

CRESSIDA D19-20 - 7¹⁰/₁₉39⁶ was tightened at the start.
