

**RACING INCIDENTS
IN BRIEF OF IMMEDIATE PAST 6 RUNS**

1st Race The Bright Law Handicap

CI-V, 1-26

1100 Mts.

BEOWULF CI20-21 - 16³/₂₁102⁹ was difficult to load, played up just as the start was being effected unbalancing itself and losing some ground.

MARAZZO CI20-21 - 6²/₂₁93² drifted outwards when placed under pressure during the final stages of the race.

ZODIAC PRINCE CI19-20 - 12¹/₂₀84³ returned with cut injury on left hind. CI20-21 - 30¹/₂₁80⁵ stumbled at the jump out.

ASHWAMEGH CI20-21 - 22¹/₂₁78⁶ missed the jump. 16³/₂₁102³ met interference soon after the start. 3⁴/₂₁126³ was slow to begin.

BEMUSE CI20-21 - 11²/₂₀14⁰ found to be lame on right hind. Under the circumstances the colt was permitted to be withdrawn on veterinary grounds.

ICONIA CI20-21 - 13¹/₂₁60¹² returned with cut injury on right stifle.

2nd Race The Sound Of Cheers Handicap CI-IV, 21-46, which have run at kolkata having completed the course since 24th november, 2020 and have not won a race at any centre since that date. To be ridden by jockeys of indian nationality. **1200 Mts.**

COMMUNIQUE CI20-21 - 3²/₂₁89³ Jockey reported that he had to ease back his mount at about 1100 metres in a closely packed field and the gelding finished on in the straight.

BUNTING M19-20 - 16²/₂₀148⁵ met interference soon after the start. CI20-21 - 17¹/₂₁71¹⁰ was very difficult while being stalled, jumped outwards at the start. 16³/₂₁102⁷ Jockey was fined for making no effort to correct his mount from drifting out soon after the start.

ISLE OF SKYE M19-20 - 21²/₂₀71³ had a cut injury at the right hind pastern and an abrasion at both hind fetlock. 2²/₂₀124⁴ received checked and drop back passing the 400 metres. and Jockey reported the loss of whip near 200 metres.

NOVA CI20-21 - 24¹/₂₀3⁴ met interference at the start. 22¹/₂₁74² returned bleeding from both nostrils.

POSSE M20-21 - 11¹/₂₀26⁴ had right eye injury.

POPCORN CI20-21 - 26¹/₂₀42⁶ returned lame on right fore.

SHIVAYY CI20-21 - 22¹/₂₁74¹⁴ jumped awkwardly from the gates. 26³/₂₁112⁶ Jockey reported that his mount was not responding to his urgings throughout the race.

SCRIPT CI20-21 - 13¹/₂₁60⁵ missed the jump & fly jumped out from the gates passing the 700 metres.

BRILLIANT GOLD M19-20 - 12²/₂₀119¹³ met interference passing the 1000 metres. CI20-21 - 26¹/₂₀38⁸ returned bleeding from its nostrils. 30¹/₂₁83³ returned bleeding from both nostrils.

THE INDICATOR CI20-21 - 11²/₂₁46³ was slow to begin & took a slow jump losing approximately 3-4 lengths at the start, the enquiry opened and Jockey fine for failing to make adequate attempt to place his mount. 30¹/₂₁79² was slow to begin.

BASHARAT CI20-21 - 31³/₂₁118⁶ was fractious in its stall, was slow to begin.

3rd Race The Eagle Pines Handicap Div - I CI-III, 41-66, To be ridden by jockeys of indian nationality. **1200 Mts.**

SITARA Hy19-20 - 25¹/₁₉38⁶ met interference at the start & An enquiry has been opened into the running and riding. 17²/₂₀181³ returned bleeding. Hy20-21 - 6¹/₂₀26⁵ App was cautioned to make more determined efforts to follow the given instructions for going to front.

HARBOUR SUNRISE Bg20-21 - 25¹/₂₀71⁵ met interference approaching 400 Metres.

ARCELIA CI20-21 - 16³/₂₁104¹⁰ Jockey reported that his mount threw its head up repeatedly, veering out soon after the jump out & met interference inconvenienced some distance after the start.

CORONA DEL CORSA Bg19-20 - 6³/₂₀181⁵ jumped awkwardly inwards at the start. CI20-21 - 19³/₂₁108⁰ played up on its way to the start and dislodged its rider, bolting riderless. The gelding was captured and permitted to be withdrawn before coming under Starters orders. 26³/₂₁114⁸ was extremely fractious while being stalled, was slow to begin losing approximately three lengths at the start. 3⁴/₂₁127⁶ was slow to begin.

SUMMER AIR M19-20 - 22¹/₁₉46⁵ met interference from the 400 metres. CI20-21 - 51²/₂₀(21) met interference soon after the start & Jockey was reprimanded in the presence of Trainer for riding an over confidence race. 19³/₂₁107⁰ found to be lame on right fore- withdrawn.

YAHALLA CI20-21 - 51²/₂₀17⁹ slow to begin & returned bleeding from both nostrils.

WHISPERING GRASS CI19-20 - 4³/₂₀148⁴ stumbled at the start.

AGGRESSION CI20-21 - 17¹/₂₁71⁴ met interference at the start & was inconvenienced at the start when the horses on his outside moved in. 6²/₂₁95⁵ met interference was inconvenienced soon after jump out & The Stipendiary Steward decided to continue with the enquiry. 16³/₂₁104⁸ Jockey was fined for the indifferent handling of his mount in the initial and middle stages of the race.

4th Race The Eagle Pines Handicap Div - II CI-III, 41-66, To be ridden by jockeys of indian nationality. **1200 Mts.**

ESTRELLA STAR CI20-21 - 19³/₂₁107⁵ Jockey reported that his mount was inclined to hang out throughout the race, colt returned lame on left fore.

TREASURE HUNT CI20-21 - 26¹/₂₀38⁰ dropped the rider at about 1150 mts and ran riderless & met interference some distance after the start.

ASTRAL FORCE Bg20-21 - 25¹/₂₀68⁷ accidentally brushed the running rails passing the 1200 Metres.

ATOM CI20-21 - 1¹/₂₁50³ was slow to begin.

RESOLUTE M20-21 - 29¹/₂₀10⁴ was observed to have lost its left fore shoe.

GOLD BOND CI20-21 - 18¹/₂₀32⁶ met interference soon after jump out. 19³/₂₁107⁰ found to be lame on left fore -withdrawn.

COUP DE GRACE CI20-21 - 3⁴/₂₁129² threw its head around soon after the start losing some ground in the process.

BLAZING BELLE	CI20-21 - 30¹/₂181³ Jockey reported that his mount, having its maiden outing, shifted inwards when placed under pressure approaching the 600 metres.	
6th Race The Sunray Handicap	CI-II, 61-86	1400 Mts.
INCA	CI20-21 - 12¹/₂2027² Jockey was fined for the excessive use of the whip. 26 ¹ / ₂ 20(39) met interference from the 400 metres. 6 ² / ₂ 197 ² Jockey reported that his mount was inclined to lean outwards during the final stages of the race. 31 ³ / ₂ 122 ² was slow to begin.	
MALWA	M19-20 - 1²/₂0117⁶ was sore by the right fore leg. Bg20-21 - 9¹/₂185⁹ Jockey reported that his mount did not relish the underfoot conditions of the track & Jockey reported that he accidentally lost his whip passing the 300 Metres. 13 ² / ₂ 125 ⁹ Jockey reported that his mount stumbled twice passing the 400 Metres. 13 ³ / ₂ 1(160) An enquiry is being held into the relatively improved performance.	
KILKARRY BRIDGE	CI20-21 - 5¹/₂2018³ was denied a clear run approaching the distance post. 22 ¹ / ₂ 172 ⁵ Jockey reported that his mount which was well up with the leaders dropped back out of contention from about the 300 metres.	
BIG STAR	CI20-21 - 5¹/₂2021⁵ met interference soon after the start. 5 ¹ / ₂ 152 ³ threw its head up as the start was effected. 30 ¹ / ₂ 1(84) jumped outwards	
BARACK	M20-21 - 6¹/₂2019⁵ met interference soon after the start. 27 ¹ / ₂ 2057 ² was observed to have stumbled due to a tightly packed field and was steadied passing 800 metres. CI20-21 - 19³/₂1108² Jockey reported that his mount was inclined to hang out during the final stages of the race.	
OAK BROOK	CI20-21 - 30¹/₂184³ Apprentice was severely reprimanded for failing to place his mount judiciously during the running of the race, swinging wide round the final bend and finishing the course on the outer rails.	
FOOL PROOF	CI20-21 - 22¹/₂172² was slow to begin. 16 ³ / ₂ 1103 ³ was slow to begin.	
KIMAYA	CI20-21 - 31³/₂1125³ Jockey was reprimanded for changing course passing the 800 metres.	
TOPNOTCH	M19-20 - 2²/₂0125¹⁴ met interference and tightened for room and had to be checked soon after the start and again approaching the 600mts.

NEW ENGLAND	CI20-21 - 22¹/₂175⁸ slow to begin. 3 ² / ₂ 191 ⁶ was slow to begin. 19 ³ / ₂ 1110 ⁹ slow to begin. 31 ³ / ₂ 1124 ⁴ was slow to begin.	
INTO THE SPOTLIGHT	Bg19-20 - 29¹/₁1929⁴ met interference at the start.	
RAINBOW TROUT	M19-20 - 1²/₂0117² met interference passing the 150 metres and The saddle used was observed to have slipped during the race and App was observed to have used the whip in excess of the prescribed limit on his mount. M20-21 - 27¹/₂03⁶ App reported that his mount hung-in from the bend despite his efforts.	
SAGITTARIUS	M19-20 - 16²/₂0146² met interference at the start. CI20-21 - 19³/₂1110⁸ slow to begin. 31 ³ / ₂ 1124 ⁵ was slow to begin.	
TUDOR HALL	M20-21 - 6¹/₂2019² lost about 3 lengths at the start.	
8th Race The High Born Handicap	CI-IV, 21-46, To be ridden by jockeys of indian nationality.	1100 Mts.
EASTSIDE	CI20-21 - 16³/₂1102⁶ bumped soon after the start.	
LAKMOS	CI20-21 - 13¹/₂160⁰ found to be lame on left hind. Under the circumstances the colt was permitted to be withdrawn on veterinary grounds.	
GUSTY LOOK	Hy20-21 - 18¹/₂183⁸ met interference soon after the start. 7 ² / ₂ 1113 ¹⁴ Jockey reported that his left stirrup iron came out soon after the start and to balance himself he removed right iron stirrup as such he could not offer any assistance to his mount throughout the race 22 ² / ₂ 1142 ⁸ Jockey reported that he had no room in the inside as such he was forced to shift out in the straight to make his move was noted. 15 ³ / ₂ 1169 ⁷ jumped out slowly losing about 2 or 3 lengths & Jockey was cautioned for tender handling of his charge in the straight.	
UNSTOPPABLE	Hy20-21 - 27¹/₂198⁵ was denied a clear run at about the 300 mtrs due to wall of horses racing in front. 22 ² / ₂ 1143 ³ met interference soon after the start.	
NANDINI'S PET	CI20-21 - 26¹/₂2036³ stumbled soon after the start losing her balance for a few strides.	
AROUND THE WORLD	CI19-20 - 26¹/₂1960⁹ returned with cut injury on right fore. CI20-21 - 3²/₂189⁶ Jockey reported that his mount did not have much to offer during the final stages of the race when placed under pressure. 19 ³ / ₂ 1111 ⁵ Jockey was fined for the indifferent handling of his mount.	
BERLUTI	CI20-21 - 22¹/₂178³ was difficult to load, drifted outwards when placed under pressure during the final stages of the race.	
STAGGER	CI20-21 - 3²/₂186⁷ App was observed to have eased up his mount out of the field passing the 1000 metres and not make sufficient effort to improve position till passing the 300 metres & returned lame on left fore. 3 ⁴ / ₂ 1(126) Jockey was reprimanded for failing to exercise proper control over his mount in the concluding stages of the race.
